Y-Piles Arrive By Evan Kramer



The Port of Port Orford Commission met Monday night and first off considered a request from Liz Stone to place her catering truck at the dock

four or five days a week during the lunch period. Some of the commissioners were concerned about the truck because of the congestion at the dock and also what they should charge Stone for letting her bring the catering truck on port property. The commission decided to let her park the truck on port property for a one-month trial basis with her paying a prorated part of the annual business license fee.

Jack Pruitt asked if the old timbers being removed from the dock would be available to the public. They are being taken to Knapp Ranch for disposal. Pruitt was told to go to the Laskey-Clifton office about getting some of the old timber.

Port Manager Gayle Paige reviewed the status of the permanent dock project. She said Laskey-Clifton started driving the first sheet piles in the ocean last Friday. The Y sheet piles (the most important ones) started arriving last week. Paige said 50% of the fill material has already

been brought to the dock. She said Laskey-Clifton started working 12-hour days today. Paige said the existing dock and hoist would be in use a couple more weeks and then a temporary hoist will be erected and in use. Port employees will be trained using the crane as a boat hoist.

Port commissioners agreed to set up a meeting with Doris McKillip with the Army Corps of Engineers on Friday, November 5, at 5:00pm, at the Port office. The Corps will update the Port on studies they have been conducting.

Port commissioner Dave Knapp made a motion to form a committee consisting of Port Commissioners Leesa Cobb and Chris Hawthorne to study the standard lease form. The motion carried unanimously.

The Port received a letter from Carvalho Fisheries requesting an additional 45' by 45' more space on the dock. The Port will renegotiate their lease.

The Commission next looked at the boat parking policy on the dock. Gayle Paige said there was a boat owner who may be refusing to move his boat. Commissioner Scott Macdonald suggested getting together with the fishermen's association and asking them what they want to do about the boat parking situation. Macdonald will organize the meeting,

which will try to come up with a parking system. Macdonald asked about the crab pots for the upcoming crab season and Paige told him the fishermen probably wouldn't be able to stage their pots on the dirt surface of the new dock.

Gayle Paige said Richard AuFranc had offered to serve as the Port attorney but he didn't want to litigate or do court cases. Paige pointed out that AuFranc has a history of legal work with the Port and a knowledge of ports in general. She said most of the Port legal work has been contracts and leases, not litigation. She also noted his fairness in what he has charged the Port and that he doesn't charge them for shooting the bull like some other lawyers. Chris Hawthorne said he wanted AuFranc as the Port attorney and the rest of the Commission agreed.

The Commission then discussed the Premium Pacific Seafood lease with owner Mark Barnes. He was told his company owes the Port \$4500 which includes a 1% charge on his fish catch for September. Gayle Paige told Barnes he was 60 days past due, not 30 as he had stated. Barnes spoke about problems he had in January and February of this year with bad weather and that some of his customers are behind in paying him. Port

Accident Closes Highway 101 by Evan Kramer

A multi vehicle accident on Tuesday morning blocked Highway 101 at Paradise Point Road. Three people were injured. Traffic headed south on Highway 101 was diverted onto Port Orford Loop Road at Silver Butte and traffic headed north was diverted onto Port Orford Loop Road at Madrona. The Curry County Sheriff's Department, Oregon State Police, Port Orford Police and Port Orford Ambulance responded to the scene. Several local citizens also responded and many helped clear the debris from the highway.

The accident began with a Roto-Rooter waste collection truck which was turning left onto Paradise Point Road at Highway 101. A blue Ford Ranger driven by Port Orford resident Cheryl Andres was rear-ended by an empty log truck as she tried to pass the Roto Rooter truck on the right.

The Andres vehicle then hit the right front edge of the Roto Rooter truck and then hit a Ford 250 XLT truck hauling a fifth wheel trailer. Both the Ford Ranger and Ford 250 were destroyed in the accident.

Andres and the two people in the Ford 250 were transported by Port Orford Ambulance to Curry General Hospital. A spokesperson at Curry General said no one was injured seriously though Andres and one other person would remain in the hospital overnight. Andres' dog Tasha was in her truck and ran away from the scene of the accident. She was found later on in the morning scared but not apparently injured.

There is no left turn lane at Paradise Point Road and Highway 101. I've been told that bad accidents with injuries like this can influence ODOT to add a much needed left turn lane.

Sail Boat Burns

The sail boat Ovidia, a forty-two foot long yawl burned in the early morning hours on Thursday, October 14. It had been anchored in Nellie's Cove near the Port of Port Orford. By the time the boat's owner called in the fire it was fully involved. The Port Orford Fire Department responded to the fire but could do nothing but watch as the Ovidia burned in Nellie's Cove. The department did not know the cause of the fire. The boat was completely destroyed and no sign of it could be seen on Sunday morning.



More Balancing Graeme Graydon



Producing a happier balance in life often requires something quite different from the usual. At the Health Resort in the Catskills, I did everything I could to evoke an unfamiliar experience for our guests. It was standard policy to discourage anyone from coming with a family member, - especially a spouse - it gave everyone a better chance. This opportunity was especially appreciated by a unique group - they were the wives of the rabbis. Their response to our very different balance was sometimes touching, often hilarious. They were able to explore areas normally closed to them and to let their hair down as they never could elsewhere.

At Easier, when I was fifteen, my father took me deer-stalking in a remote mountain valley called Totara Flats. I had been raised to regard Easter as the one church festival that I should never miss. I even felt a little guilty not being in church. We didn't shoot anything but we

had three days of adventure. On the way out there was a particularly dangerous moment when we forded a swollen river followed by the grind of a cold and wet five hour trek over the range to our car. My father had found it more important to take his son into the wilderness than to be in church. It was one of the most treasured times I had with him. I found a new space where I wasn't his son, we were men who took risks together and watched out for each other. Much later I saw that he had created a balance - making up for the times we hadn't spend together.

Balance can look pretty peculiar at times. There was a man who could no longer work because of an injury. His wife took over his role as head-of-family and provider. She took him to a new doctor, looking for a better treatment. The doctor, a colleague of mine was able to alter the conditions to a point that the husband could think about returning to work. Without warning the patient stopped coming for treatment. The doctor was told that the couple hadn't expected a cure and weren't ready to give up the comfortable balance that they enjoyed - (he the dependant and she the dominant), and that, accordingly, they

would not be seeking further treatment. They chose a balance which seemed to serve them well for that time. Oh well...

Then there was the brainy kid who came into the museum with his mother. He persisted with one question after another - asking me to name twenty or so rock specimens on display. Not my forte.. I was being pushed and didn't want to admit it. He was trying to get me to say "I don't know", so I stopped his interrogation: "Before I give you anymore information, I would like to know what you have learned." Pointing to the first rock I asked, "What is this, called?" The kid couldn't remember a single name I had given him, That was such a delicious balancing moment for me... however, I've since learned that the best balance never comes from getting even. - that's just another imbalance in the opposite direction. I left that kid with the same discomfort that I had felt. A far better way is to be brilliant enough to never leave the other person put down or feeling threatened. It's not easy but when I do manage to pull it off - I feel so proud of me.



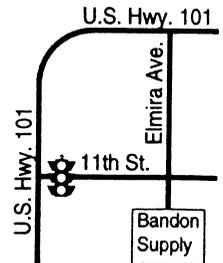

Hypothermia

Hypothermia, often called the killer of the unprepared, is a drip in the body's core temperature. This condition may

pose a real threat to anyone, including fishermen, boaters, hunters and hikers. Lynda Foster is presenting a three-hour workshop emphasizing practical training to prepare students in recognition, prevention and treatment of hypothermia. According to Foster, "By understanding all aspects of hypothermia, you may save a life – possibly your own."

The workshop will be held in Port Orford, Tues., Oct. 26th, from 6pm to 9pm, at the Port Orford City Hall. The cost is \$10.00.

Students will learn to define and explain the prevention and treatment of hypothermia. Both dry hypothermia, which may occur in mild weather conditions, and immersion hypothermia will be addressed. Leesa Cobb, of the Port Orford Women's Fishery Network, said in a letter of appreciation for Foster's training, "commercial fishing is the most dangerous occupation in the US. Our industry must take the steps necessary to minimize risks. Safety training is our greatest tool to preserve life and health."



State Parks Master Plan By Kathy Schutt

On June 25, 1999 the Oregon Parks and Recreation Commission, a statewide group appointed by the Governor to oversee the Oregon Parks and Recreation Department, decided to defer any recommendation on the Draft Curry County State Parks Master Plan until certain issues regarding the Canopy Project were resolved.

The Commission's next regularly scheduled meeting is November 4, 1999 at Tryon Creek State Park beginning at approximately 1:00pm. There is no agenda available at this time. At this meeting, the Commission is scheduled to reconsider approval of the draft Curry County Master Plan and authorize OPRD to initiate rule making. In addition, staff will update the Commission on the current status of the Canopy Walk Board and the project's grants.

At the June meeting, staff suggested five options for the Commission to consider regarding the Canopy Walk proposals in the draft master plan. The Commission deferred their decision because at the time, the Canopy Walk Board was unsure

whether the grantors would convey the remaining grant funds to another entity other than Curry County, and if so, what entity would receive and administer the grants and contracts and where the required matching funds would come.

The Commission will be reviewing the alternatives at this meeting for a second time, in light of current situations regarding the Canopy Walk Board and the status of the grants.


President, Chamber of Commerce

Commission chairman Leesa Cobb said she would like to see the bill caught up and paid on time. She said she doesn't want the Port carrying a business. Barnes said the PPS debt was \$10,500 when he took over. He said a large source of his income is live fish and with the construction it is more difficult getting water to keep them alive. He asked a couple of times what the Port would be willing to do for him. Scott Macdonald said every fisherman was going to take a hit on the dock construction and asked pointedly if the Port could subsidize everyone. Gayle Paige told Barnes he has the more space than anyone has at the Port and pays less rent than the other tenants do. She continued that the other tenants are staying current on the leases. Barnes responded to these remarks by saying there was no giving on the part of the Port, but instead all taking. Despite the amount of time spent discussing the issue no resolution was achieved.

The Commission expressed concern with water coming out of the pipe from the fill area below the Castaway Motel. It will be on next month's agenda.

More of the old wooden dock has been removed and there is now just a narrow alley left for boats to be towed to the yellow "permanent" hoist. There is now a sign stating that only one boat is allowed at a time on the dock.

A While Ago **By Jane Cramer**

A while ago I learned about a grassroots citizen effort to keep billboards from spoiling the pristine beauty of the southern Oregon coast. This anti-billboard campaign occurred 72 years ago, and shows that south coast residents have always appreciated the natural wonders of their area.

When the Roosevelt Highway was opened in 1927 the portion of the road from Marshfield to Crescent City was called the most scenic highway in America. An article in **Oregon Business** stated "So much has been written concerning 'the last frontier' that there is danger of causing this phrase to lose its power, but if there remains a shred of suggestion in the words, they are applicable to Curry County in the extreme southwestern corner of Oregon."

When the Shell Oil Company began to erect billboards along the new highway, people were afraid the beauty of this road would be destroyed and it would be completely plastered with signs like other Oregon highways.

Save The Roosevelt! Became the rallying cry. Newspaper articles and editorials proclaimed that public money built the highway and the people should have a say in protecting the natural beauty. Since the oil companies profit from travel, they should safeguard the rights of those who put up the money. Letters and article from PO News were reprinted in the Oregon Journal.

The successful campaign convinced 141 large national advertisers, including Shell Oil, that business could succeed without using the landscape for advertising and they agreed to restrict billboards to commercial districts. A December 13, 1927 Port Orford News article reported that the highway was free of billboards except for a few isolated signs which would soon be down.

To make sure the highway remained this way, the Port Orford Chamber of Commerce launched a campaign to get landowners along the route to sign cards, pledging that they would refuse to permit signs to be erected or painted on fences and buildings for a period of two years.

W.P. Young, who owned 25 acres of property along the highway south of Hubbard's Creek and between the Roosevelt Highway and Pacific Ocean, signed Pledge Card #1, which was titled 'County of Curry Pledge to Prohibit Commercial Advertising on Private Property.'

100 miles of highway from Bandon to the California line were free of signs by January 1928 due to the efforts of dedicated people a while ago.
