### The Cost Of Doing Business By Evan Kramer

Election time is once again upon us and ballots have been received in the mail for the special districts' election. Ballots must be marked and received by the County elections division no later than March 11, at 5:00pm.

One reminder for all the voters in the Port Orford Cemetery District — No one filed for two open positions. Roxanne Compton and Greg Gibbs who are currently on the board failed to qualify for the ballot because of a clerical error. They are asking the public to write-in their names for positions #1 and 2.

The part of this election attracting the most attention is the race for Port of Port Orford Commissioner, position #1. Incumbent Bill Oleson is the only candidate on the ballot for that position. However, last week a groundswell of support arose for write-in candidate Rocky Raccoon. The raccoon is a symbol of the opposition to Bill Oleson and to the practices he has been accused of regarding treatment of raccoons and cats. Please see the letters from Debra Timmons and Robert Courtright elsewhere in this paper and Howard Lichtig's letter last week.

people tried to alleviate the problem of raccoons eating the strawberries in Bill Oleson's garden. They worked out an arrangement with Oleson to pay for and install an electric fence around his garden to keep raccoons out.

On June 12, 1996, Bill Oleson was issued a "Wildlife Damage Complaint and Permit Form" to live-trap and shoot no more than 10 raccoons. The permit was issued by Oregon Department of Fish and Wildlife employee John Toman and expired on October 31, 1996.

I spoke with Curry County Clerk Renee Kolen on Tuesday morning. I asked her if the elections division would count the write-in votes for Rocky Raccoon. She told me the way it works is if the write-in line draws more votes than the candidate then the write-in votes will be manually counted. If the raccoon wins the majority of the votes then it will be up to the Port District to decide what to do. Later in the day I spoke with Port Manager Gayle Paige. She told me the Port District would have to pay the cost of counting the write-in votes if they had to be done manually.

Raccoons are typically 18-28" long with an additional 8 to 12" of tail. They weigh 12-35 lbs though chubby city raccoons may range up to 60lbs.

Raccoons are nocturnal (active at night) although city raccoons may be seen in the day. Raccoons do not hibernate. During cold winter months they can, and will, stay in their den for weeks at a time though they may emerge on warmer days.

Raccoons give birth to a litter of 3-5 kits in January to April following a 63 day gestation period.

Captive raccoons may live up to 14 years but those in the wild have a much lower life expectancy, typically around 6 years. Raccoons are solitary animals except during mating and possibly winter.

Raccoons are omnivorous. They eat birds, eggs, crayfish, crabs, carrion, mammals, fruit and berries. They seem to have a fondness for chickens.

Raccoons may range up to 2 miles but normally stay within 1 mile. The young may disperse anywhere within 30 miles and have been known to go as far as 165 miles (boy that one sure didn't get along with its folks!) Raccoon population in the wild may be 1 raccoon per acre to as little as 1 per 15 acres.

### CGH Hires Nurse Anesthetist

Nurse anesthetist Dee Schacher, CRNA, has joined the Curry General Hospital staff, announced Millie Bird, director of clinical services. She replaces Cyndi Jacobi, CRNA who relocated to a hospital on Oregon's central coast.

A nurse anesthetist provides anesthesia services for patients during surgery, labor and delivery and other procedures. Schacher also assists during emergencies as needed. She is on call 24 hours a day, and as such, never can be out of the Gold Beach area unless the hospital calls in a substitute.

Schacher comes to Curry County most recently from a 60 bed community hospital in rural Vermont where she also provided nurse anesthesia services. "We did a lot of orthopedic surgeries there," Dee says, "We were located near five ski areas."

She grew up in Oregon, at the north end of the Rogue Valley, and worked at Three Rivers Hospital in Grants Pass. After practicing nursing for more than 20 years, she earned her master's degree in the anesthesia field in 1993 from the University of Kansas Medical Center in Kansas City, Kansas. She received her bachelor's degree in nursing from Southern Oregon State College in 1986/

Schacher says she entered the anesthesia field because she loves a challenge and she is very "clinically oriented." She adds that she also enjoys working with people, "especially one on one which is what my duties entail."

When Schacher isn't at the hospital, she enjoys all outdoor and nature activities and crafting custom jewelry. She and her husband, Fred, also are interested in wildlife rehabilitation. They have three grown sons.



### **Beautification Questionnaire By Ed & Nancy Dowdy**

Results are in for the questionnaire seeking initial community input for a Highway 101 Beautification Master Plan. The planning is expected to be funded through a Forest Service grant. The questionnaire was widely distributed by the Community Response Team (CRT) and was included in this newspaper. Of the 700 plus copies distributed, 75 responses were received including 26 from businesses on 101. A detailed distillation of the results is available in the Library. Here are the highlights:

Liked the overall vision of a tree-lined street with green spaces using native plants supplemented with colorful flowers: 56 yes, 6 no, 13 no response.

Entrances to town: most wanted a clear sense of entry into the town. (See last week's Port Orford Today for news of the

Additional concerns: appearance of businesses and residences on 101 (painting, remodeling, more attractive signage) and safety (traffic too fast, although police enforcement has helped).

Ideas for carrying out the plan, once we have it: raise funds by benefits, donations, grants, and bed tax money.

Ideas for maintaining the landscaping: volunteers, businesses and residents for the landscaping in front of their property, the City. Professional oversight was suggested.

Many volunteered to help develop the plan. 34 volunteered to help pay for materials or provide in-kind contributions to carry it out and then to help with maintenance. Thanks to all of you. The governor told the assembled rural visitors that he is pursuing three immediate goals: 1) adequate education, 2) expanded health care, and 3) economic development.

Teams met with individual legislators in their offices to ask them to support Oregon Economic Development programs that help rural areas in creating jobs. A team from Brookings, Port Orford, and Myrtle Point visited with Representative Messerle and with Senator Tarno. Legislators pointed out that Measure 47 restrictions and mandated prisons will force every program to give, and no doubt the economic activities will help keep the cut to a minimum.

The importance of individual citizens communicating with their legislators about bills and issues was emphasized. ### **DUII Victims Impact Panel**

A DUII Victims Impact Panel will be held in Curry County on Wednesday, February 26, at 7:00pm in the Brookings City Council Chambers.

The Panel is designed to show DUII offenders the tragic consequences of driving under the influence of intoxicants. Victims who have suffered because of an intoxicated driver tell their stories to an audience of DUII offenders. By hearing a personal story, the offender can begin to understand the pain and suffering that often results from a DUII.

The Panel is based on similar VIP models held in other counties. However, it was developed specifically for Curry County under the direction of a community Task Force, sponsored by the Curry County Council on Alcoholism through a grant from Oregon Department of Transportation. Local victims speak and the Oregon State Police present a brief but graphic slide presentation.

This is an ongoing DUII prevention program with Panels scheduled periodically throughout the year. The next scheduled Panel is Wednesday, March 26, at 7:00pm, in the Gold Beach City Council Chambers. Members of the community over the age of twelve are invited to attend.



Few people in Curry County know who Leslie A. And Robert P. Pickett were. Their legacy was to provide the north county with a park. They wanted the park built for all citizens, and visitors to enjoy. Their other request was to dedicate this park in their name, so they could always be remembered for the gift they gave to our county.

On May 19, 1970 after Leslie Pickett had passed on, Robert Pickett formed a corporation known as the "Pickett Garden Park Foundation, Inc." In the Articles of Incorporation, Mr. Pickett wanted the foundation to maintain parks, museums, swimming pools, community halls, and such other recreational facilities or centers as the board deemed fitting and proper. Mr. Pickett was a smart man. In the Articles of Incorporation, he had four board members including himself. Mr. Pickett placed a paragraph in the Articles of Incorporation that states; "In the event the Board of Directors shall fail or refuse to act within 60 days after a vacancy shall occur, or board of directors shall be reduced too less than a quorum than vacancies shall be filled by a member of the Port Orford Chamber of Commerce, Port

Orford Rotary, Port Orford Lions, and Port Orford Garden Club." It further states; "In the event the Corporation should ever become defunct for any reason, then all assets of this park would be turned over to Curry County Oregon to be used to maintain a park known as the Leslie and Robert Pickett Memorial Park."

On April 27, 1972, Robert Pickett died. In his will he left assets to the Pickett Park Foundation that included a 49-acre parcel located just north of Knapp Road in North Curry County.

On July 28, 1983, the State of Oregon, Corporation Division dissolved the corporation because the Corporation had not filed its annual report or corrected annual report within the time prescribed by ORS.57.757, or had not paid any license fee, or penalty when due.

I found out about this property by rumor. I had heard a rumor for eight years that there was property left for a park. I decided late last year to investigate this property, and determine if there really was some property available for use for recreational purposes. My idea was a baseball field for the community. I found the will, corporate papers, and other documents. I found through my investigation

that part of the Pickett Park property has been leased for some time, and earnings from the property have been used to pay the taxes, and that the taxes have been paid up to date by a representative of the defunct Pickett Garden Park Foundation, Inc. The documents I found are all public documents, filed in Curry County or the State of Oregon.

After reading the will and other documents, it was clear to me that something needed to be done so the names of these two generous men would not be forgotten. I found through my investigation, that the corporation could not be reinitiated because of the State Corporation Law.. I went to the four community organizations and got a representative from each. Each of the listed organizations agreed to provide a director in the event we could restart a corporation. The county was then advised of the circumstances of the property. It is now in the commissioners hands.

It is very apparent that Leslie, and Robert Pickett wanted a park built in their names on the property they left to the citizens of Curry County. Their original wish was to have the oversight of this park by a corporation, and not city or county government. I have circulated a petition requesting people to sign showing they have an interest in restarting this corporation and building a park. This petition is not intended to take the property from anyone who has a genuine interest in it. The intent is to show the commissioners there is a real interest in restarting this corporation, and if the county acquires the land and assets, that the corporation is restarted and those assets given to the corporation. The intent here is to use that property for a park in memory of Leslie and Robert Pickett.






One of the bidders for this area is Bay Cities Ambulance. They are a full time, 24 hour ambulance service.

Since most critical cases go to Coos Bay where an emergency room doctor is on duty, not on call like Gold Beach. It is up to you to contact the commissioners before March 3 and let them know who you want taking care of you on the long trip to Coos Bay. Your life may depend on it.

## **To the Editor:**

I have lived on the shore of Garrison Lake for nearly 30 years and monitored the many kinds of beautiful wildlife which also live here and around the surrounding wetlands. Hundreds of other citizens also take great pleasure in watching God's critters, this is one of the great benefits we have here in Port Orford. Anyone, not wishing to SHARE the community environment with the animals that are here should consider moving to a large city that does not offer this unique pleasure and opportunity.

Unfortunately, many of these animals that have been seen on a daily basis, started disappearing at an alarming rate last year. People began calling me, about this problem. Then an outraged member of the Gun Club, told me that Bill Oleson had killed 6 or 8 raccoons and was bragging about it. Other people came forward and told similar stories. At this point, as far as I was concerned, it was all hearsay. However, the credibility of these people was so great an investigation was started. I called the police chief Barney Issel, the county trapper, the state police, the humane society, etc. All said we needed proof. I talked with Howard Lichtig and he wrote a letter to Oleson. In the meantime, Barney went to Oleson and told him, if he did not get a permit to kill the animals he would probably get into trouble because it was upsetting too many people. Oleson immediately applied for and received a permit by telling John Toman of Dept. Fish & Wildlife that raccoons were destroying his property and that he did not want ANY animal on his land as it was "an invasion of his privacy". Everything that I am saying, is documented in writing and/or first person communication. As a result of Howard's letter, Oleson responded and invited us to come to his property in an attempt to solve the "problem". Five of us were given a tour by Oleson. He bragged about his beautiful flowers, his strawberry plants which were loaded with berries, etc. NO

WHERE DID WE EVER SEE ANY EVIDENCE OF ANIMAL DAMAGE OF ANY KIND. Nevertheless, in good faith and in hopes to stop the animal killing, (which Oleson directly to our faces admitted he was doing) we agreed to pay for and install a small mammal electric fence wherever Oleson wanted it. Oleson told us it would only be needed around the strawberries, but he would CONTINUE to trap and kill UNTIL the fence was installed. We ordered the supplies and a week or so later, set up a time that was convenient for Oleson and installed it under HIS supervision and to his satisfaction.

After we had completed the job, Oleson told us that we were stupid to use our time and money for this project. Because he intended to CONTINUE to trap and kill the animals! He also stated that his friends would too. I guess birds of a feather flock together. It is no longer hearsay to me, I was there and I will not be intimidated by threats.

One last thing. The Port and Commercial Fishermen: Folks, these guys and gals are the most dedicated, hardest working people you can find anywhere. They are very tough, but they have the biggest warmest hearts of any people I know and everyone of them will go to the aid of any Person or Animal that has been hurt, abused or needs help. And this, if for no other reason, is why MY write in vote, completing the arrow is for ROCKY RACCOON for Port Commissioner position #1.

I spoke with Bill Oleson early Tuesday evening. I asked him if he had been trapping and shooting raccoons or household pets. Oleson told me "I haven't killed any raccoons nor any household pets". He said he hasn't done anything wrong. He said the raccoons he had trapped he had released alive. Oleson complained about receiving many phone calls at his home from people who were hanging up.

I can sympathize with anyone who has suffered damage from wild animals. The damage count around our house is at least six chickens killed, dogs, raccoons and possum eating cat food intended for our outdoor cats, and destroyed bird feeders. But I look at as if it was the cost of doing

business. We live in a rural area surrounded by forests, pastures, wetlands and rivers. We're going to come in contact with wild animals whether they are raccoons, skunks, coyote, cougar or bear. It has never occurred to me to get a permit to trap and kill the raccoons that have helped themselves to several chicken dinners along with many helpings of cat food not intended for them. I feel the obligation is on me to protect my livestock and cat food. I could have built a roof over my chicken yard and I could take the cat food in at night. One thing I don't do, and this is where I differ from many other people who appreciate and respect animals, is that I don't feed or attract them to my property. I prefer chance encounters whether it's a deer wandering through my yard, a bear ambling across Elk River Road or a beaver busy at work building a dam. Each to his own.

I voted for Rocky Raccoon for port commissioner position #1. I don't expect the masked furry one to win and be seated on
