Council Declares Emergency Article by Evan Kramer



January 28 was Chinese New Year's Day. This is the year of the Tiger in the Chinese calendar, which is appropriate considering the New Year in Port Orford is coming in with a ferocious roar.

The Port Orford City Council held an emergency meeting on Monday at noon as the City's wastewater drain field was threatened with imminent destruction. City Public Works Director Jerry McNurlin showed the council and public a video of what the dunes at the city's drain field look like now. He said the siphon vault where the treated effluent water goes is about to slide into the ocean and the photos bore that statement out. There are no more dunes left to protect it from dropping into the ocean. This vault was located some 100-150 feet from the surf line until the last couple of weeks. However the same winter conditions which have washed away the dunes protecting the outlet creek from the ocean have also eaten away most of the dunes protecting Garrison Lake from the ocean. The video showed the monitoring wells are now located in the surf zone. Councilor Robert Warring said he wasn't convinced we have an emergency that

can be solved. He said that it was a bad choice to begin with putting the drain field in the dunes.

Councilor Ralph Donaldson stated what was happening was an "Act of God."

McNurlin told the council he has contacted many state agencies including the Department of Environmental Quality, State Parks and State Emergency Services. McNurlin said he wanted to save what we've got. McNurlin has looked for contractors who could help save the vault and drain field. Port Orford based Forest Access was one of those contacted about riprapping the area. Warring said riprapping will cause problems and urged the council to let the drain field go and instead consider an alternative.

The council adjourned to the public works office for a conference call with city lawyer Randall Tosh. Tosh said they need to adopt a resolution declaring an emergency. He had one written up and faxed them a copy. He said they need to designate an emergency response officer and a person on the council that officer reports to. The council chose McNurlin as the response officer and Ralph Donaldson as the councilperson he will report to.

The council reconvened the public portion of their meeting in the council chambers. Ralph Donaldson made a motion

with Jim Campbell seconding to accept Resolution 98-07 declaring an emergency. The motion passed 5-1 with Donaldson, Campbell, Carl Eskelson, Tim Sparks and Ruth Jamieson voting for it and Robert Warring voting against it. Donaldson said we need to solve the problem with the least funds spent. He urged the council to save the drain field.

Councilor Warring said he wanted someone competent to review the proposed work. He wants an outside opinion. He also said he hadn't been made aware that contracts had been let to dig the trenches, which opened the lake outlet creek. He asked for better communication.

McNurlin has contacted Wilbur Turnick, a specialist in ocean dunes about the situation and Turnick recommended riprapping.

Jim Britell told the council he was against riprapping. He stated all it would do is move the problem around and may cause a problem elsewhere. He said we need the best brains involved in ocean hydrology and volunteered to help the city resolve the problem in any way.

Ralph Donaldson said we need to save the siphon vault and "we're talking millions (of dollars) if the drain field goes".

Resolution 98.07

A resolution of the City of Port Orford, declaring an emergency and making provision therefore

WHEREAS, ORS 401.309 authorizes the City Council of the City of Port Orford to establish procedures to prepare for and carry out any activity to prevent, minimize, respond or recover from an emergency; and

WHEREAS, an ORS 401.025(4) defines emergency as including "any manmade or natural event or circumstance causing or threatening loss of life, injury to person or property, human suffering or financial loss"; and

WHEREAS, the City of Port Orford has a "dune field drainfield" (the drainfield) as a component of its wastewater treatment system for the disposal of treated effluent; and

Whereas, the drainfield is located in an area of dune field located directly adjacent to the Pacific Ocean; and

WHEREAS, as a result of recent storms and high surf, the foredune of the dune field has been eroded by the Pacific Ocean, and no longer protects the drainfield, and

WHEREAS, the drainfield is threatened with destruction in the immediate future, for which there is no ready solution; and

WHEREAS, such destruction will cause the discharge of treated effluent in a manner not authorized by law and creating conditions for contamination and other conditions recognized as emergency conditions; and

WHEREAS, by virtue of the Port Orford City Charter, Chapter II, Sections 4 & 5 and Chapter III, Section 6, the City Council of the City of Port Orford is vested with the power to declare that a state of emergency exists;

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Port Orford, that as a result of the erosion by the Pacific Ocean the City of Port Orford's wastewater treatment facility has been placed in immediate peril, the City Council hereby declares an emergency exists pursuant to ORS 401.309(1);

BE IT FURTHER RESOLVED, Jerry McNurlin is hereby designated as the official charged with carrying out the emergency duties and functions necessary and incident to this resolution, who shall be known as "the Emergency Response Officer" of the City of Port Orford;

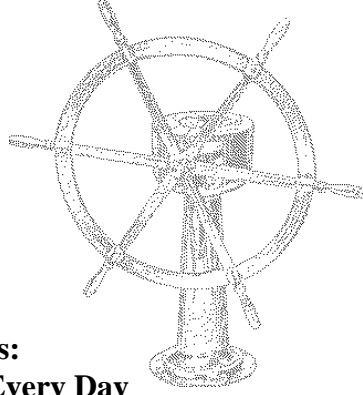
BE IT FURTHER RESOLVED, that the Emergency Response Office shall report directly to Ralph Donaldson who shall be responsible for communicating directly with all members of the Port Orford City Council;

BE IT FURTHER RESOLVED, that the Emergency Response Officer may and shall notify all necessary and proper authorities regarding the emergency, may schedule meetings with officials for the purposes of eliminating the emergency;

BE IT FURTHER RESOLVED, that the City Council may enter into contracts and incur obligations necessary to mitigate, prepare for, respond to or recover from the emergency hereby declared, and shall have such other powers as are granted it under ORS Chapter 410.

Approved by the Common Council of the City of Port Orford this 2nd day of February 1998.

not know scientifically what it takes to produce such a healing, how much courage, how much passion to live must there be? We can say however that Cayenne was and is a very congenial tool to use, it is so aligned with Life.

Some herbs are reputed to be “thinking” herbs. They seem to modify their action according to the needs of the body. Cayenne always means greater circulation, more blood, but when the crisis is severe bleeding, internal or external, Cayenne stops the bleeding, quickly and completely by redirecting pressure away from the damage but increasing the delivery of repair materials through the capillary beds.

I was building a fence with two men who were driving steel posts into the ground. The head flew off the sledgehammer, felling one of them with a nasty wound to the scalp. Blood spurted and I ran for the Cayenne, dumping a couple of spoons full onto the mess. The bleeding simply stopped, he stood up as though nothing much had happened and we went off to get him sewn up.

I confirmed this result later when I split my own head open. Another plus for Cayenne – when used in trauma like this it minimizes or negates the need for the body to go into shock while accelerating the healing process.

The call volume for South Coast EMS in 1997 was as follows: July, 16 transports, 14 no transports. August, 17 transports and 11 no transports. September, 14 transports and 2 no transports. October, 10 transports and 14 no transports. November, 17 transports and 5 no transports.

Since South Coast EMS was classified as a non-profit organization they should have been allowed to use the ambulance chutes at City Hall. This was blocked by the city council voting to allow Port Orford Ambulance to store their ambulances there. They get free use of the chutes and pay no

if they would put the County back up for bid. This service area covers 2 grade schools; 1 middle school, a high school and lots of seniors. I believe we have bases for schools, libraries, fire departments and cemeteries. Why not a base to cover a full service ambulance?

For a cardiac patient the EMTs must reach the patient within 10 minutes to administer the proper drugs and open an airway or it's DOA. An EMT cannot use a respirator. Only a doctor or nurse may do so.

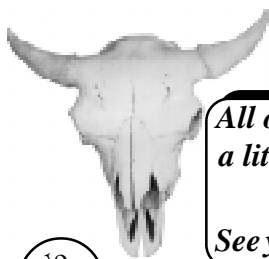

John W “Red” McWilliams

John W “Red” McWilliams passed away on January 30, 1998 at OHSU in Portland, Oregon at the age of 81.

John was from the Cape Cod community of Wareham, Massachusetts. After completing his education he played semi-pro football. He came to the Port Orford area during World War II while serving with the U.S. Coast Guard. He was stationed at Cape Blanco.

He married Nadine Babel in 1946 and settled in Port Orford. In 1949 he built and ran a gasoline station and garage, “Reds’ Associated Flying A”, which currently house “The Crazy Norwegian” restaurant.

John and Nadine owned and managed the Shoreline Motel for many years. During the same time John became both a Real Estate and Insurance Broker as well as a State Real Estate Appraiser. For many years his “Shamrock Real Estate and In-

surance” office was located on Highway 101 near Battle Rock Park.

John was very active in civic affairs throughout his life. In 1956 he coached the Junior High basketball team and won the county championship. He also organized and coached Port Orford’s first Little League Baseball Teams. He was an original and active member of the Pacific High Quarterback Club.

John was a charter member and past President of the Rotary Club and received the Paul Harris Fellowship Award, served two terms on the city council, was twice president of the Chamber of Commerce, and was on the County Juvenile Advisory Committee.

In the mid-1950’s John served as Port Orford’s Police Commissioner. In the early 1980’s he was Grand Marshal of the Port Orford 4th of July Jubilee.

John is survived by his wife of 51 years, Nadine and children, Mike, Ellen, Julie

and Jon, and grandchildren.

A Memorial Service and celebration of his life will be held in the future.

The fisheries service held public hearings in Gold Beach, Oregon, and Eureka and Santa Rosa, California, to gather public comment.

The fisheries service said it welcomes comments and recommendations on any aspect of this proposal. In particular, the agency is requesting any data, maps, or reports describing areas in the Central California coast and in the Southern Oregon/Northern California coast that currently or previously supported coho salmon and that may require special management consideration.

Comments on the proposed rule should be sent Garth Griffin, NMFS Protected Resources Division, 525 NE Oregon Street, Suite 500, Portland, OR 97232. The fisheries service will consider all comments received by that deadline before reaching any final decision.

The Federal Register notice announcing this extension (1/27/98) and the previous notice describing the proposed critical habitat designation itself (62 FR 62741) are available at the Government Printing Office's website at www.gpo.gov.

More on Hubbard Creek

This letter was given to us by the City of Port Orford and is part of the official record.

November 17, 1997

Dear Mayor and Council:

I raised the question about the fish ladder being installed at the Hubbard Creek water impoundment of the City of Port Orford for the following reasons.

The remarks of Mr. Grey indicate that he believes a fish ladder is a one-way structure used only to get salmon up the stream. It is a two-way conduit that also allows juvenile salmon, steelhead, sea-run cutthroat and other species to return to the sea as well as ascend the stream. Those events occur at various times of the year, not just at high-water events in the fall. There-in is the possible problem I envision.

The fish ladder may introduce coho salmon which are on the endangered specie list. This could have a profound effect on land use activities in the watershed.

The steelhead and sea-run cutthroat are also candidates for listing as endangered and are present in Hubbard Creek. (Watershed letter summer of 1997)

I am a property owner in the North Fork Hubbard Creek watershed and I am engaged in growing Christmas trees, noble fir boughs, Port Orford cedar boughs and other ornamentals. I engage in land clearing, soil tilling, use of herbicides and fertilizer. My business could be severely impacted by the building of this fish ladder and enlargement of the impoundment.

I, therefore, request an Environmental Impact Statement be prepared by the City to address these issues and determine

what affect it could have on future land use activities in the watershed.

I am also concerned about the burying of the water pipes from Hubbard Creek in the Wetlands of Gold Run Creek. Gold Run Creek has been identified as a source of water to augment Hubbard creek flow during low flow periods by the Project Engineer Matt Grey of HGE. I am requesting an Environmental Impact Statement be done on this watershed.

**I'm Looking Over...
By Donna L. Hoffmann**

With all the rain we've been having lately, some Haida children must have been picking the Red Rain Flowers (Red Columbine, which I wrote about in my last article.)

This time the plant of choice is Springbank Clover (*Trifolium Wormskjoldii*). It's considered a perennial herb with creeping rhizomes; red to purple flowers; often white tipped; growing in moist to wet places, from low to middle elevations. This clover differs from other perennial clovers because it has an 'involucre': A cluster of bracts under the flowering head. It has long fleshy, white rhizomes, which were important food source to the Northcoast peoples Sechet, Haida, Kwakwaka Wakw, Nuu-Chach-Nulth, and straits Salish to

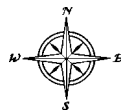
name a few. They were harvested and prepared with the roots of Silverweed. Both were usually dug in the fall after the leaves had died back. Both grew in dense patches along estuaries, which the Kwakwaka' Wakw and a few other groups, divided the patches into beds which were owned by families or individuals and passed down from generation to generation. The beds were 'weeded' and sticks and rocks were removed and the annual cultivation most probably enhanced these beds. At some point, the Nuxalk transplanted these species and worked them as we would our vegetable gardens. They dug up the rhizomes with a stick and wrapped them into a fist-sized bundle, using one of the roots to tie it

together. The roots were sometimes eaten raw, but most of the time they were steamed in a box or underground cooking pit, then dipped in fat or oolichan oil. The raw rhizomes were stored raw in underground boxes or dried for winter use. Reportedly the flavor is sweet, similar to young green peas. (I wouldn't suggest trying this at home!)

Attention Holly tree owners: Now is the time to spray again with micro crop to prevent the leaf and twig blight...If you can get a day that it isn't raining.

Council Declares Emergency Continued from front cover

John Mayea told the council he had gone out to observe the drain field and dunes on Friday, January 30. He called county commissioner T.V. Skinner later that day to explain the situation. He brought up with Skinner the possibility of the county providing a piece of equipment to keep the lake outlet open. He asked the council to authorize McNurlin to contact the county about getting a piece of earth moving equipment and station it close to the lake outlet. Mayea said that as of Friday there were 32 feet of dunes protecting the siphon vault and drain field. On Sunday there were 14 feet and on Monday there were none.

Meanwhile the lake outlet creek has been blocked from Wednesday, January 28 through Monday, February 2 and high water is threatening septic tanks, basements of homes, flooding 12th Street, and is ready to raise havoc with the sewer and water system if some of the water isn't let out.

Okays Emergency Spending

The city council met on Monday evening at 6:00pm. The original purpose of the

meeting was to set goals. However, they also discussed the situation with the drain field and siphon tank. Jerry McNurlin explained what the city wanted to do. They want to dig a deep trench in front of the siphon tank and drain field and fill it with "jetty" rock. Then they will put more jetty rock on top of the first layer of rocks. Jerry said so far the leach fields are okay. He described the jetty rock riprap as a temporary emergency repair. The riprap section would be approximately 50 feet long. McNurlin has contacted and arranged for the work to be done by Forest Access. They will install culverts and put a bridge across the lake outlet creek and build a road to the drain field and siphon area. This will cost up to \$50,000. Jerry then said it would cost over \$1,000,000 plus to repair the property after the winter storms are over.

The council ended this discussion by convening a special emergency session at 6:20pm. Councilor Ralph Donaldson made a motion to authorize Forest Access to start work to prevent further dune erosion at the siphon tank and drain field area at a cost not to exceed \$50,000 and do no more work than is necessary to get us through winter. The motion passed 3-1 with Donaldson, Jim Campbell and Carl

Eskelson voting for it and Robert Warring voting against it.

Tuesday Morning February 3

I loaded up my rain gear and Myrtle and we drove down to Agate Beach Trailer Park about 7:30am. We walked out to the drain field for a look at the siphon tank. It is literally hanging in midair. It hadn't dropped into the ocean but at least three feet of it was exposed and the bottom portion was being undermined. I was surprised it was still in place. I continued north of the drain field to one of the few high spots left between the ocean and the lake. I had spent several hours on Sunday afternoon out here with Robert Warring and Jim Rhodes during high tide and we watched with awe and wonder as the waves pounded the dunes and chunks dropped into the water.

Myrtle and I then walked back to the lake outlet creek where it is plugged. About this time I heard a bulldozer and saw a D-6 cat with Curry County insignia rumbling down to the beach. The county equipment came with a two-man crew. One of the men started working on building a temporary dune before clearing a channel. Shortly after this Jerry McNurlin arrived. He told me he was responsible for the county crew arriving to clear a channel for the lake to begin draining again. He had spoken last week with county roadmaster Dan Crumley about the city receiving assistance. McNurlin told me Forest Access would begin their project sometime today and by 10:20am they were at Agate Beach working on the access road to the dunes.

Valerie did a bit of research. From now through Jan 31, 2000, we will have 126 days on which there will be tides 8.0 ft or greater and on 45 of those days the tides will be 8.5 feet or greater! On 16 the tides will be 9.0-9.4 feet!!! The next 8.5+ tide will be Oct. 7, 1998.

All I can say is, you've got to see what's happening on the ocean shore to believe it!
