City Administrator Appointed By Evan Kramer



The Port Orford City Council met for the fifth Monday night in a row earlier this week. The meeting began with a report from Public Works director Jerry McNurlin. He told them that KCM, the company the city has contracted to do the drain field study, is bringing a geotechnical firm to Port Orford on August 20 to study the drain field dunes. He said someone in an act of vandalism had covered the inside of the men's restroom at Buffington Park with brown shoe polish. He has gotten in touch with Bracylin-Yaeger for a quote on some small street repairs. McNurlin has ordered some "No Through Truck Traffic" signs to keep the big trucks off Washington and other side streets. He noted the bridge at the North Fork Hubbard Creek reservoir is almost installed.

Councilor Jim Campbell said there have been 15-16 applications for police chief with two of them coming from Oregon. The cut-off date for applications is August 15.

Dave Wilken gave the council a presentation about the Central Wetlands Greenway located between 16th and 17th Streets on the west side of Highway 101. He said

news had just been received that Port Orford was awarded \$83,000 by the Federal Highway Administration to fund the project. He said a 20% matching grant was required and there were two programs available including the Coos Curry Douglas Business Development lottery funds and Oregon Economic Development Department tourism funds. Wilken said substantial public input was needed for this project and would include six public meetings. He said the project was designed with minimal maintenance in mind. Councilor Carl Eskelson insisted he wanted a public hearing before the council accepts the grant. Councilor Robert Warring made a motion authorizing the application to Coos Curry Douglas for a grant of up to \$15,000 and the OEDD tourism office for a grant of up to \$5,000 and that the council designate councilor Norm Leeling to oversee the grant applications. The council passed the motion unanimously.

The council passed a motion for a new job description for the city administrator. City administrator is a new title for the job formerly called city administrative assistant.

Mayor Gary Doran said the city had received 22 applications for the city administrator position. They whittled that number down to six and then interviewed five

of the candidates earlier that day with the sixth applicant, Jim Poland, having withdrawn his application. Councilor Ralph Donaldson made a motion to accept the application of Johnny Alexander for the position of city administrator. He is from Tucson, Arizona and has an MA in public administration with six years work in that field in Tucson. He is a retired Air Force Lt. Colonel and flew 33 combat missions in Operation Desert Storm. He will be available to begin work on August 31. The council unanimously agreed with the motion.

Mayor Doran said the only applicant for the vacant planning commission seat had withdrawn their name earlier in the day. Notice of the vacancy will be placed in the newspapers. Mayor Doran appointed Rick Cook and Jean Kilburn to fill two vacant seats on the Parks Commission. He thanked Bonnie Allen and Jane Cramer who both recently resigned from the Parks Commission for their service to the city. The council accepted his appointments unanimously.

The council turned to the sewer charges paid by Paula Cracas and attempted to resolve a long-standing situation. Councilor Carl Eskelson made a motion to refund to Cracas all the money she had paid in sewer charges during the time her

The regular luncheon is August 22nd at 11:30am. Also a rummage sale from 8am till 1:30pm.



Port Orford Sewage Disposal

To: Mr. Jim Poland

Subject: Port Orford Sewage Disposal

The Department of Land Conservation and Development (DLCD) is writing out of concern that the City of Port Orford may be considering reconstruction of the community sewage drain field destroyed by erosion this past winter. While DLCDC could support a long-term solution to the City's sewage disposal needs, available information indicates that reconstruction of the drain field is not a viable, long-term alternative. Specific concerns are:

The beach and dune system is highly dynamic in this area, and the erosion hazards are now very evident. According to a recent geological hazard report prepared for the city regarding the sewage and water systems, any facility at the current drain field site would continue to be subject to coastal erosion events. The report findings do not support the reconstruction alternative:

"But there is also a probability that sometime in the future another El Nino will bring about a renewal of the erosion problem. Therefore, any solution to the erosion and the parallel problems concerning what to do with the sewage treatment plant and fresh water sources should take a very long-term view. With the likelihood of returned erosion sometime in the future, it would for example be unwise to reestablish the drain field in the foredunes backing the beach". (Report to the City of Port Orford-Shoreline Erosion at Port Orford related to the 1997-98 El Nino by Paul D. Komar and William G. McDougal.

In 1991, the Department raised a concern about what seemed to be inadequate consideration of erosion hazards in the geological report for the drain field project. The Department explained to the City that the drain field would need to be sited and designed carefully because the facility would not be eligible for a beachfront structure under statewide planning goal 18 for beaches and dunes. Goal 18 restricts placement of beachfront protective structures to areas where development preclude both the county and state from issuing permits for protective structures along the ocean shore. However, it seems

unlikely that a new drain field could be constructed without the eventual, if not immediate, need for a protective structure.


Further public expenditures on a sewage disposal system for Port Orford should be targeted to a system that will remain viable for years to come. A well-designed system is necessary to protect the health and safety of the citizens of Port Orford. None of the information provided to date indicates that reconstruction of the drain field would be a wise investment or even feasible under state and local law. The drain field option would simply be placing more public investment in harms way. Therefore, the Department encourages the City to focus its efforts on finding a new option for sewage disposal.

The Internet is a fantastic resource and it keeps getting better. The only problem is that it can be difficult to find what you're looking for. Here are a few tips to get you started.

If you know where you want to go (maybe you saw the address in an ad or on TV), just type in the address and go there. If you want to get to some specific company or national product, try typing the company's name or product's name with "www." in front of it and ".com" behind it. For example, if you are interested in buying a Ford car, visit www.ford.com.

If the place you want to get to is part of the government, use ".gov" instead of ".com". For example, www.whitehouse.gov takes you to the White House site. Sometimes you have to try a few alternatives. www.postoffice.gov or www.mail.gov may not get you where you want to go but www.usps.gov takes you to the United States Postal Service. Besides ".com" for "commercial" or "company" and ".gov" for government sites, you may also visit ".edu" education and ".org" organization sites.

Another good way to get around is to start with a "hub" site that leads you through categories to relevant links to other sites. Some of the main hubs like this are:

- www.yahoo.com (everything!)
- www.cnet.com (computer & technology)
- www.cnn.com (news & weather)
- www.cyndislist.com (genealogy)
- www.geocities.com (everything)
- www.lycos.com (everything)
- www.dataweb.net/~sham/ln_comme.html (cats)
- www.loc.gov (Library of Congress)

Well, you get the idea. Of course, you can bump into the odd and interesting if you get the name wrong. I tried to go to the Library of Congress site but gave a ".com" name instead of .gov and was given a link to "learn the secrets of sex" I knew I





Scenic Byway By David Wilken

A grant of \$83,000 has been awarded to Port Orford by the Federal Highway Administration (FHWA). Word came last week that the City's application last winter for "Scenic Byway" funds has been selected to receive over one percent of the total money available for the whole country. The Wetland Greenway/Scenic Byway proposal was one of four along Oregon's Highway 101 approved by FHWA, according to Terry Cole of the Oregon Department of Transportation (ODOT). Curry County, in fact, will be receiving over five percent of the national total, as a Wayfinder Point at Myers Creek, South of Cape Sebastian, will be built with \$286,691 of the Scenic Byway grant money.

Port Orford's project will ultimately consist of three wooden viewing decks, one on the east side of 101 and two on the west, located on City right-of-way for 16th and 17th Streets. The two west decks will be connected by a boardwalk down to, and out over, the wetlands between Sentry and Kar Kare Auto Parts. The boardwalk will include a sheltered viewing platform at about midway between the decks, all of which will be handicapped accessible. The school district expects to use the facility for outdoor education during the school year to expand their watershed science offerings. Locals and visitors alike will be able to learn about the wetlands' plants and ani-

mals from "interpretive" signs, which will be located along the boardwalk, on the decks, and along the sidewalk.

The grants were originally scheduled to be announced in March, so just about everyone involved had given up hope of obtaining funding for the project this year. The original plan was to spend this year doing the design work, then building the project next summer. There will be frequent public input meetings during both the design and construction phases. A concept drawing has been posted at City Hall. The drawing, however, shows curb extensions as part of the crosswalks envisioned. They will not be included in the final design if the "Highway Beautification Plan" is defeated in the November election.

When the surprise announcement came, planning team chairman Dave Wilken said, "Our community has been through some difficult times lately, and the controversy over change and 'outside' funding continues. We hope everyone remembers that this project came out of City Parks, will create a unique tourist attraction, be a valuable resource for us 'locals'. And give a boost to local builders and suppliers. It will be designed locally, built by local residents using locally purchased materials, be beneficial to all who care to use it, and be paid for by outsiders. The present Federal grant system may have flaws, but if this year's Scenic Byway money had been left in our own pockets, it would have amounted to

a little over two cents per resident. Our "fair share" of this fund would have been about twenty dollars for the whole city, and we're about to end up with \$83,000 to pay for a darn good project, dreamed up and applied for by local volunteers."

**Maurice Messegue IV
By Graeme Graydon**

By the summer of 1949, the 29 year old Messegue was in such demand that he had no time to gather his own plants. He employed the peasant folk from his boyhood village to do this. He had a State License to practice Radiesthesia, (use of a pendulum for medical applications), and he had made peace with the Pharmaceutical Associations for he never charged for the herbs that were the basis of his treatment. H never diagnosed a condition but always asked for the doctors diagnosis recognizing that although doctors knew little of their patients they did know a lot about illnesses. He never disputed a doctors diagnosis and often sent clients for x-rays or testing for no other reason than to be sure to do no harm. Messegue had more patients than any doctor in the area, often succeeding where they had failed.

Then the Medical Association voted 21-4 to nail him for practicing medicine illegally. (The four dissenters had all sent their wives to Messegue for cures that they could not achieve themselves.)

By this time his patients included the President of France, Edouard Herriot and

75 of his Deputies in the Chamber, a tenacious journalist had investigated and published his report in a Paris Weekly which concluded – "It may be that his work defies law and logic, but the fact remains that he does heal."

The threat of prosecution was devastating to Messegue, but it brought out his peasant resilience. His lawyer produced a parade of witnesses, each with a moving story of release from illness. The President of the Medical Association and two other doctors disassociated them from the action taken by their colleagues and defended him soundly. But the case was not about how many people were healed, but that he had no right to heal them. He was declared guilty and fined \$40 which was awarded to the Medical Association. The crowded courtroom erupted in jubilation seeing the outcome as a victory, but Messegue could only see that he had shamed his father's name, he was not qualified to heal and he resolved to go back to teaching.

The next day at dawn, there was a light tap on his door. The concierge said – "Monsieur Messegue, they're here, they're waiting to see you." Who! "More than a

hundred of them." "I'm not seeing anyone and he shouted, "I don't have the right!" A very ordinary woman appeared behind the concierge, looked straight into his eyes and said "Sir, it's not possible, you can't do this to us." And he couldn't, so his door was opened and his work continued. Over the years, twenty more court cases were called. Messegue never got used to the conflicts, which always made a criminal of him. By the time of his final case, his witnesses had included British Royalty, many famous personalities, professors of medicine and a strong support of doctors. Prosecutors and judges grew weary of sentencing the man who had healed their illnesses. The dispute moved off Messegue shoulders to an examination of laws that were inadequate. He found some peace in the understanding that although he would never have the comfort or honor of the title of doctor, he would be known as a pioneer in the arts and science of Phytotherapy – healing with plants

Sometimes Thelma Hoffmann thanks she's swimming in alphabet soup. A former teacher who taught kindergarten in Europe, Hoffmann now volunteers as a community services specialist in Curry County. Part of her initiation was learning to maneuver between groups known as RARE, SCF, CGH, CCHS and CCCCFC. Over the next 10 months, Hoffmann will work closely with these groups and ordinary citizens wishing to make things better for everyone in Curry County – from fishermen and ranchers to homeless children.

One of her primary projects will be to assess and evaluate health needs and services. She'll guide members of the Community Partners Program through "a planned approach to community health," also known as PATCH.

New Recreation Fees Should Go By Representative Peter DeFazio

The scene: the French Pete Creek trailhead in the Willamette National Forest. A sign informs would-be hikers that they are now required to pay \$3 for the privilege of hiking on a forest trail. Similar signs have sprouted up at trailheads and beach access points throughout the state.

The scene: the Goldstrike mine, a massive industrial earth-moving operation located on about 1,700 acres of land formerly owned by the federal government in Nevada. The Canadian company that owns the mine expects to remove about \$10 billion worth of gold from the site. Under the archaic 1872 Mining Act, the company paid the U.S. taxpayer on \$9,765 for this golden giveaway. If the land was still in federal ownership, the company could mine the gold without paying one dime in royalties to the U.S. government. The U.S. is the only landowner that doesn't charge mining royalties.

Congress is socking it to ordinary citizens who want to enjoy their public beaches or take a hike in their National Forests. But a multinational corporation is allowed to take a free hike straight to the bank carrying billions of dollars worth of gold mined on our public lands.

These new user fees are part of the so-called Recreational Fee Demonstration Program authorized by Congress about two years ago. The program gave the federal land management agencies the authority to raise existing fees and create new ones. So far, the fee program has generated 95 new access fees, a price increase for Golden Eagle passes, 119 new passes good for a single forest or park, 29 new day use fees, 23 hunting and fishing fees, wildlife viewing fees, trail fees, motorized recreation fees and more.

In theory, these new fees are supposed to be returned directly to the forest, park or wildlife refuge where they were collected for needed improvements. But the early

indications are that a lot of money is disappearing into the bureaucracy.

Last year the Forest Service spent about 53 percent of the fees it collected on "collection costs." The National Park Service didn't do much better. Some of the high overhead can be attributed to start-up costs. But especially for the Forest Service—which is trying to collect these extremely unpopular fees at trailheads and other widely disbursed recreational sites – it is likely that collection costs will continue to be very high.

The recreational fee program violates the principle that our National Forests belong to the people of this nation and should be accessible to them. It also is fueling a deep resentment our land management agencies and of Congress. It should be repealed.

Crab Management Bill

The House of Representatives today approved legislation allowing Oregon, to regulate Dungeness crab fishing off the Oregon coast. Rep. Peter DeFazio (D-Springfield) is one of the House sponsors of the legislation.

“This bill is about common sense and good government,” DeFazio said. “The State of Oregon has successfully managed the Dungeness crab fishery for five decades. This legislation keeps the state in the driver’s seat.”

The Dungeness Crab Conservation and Management Act exempts Oregon, Washington and California from provisions in the Magnuson Act which requires the Pacific Fisheries Management Council to develop a management plan to replace Oregon’s plan for the crab fishery by the end of 1999. West Coast crabbers and state agencies argued that they already had a plan in place and could best regulate

the fishery. Oregon currently has 460 commercial Dungeness crab permit holders.

“This is great news for Oregon’s crab industry,” Nick Furman, Executive Director of the Oregon Dungeness Crab Commission. “If approved by the Senate, this legislation will allow the three coastal states to continue successful management strategies that have made the Dungeness crab fishery one of the soundest fisheries in the nation with an enviable track record dating back to the late 1800’s. We’re very encouraged to see this legislation move forward and hope the Senate will act on the bill soon.”

The bill is endorsed by the Pacific Fisheries Management Council, fishermen, processors and tribal interests. It must now be approved by the U.S. Senate before becoming law.

There is no problem so large or so small that it can’t be blamed on the government.



house was not hooked into the sewer system and pay her 9% interest. The motion passed with one abstention.

The council passed Resolution 98-16 calling for an election of funding for a police department. Councilor Donaldson then made a motion to accept the ballot title for Measure 9 written by city attorney Randall Tosh. The first line reads "Measure authorizing public safety serial levy to fund police force." This will be on the November 3 ballot and is a two-year serial levy, which would raise property taxes by sixty-five cents per thousand dollars of assessed evaluation to pay for one police position.

Councilor Warring made a motion to accept the ballot title and wording for Measure 10 also written by city attorney Tosh. The first line reads "Measure directing the creation of a highway 101 Master Plan". The effect of this measure is that the residents of the City of Port Orford will be voting on whether they want to create a Master Plan for the beautification of Highway 101 in the future. They **won't** be voting on a plan already in existence. We will print Measures 9 & 10

in their entirety in the coming weeks.

Mayor Doran named Councilor Warring to serve on the council personnel committee, replacing Ralph Donaldson. Doran named Norm Leeling to serve as the council representative on the Parks Commission.

The council adjourned to an executive session regarding pending litigation and then resumed their regular meeting with council reports.

The council does not have a meeting scheduled for next Monday night!

Industrial Restrictions

Due to continued drying conditions, District Manager Gene Brock of the Coos Forest Protective Association has announced the following industrial restrictions will be in effect at 8:00am, Monday, August 10, 1998.

There will be a Level III Closure in all state, county, and BLM lands within Regulated Use Area SK-2 prohibiting:

Cable yarding – except that gravity operated logging systems employing non-motorized carriages may operate between

8:00pm and 1:00pm when all blocks and moving lines are suspended 10 feet above the ground except the line between the carriage and the chokers.

Power saws – except power saws may be used at loading sites and on tractor/skidder operations between the hours of 8:00pm and 1:00pm local time.

In addition, the following are permitted to operate between the hours of 8:00pm and 1:00pm local time:

Tractor, skidder, feller-buncher, forwarder, or shovel logging operations where tractors, skidders, or other equipment with a blade capable of constructing fireline are immediately available to quickly reach and effectively attack a fire start;

Mechanized loading or hauling of any product or material;

Blasting;

Welding or cutting of metal;

Any other spark emitting operation not specifically mentioned.

Fire/Off Road Vehicle Use

The Siskiyou National Forest is implementing a Fire/Off Road Vehicle Use order, effective Friday, August 7. The order will restrict campfires, smoking, the operation of combustion engines, and the use of motorized off-road vehicles except under specific conditions and locations.

"The Forest needs to take these precautions due to the heightened fire danger," commented Charlie Phenix, Siskiyou NF Assistant Fire Staff Officer. "This order is also consistent with the Oregon Department of Forestry's public use restrictions, and will remain in effect until fire conditions subside.
