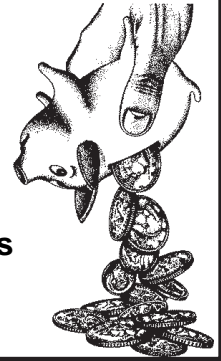

Council Approves More Money By Evan Kramer



The Port Orford City Council met on Monday night and began by reviewing department reports. Council Jim Auburn asked public works superintendent

Dave Pace about the discrepancy between the amount of water treated in September (5.057 million gallons) and the amount of wastewater treated ((2.595 million gallons). Pace said his department had found no major water leaks. He suggested that summer water usage could have caused the discrepancy but had no further answer. Councilor Emily Francona asked Pace if other communities have similar discrepancies. Pace told her he had contacted other cities but they had not responded.

Francona asked city administrator Erna Barnett about the Eleventh Street situation and whether the council would hear about it tonight. Barnett said no but replied, "the goal is a tidy yard" which she named the tidy yard plan.

Councilor Auburn repeated that the planning department reports were coming in too late, that they were a month behind.

Liaison reports began with Jerry Steinhorst, Port liaison who talked about the OSHA penalties levied against the Port. Chamber of Commerce liaison Emily Francona said next year's Wind Fest would be held on June 5 and 6. She talked about the Chamber's upcoming efforts in getting help from the city in finding out about Verizon's business plans for Port Orford. Parks liaison Jim Auburn said the Parks Commission was looking at a proposal for a larger size picnic area in Buffington Park.

Mayor Gary Doran spoke about a meeting he attended in Gold Beach on wideband and high speed Internet regarding the NOA Net, a group seeking to bring high-speed Internet capabilities to the south coast. Doran said that a committee chaired by County Commissioner Marilyn Schafer would be conducting a survey regarding wideband and high-speed Internet needs. Councilor Auburn said that Verizon has the infrastructure to provide broadband in Port Orford.

October is National Domestic Violence Awareness Month. Mayor Doran said that statistics show 30 incidents of domestic violence happen to an abused woman before the first call to the police is made.

Jack Pruitt spoke under Citizen's Concerns asking Mayor Doran if the five-minute rule for citizen's to speak was a "law." Pruitt said he had a severe problem with the city limiting citizen's time to speak. He questioned the legality of the five-minute rule. Councilor Francona said that Bandon limits public concerns to 3 minutes. Pruitt asked the council if they were going to push the 5-minute rule and all nodded yes.

Caroline Clancy asked if there would be any more land use meetings. The council held one in August. Clancy was told the council will hold a land use work session on Wednesday, October 22, at 6:00pm. (Sorry for the late notice but we just found out). Clancy suggested the city look into a historical area and accompanying historic walk.

Sewer outfall project engineer Steve Donovan spoke next and held the floor for a considerable time. Donovan said he had spoken to the outfall contractor and received a Change of Conditions from them at 3:30pm that day.

Donovan presented the council with two options for proceeding on the ocean outfall portion of the project. Option #1 includes the following:

Standing down the barge (take the equipment off the barge and store it) \$26,000

Standby for long term \$5,000 a month

Remobilize the barge (put the equipment back on the barge and ready to bring it back to Port Orford \$33,000

Total \$59,000 plus 10 months of long term standby for \$50,000.

Costs to continue the project also include the concrete bag work at the diffuser site, which includes \$20,000 to mobilize the tugboat and \$12,000 a day for four days work at \$48,000 for \$68,000. Donovan spoke of putting a 24-hour go notice in the contract. The total cost for the change conditions work, standby and new standby totaled \$340,000. Donovan presented an Option #2 (which the council did not vote for) and also spoke

of another option, that being halting the project. Donovan recommended the council adopt Option #1. Councilor Auburn asked Donovan if the contractor would share the costs with us. Donovan responded about the contractor having limited visibility on the ocean floor (six inches) and the difficulty in getting a good bathymetric data. Auburn made a motion the council authorize Steve Donovan to go with Option #1 and get the concrete bag work done as soon as possible and to get the 24 hour go notice on the bag work and to negotiate the prices down. The council voted 5-0 in favor of the motion.

The council next discussed an eight-page professional services contract change order with SHN that they had received at the beginning of Donovan's talk. Erna Barnett recommended a yes vote on the change order. Councilor Auburn made a motion to approve the change order, which he said he had read

and called "reasonable." Councilors Eskelson and Auburn voted yes and councilors Campbell, Francona and Steinhorst abstained meaning the motion failed. The council will take up the issue at its Wednesday, October 22 special meeting.

The council considered a new contract with the Port Orford Rural Fire District, which would designate the Rural District as having managerial responsibility for fire protection in the city. Up till now the rural district has contracted with the city for fire protection. The contract states the city will pay the rural district \$23,580 per year for fire protection. The city will continue to maintain the city fire hall. Auburn made a motion to approve the contract between the city and rural fire-board and it passed 5-0. Rural Fire Board chairman John Johnston said the district would do its best. He noted the

cooperation and hard work put into the effort by city administrator Erna Barnett.

Auburn made a motion to approve the Transient Lodging Tax applications for funds as recommended by the TLT committee. They are as follows:

Kalmiopsis Audubon	\$782.33

The motion passed 5-0. The total amount awarded is \$12,100.

Dave Pace submitted a Garrison Lake report in the council packet. Pace said as of Monday the lake level was 12.5 feet. He spoke about the large amount of wave overtopping coming into the lake at the outlet. Erna Barnett said if the dune doesn't build up we're looking at an estuary this year. Mayor Doran asked Pace to include a monthly salinity report on the lake water.

The council unanimously approved a motion by Francona to make the city administrator position a full time one immediately. Currently the city administrator position is .75 full time equivalent, which it has been since July 1 of this year. The cost to the city for this change is \$800 per month, which includes benefits.

Auburn make a motion to approve the consent calendar, which includes a Credit Union day proclamation, adoption of October as National Domestic Violence Awareness Month, the mayoral appointment of Joyce Spice Kinney to the TLT committee and minutes for four meetings. The motion passed 5-0. The council meets again on Wednesday, October 22 for a land use work session and special session related to the outfall issues.

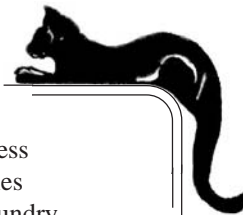

Hike Thru Oregon's Redwoods

Ed Gross, retired US Forest Service soil scientist for the Siskiyou National Forest, will discuss the natural history of the Oregon Redwoods Trail when Curry General Hospital's Sole Pursuits sponsors its next free hike, Saturday, Nov. 1.

The hike will begin at 11 a.m. at the trailhead parking lot, located up the Winchuck River on Peavine Ridge bordering California, about 10 miles southeast of Brookings.

Directions and trail maps are available from the Chetco Ranger District office in Brookings. Those parking in the lot must display forestry passes or Gold Age Passports in their vehicles.

Hikers wishing to carpool from Brookings can meet at 10:30 a.m., at The Brookings Clinic parking lot, 412 Alder St., across from the Chetco Public Library in Brookings. Those traveling from the north can rendezvous at 9:50 a.m., at the Curry General Hospital Annex parking lot, 94220 Fourth St., in Gold Beach.

An avid hiker, biker, and bird watcher, Gross has hiked in the redwood-Douglas Fir-tanoak forests of the Winchuck watershed both at work and for pleasure. The trail, about five years old, has two connected parts: a barrier-free, wheelchair accessible 1/2-mile section on the ridge top and a 0.7-mile section that loops to the west into the Mosier Creek drainage.

For a variety reasons, Gross says, these stands of redwood were not harvested and now are the centerpiece of the trail. Large redwoods are found along the entire length of both trail sections. Flora and fauna include redwood, tanoak, Oregon myrtle, sword fern, cougar, raccoon, black bear, great horned owl, red-bellied newt and Pacific giant salamander.

Fire scars on many trees indicate that stand replacement and less intense fires occurred in the late 19th century, Gross adds. Parts of the trail area include 110-year-old, post-fire stands of redwoods adjacent to 1,000- year-old stands that have survived many fires.

"The hike would quite suitable for those using scooters and those regular over-the-hills folks," Gross says.

Organizers suggest, however, that out-of-shape walkers bring a buddy to help them back to their cars, if needed.

Sole Pursuits is an incentive-walking program organized by Curry General Hospital. Volunteer guides lead monthly hikes along the shore, through river woodlands and in the Siskiyou.

Next month, Sole Pursuits invites the public to join music-producer Tony Kalhagen for a tour of his studio and visits to other artist workshops during the first Nesika Beach Art Walk, Dec. 13. Kerr, a United Methodist clergyman, is best known in Curry County as president of the Port Orford Chamber of Commerce and America's Wild Rivers Coast but most of his working career has been in religious communications and publishing. 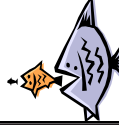

debris burning. Burn permits, which are free of charge, can be obtained by contacting the nearest CFPA office. A Fire Warden will visit the site and issue a permit for a safe burn. Letter to the Editor,

People of Curry County: If you believe we need an adequate police force to be safe; if you believe courts should be open five days a week for public access and faster scheduling of trials; if you believe our universities and community colleges are vital for the future of our state; if you believe K-through-12 students should be in school a full nine months and not lose 28 days; if you believe children, adults and families, seniors and people with disabilities need the help our state has provided in the past; read on. If you do not believe these things are necessary for quality of life in Oregon, you can stop reading.

In the closing hours of the 2003 Oregon Legislature, after much wrangling, a bipartisan effort to balance the budget was passed: House Bill 2152. It is not a perfect bill, but apparently, the best we could get at that time. Those who earn more will pay more under this bill and it eliminates the need to mortgage our future with heavy borrowing. This bill allows

everyone to pay his/her fair share of the state budget. If the economy improves sufficiently during the next two or three years, the temporary surcharge on income tax can be lifted sooner than planned.

A group calling themselves “Citizens for a Sound Economy,” or something similar, is out to get HB 2152 repealed. Does the title sound good? People such as Bill Sizemore—who does not have Oregon’s best interests at heart, but his own—and others are trying to get enough signatures on a petition to bring the measure to the voters and then try to convince them (us) to repeal the Legislature’s efforts. If all these things happen, see the first paragraph. Law enforcement, courts, schools, social services would suffer drastic cuts.

The so-called citizens’ group is backed by out-of-state money, such as Bill Gates, tobacco interests (there is a cigarette tax component in the measure) and others. Do yourself and Oregon a favor and decline to sign any petitions.
