## **Contract Awarded**

The Port Orford City Council met on Monday night and Mayor Gary Doran began the meeting with citizen's concerns and Tobe Porter was the first person to speak. She is the director of the Port Orford Public Library.

Porter thanked the city council and mayor for proclaiming April 8 as Port Orford Public Library Day. The library has framed the proclamation and she showed it to the council. Porter then gave a brief update on the new library. She said it was a \$1.4 million project and that so far they have raised \$400,000. She said the library has funding plans in place to raise the needed \$1 million including grants, corporate giving, and a community block grant. Porter said donations from local people totaled \$50,000 so far. She concluded by saying they anticipate going out to bid for the new library in late Spring 2005.

Jack Pruitt spoke to the council and said the people have a right to vote on the General Obligation (GO) bonds. He said it was a constitutional right under the Oregon constitution. Pruitt is part of a group of people attempting to get the GO

bond issue back on the ballot. Port Orford voters dealt with the issue last year in an election decided by one vote. They voted 208-207 against the GO Bonds. Pruitt had been sent a letter by city administrator Ken Knight telling him that on advice of city attorney John B. Trew the placement of GO bonds on the ballot is the purview or privilege of the city council.

Port Orford Chamber of Commerce board member Jay Stoler told the council he would be requesting space for the Chamber at the Battle Rock Park Visitor Center and to participate with the City in the Q program. This is a program, which places emphasis on retail employees giving better customer service. Stoler is a certified Q instructor. He suggested some transient lodging tax money could be used for to train people and that the City could get "Q" rated which would be good for thousands of dollars in advertising. Councilor Jim Auburn encouraged Stoler to work out the details of the Chamber moving into the Visitor Center. Stoler said the Chamber would have no paid employees at the Visitor Center but would staff it with volunteers.

The council got into a discussion on GO bonds. Councilor Carl Eskelson said he would support the GO bonds and said he supported them the first time they were

on the ballot. Jim Auburn said he didn't support them then or now. GO bonds are paid for through property tax while revenue bonds which is what the people voted for the second time is paid for through usage fees.

City Attorney John B. Trew said the first time the GO bonds were on the ballot it came from a council resolution. He said the proper way to do it was through council resolution. Jack Pruitt told the council the GO bonds issue should be referred to the circuit court to determine if it is a legislative or administrative issue. City Administrator Ken Knight said the city bond counsel had provided a GO bond resolution that can be passed tonight by the city council. Councilor Emily Francona asked on what grounds the city was going through this again. Trew told her they were not required to go back but they may submit a GO bond election to the voters again. Knight said the city had until September 2 to put the issue on the ballot to qualify for the November 2 fall election.

Councilor Eskelson made a motion to put the GO bonds on the agenda for the next council meeting (July 19) and it passed 3-2 with Eskelson, Beck and Francona voting yes and Steinhorst and Auburn voting no.

Caroline Clancy reminded the council sewer rates had gone up \$194.20 per year. She said with Revenue Bonds the costs go up each year while with GO bonds the costs go down each year. She asked them why they won't let the people vote on the GO bonds reminding them they failed by one vote. Clancy said that Clem Singer of the USDA (United States Department of Agriculture) said there was no problem with GO bonds. She urged the council to put it up to a vote. Clancy said she had called nine other cities from Crescent City to Reedsport and that Port Orford had the highest overall sewer-water rates of the cities.

Jim Auburn said the Parks Commission was working on an ODOT grant for a walkway between Battle Rock Park and the dock at the Port of Port Orford.

The council then moved into planning commission issues and heard from planning director Chuck Nordstrom. The council dealt with the Curry County Urban Growth Management Agreement and proposed Ordinance 2004-05 changes to the Planning Ordinance for prefabricated commercial structures. The council discussed a design review or architectural review committee for the commercial zone in Port Orford. Ordinance 2004-05 as currently written but not passed would adopt a new "conditional use" for the commercial zone in regards to manufactured structures. Councilor Auburn said some people didn't think the planning commission draft was strong enough. Attorney Trew said a design review process would be highly controversial and would not be a quick process.

Ken Knight recommended an ad hoc citizen committee study the issue and conduct public hearings on a design re-


view issue and bring their recommendations back to the council.

Councilor Ed Beck made a motion to move forward with this and it passed 5-0. Knight said they voted to start the public hearing process. This means that all affected parties will be notified in advance of a public meeting to discuss the ordinance.

Councilor Eskelson made a motion to adopt Resolution 2004-21. This resolution places on the November 2, 2004 ballot the issue of approving a local tax levy to finance the Port Orford Police Department for four years. The current police levy ends on June 30, 2005. The tax rate the voters will decide on is \$1.410 per \$1,000 of assessed valuation. If passed it will go into effect on July 1, 2005. It is estimated the tax will raise \$108,806.58 in fiscal year 2005-06 and peak in fiscal year 2008-09 at \$118,895.89.

Project engineer Steve Donovan next gave the council the SHN monthly report. He was at the meeting to update the council on the sewer treatment plant upgrade. Donovan presented the council with Changer Order No. 4 to the sewer outfall project. Changes were made to save \$59,934, which will be used for Phase II of the project, which is the wastewater treatment plan upgrade. SHN recommended approving Change Order NO. 4 and it went into effect without council needing to vote. The council had previously voted to let Mayor Doran and Ken Knight negotiate this decision.

The council considered the recommendation to award the Phase II contract to Laskey-Clifton Corporation of Reed-sport. Four companies bid on the wastewater treatment plan project and the apparent low bidder was Laskey-Clifton with a bid of \$1,412,913.75. Available funding for the project is \$1.33 million. To make up the difference SHN "value engineered" the project with the goal of reducing the cost by \$100,000. For example instead of a block building they will put in a metal shed building.

The council expressed some reservation with Laskey-Clifton, which was the general contractor for the new Port of Port Orford dock. Council concerns were assuaged by promises from Ken Knight of his intense interest and close contact he will keep with both SHN, Steve Donovan and on site inspector Steve Roemen during the construction phase. Knight said the completion date for the project is December 6, 2004 and that November 15 is the interim completion date. The city will then be in compliance with DEQ and the sewer hookup moratorium will be lifted.

Jim Auburn made a motion to award the Phase II bid to Laskey-Clifton for \$1.329 million contingent upon DEQ approving the changes and getting USDA to agree and that contingency funds are available from the USDA or some other sources. The motion passed 5-0.

That's all folks. Though there was more to the meeting, I was tired and went home to bed. It was a long enough day!

### June Port Meeting By Jane Cramer

All commissioners as well as Port Manager Gary Anderson were present at the June 15 regular meeting of the Port Commission.

Anderson began by advising commissioners of the status of the Port's Needs and Issues priorities and introducing David Cheramy, who will be updating the Port Strategic Business Plan.

First item discussed under New Business concerned dredging issues. Anderson began by speaking about the efforts of Michael Burton of OECDD to bring dredging funding problems to the attention of Senator Gordon Smith and Congressman Peter DeFazio with a request for their help. It is essential that dredging continue in order to maintain enough water beneath the hoist if local fishermen are to survive. Further discussion raised several questions. Evan Kramer asked

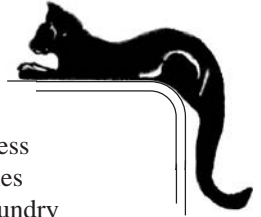

why Port Orford had been budgeted \$250,000 yet told they would only receive \$150,000 worth of dredging. Anderson replied that he had been advised that part of the money had been used for other things such as study of the jetty condition. Ed Dowdy asked why other activities were charged against dredging if the budgeting was designated for *dredging*. George Welch and Anderson had attended a meeting with people from Governor Kulongski's office and had been told that there just isn't any money for projects like dredging because all the money is going to Iraq and many entities are fighting over the crumbs. Welch stated, "We need the money at home instead of overseas."

Anderson advised that he and Dowdy were working on the application to remove sand and that he would be meeting with Russ Crabtree of the Port of Brookings to discuss pros and cons of the

possibility of the Port doing its own dredging. Crabtree promotes membership in National Harbor Association as a way of joining with other small ports to gain more political influence.

Also under New Business Anderson reported that ODOT is applying for a grant for sidewalks along the road to the Port. Anderson has also been contacted by a member of the Port Orford Parks Commission, who advised that the Parks Commission will also be applying for the grant in an effort to create a pathway from Battle Rock beach to the Port beach.

New Business ended with a discussion about refrigeration equipment in the cannery building. The commission needs to know who owns the equipment as it has not been removed from the premises and prospective additional tenants have inquired about leasing space in the building.

Under Old Business Anderson gave a Brownfield's Assessment update, stating he had signed an access agreement so the assessment could proceed. In response to a question, Dowdy added that this contamination was way down on the EPA list, but that the object was not to satisfy the EPA, but rather to clear the way for profitable future development of the site by the Port.

In other Old Business Anderson advised that the audit for the 2001-2002 fiscal year has been completed. Jane Cramer asked from the audience about plans for the 2002-2003 audit. Anderson replied that it was a matter of cash flow and being able to pay for the audit.

Discussion of the Manager's Report concerned communication from the Aeronautic Board regarding management of Cape Blanco Airport and the possibility

of Port involvement. Consensus appeared to be against taking over management at this time.

Other discussion involved proposed repairs to the hoist. Welch advised getting a firm estimate of costs involved since any repairs to the hoist so far have been far in excess of the nominal amounts predicted.

After a review of the Financial Report, the commission adjourned into Executive Session for a discussion of pending litigation.

### Prescription Drug Dilemma By Lou Mincer

The Area Agency on Aging (AAA) held their bi-monthly meeting at the Barn in Bandon on June 7. In attendance were Senior Center representatives including Port Orford Senior Center president Owen Miller and myself from Curry and Coos County. Triple A is an organization dedicated to providing support for social services – nutrition programs, advice on current matters affecting senior lives along with a host of other activities for seniors, disabled and destitute Oregonians.

Triple A is under the auspices of the South Coast Business Employment Corporation, which regulates and coordinates AAA activities. It also acts in the capacity of a liaison with both the Federal and State government senior disbursement agencies towards expediting grants and Older American Act (OAA) funding amongst other benefits for senior social programs passed by Congress and State legislature as a means of maintaining the essential financial incentive allowing the Senior Centers to administer to those in need.

These services include nutrition programs, health services, a variety of social involvement, Meals on Wheels, etc. Informative discussions are held concerning the future of Medicare prescription drugs and Social Security to enlighten the members of ways of coping with new regulations that are becoming increasingly complex.

At the Barn a lively discussion ensued on the confusing mishmash of prescription drug discount cards, about 70 or 80 varieties, being offered each having different requirements and pricing structures. Virtually all the cards when purchased have a fixed price tag for each drug they offer. The catch is the original set price can increase daily costing the buyer whatever the drug company wishes to charge or is it extort. Seniors thus are at their mercy for an entire year; the duration of the sign-up. Under the circumstances 'discount' cards might cost you more than anticipated. Each drug card initially costs \$30.00 to purchase.

Unless you absolutely know what you are signing up for think twice before making the prescription drug card your option.

At the Barn we were privileged to have a guest speaker versed in Medicare and its vast changes wrought under HR1's prescription drug bill, which in large part increases the cost of Medicare B furthermore complicating the entire concept of Medicare as we knew it in the past. She indirectly admitted the drug bill being a farce.

All in all it was a very informative and instructive session. The consensus was that seniors were being shortshrifed by Congress and the administration.

In a recent conversation about politics, the man I was talking to referred to presidential candidate John Kerry as a "draft dodger." My only explanation for this falsehood is the deluge of misinformation spread through public broadcasting. Perhaps he had Kerry confused with Bush. Bush was absent without leave for thirty days while on active duty, one day short of being a deserter. He was not court-martialed, but should have been.

John Kerry voluntarily enlisted for active duty, heroically and repeatedly risking his life under fire to save other soldier's lives. John Kerry is a true soldier's hero. ### Dredging Budget Increased

Representative Peter DeFazio announced on June 16 that he was able to bring the federal budget for dredging south coast shallow draft harbors from zero to nearly \$2.2 million, and increase dredging for the Port of Coos Bay up to \$6.5 million. Funding for dredging operations at all of Oregon's south coast shallow draft ports was zeroed-out by President Bush. The funding for dredging was included at the request of DeFazio in the Energy and Water Appropriations Act for Fiscal Year 2005, and was approved by the House Appropriations Committee.

Included in the bill approved on June 16 was \$6.533 million secured by DeFazio, for dredging at the Port of Coos Bay, an increase of \$737,000 from the President's budget. In addition DeFazio, helped bring funding for dredging operations at the following ports from **zero** dollars in the President's budget to:

Port of Brookings-Harbor .....	\$518,000
Port of Bandon .....	\$263,000
Port of Port Orford .....	\$350,000
Port of Gold Beach .....	\$350,000
Port of Siuslaw .....	\$250,000
Port of Umpqua .....	\$450,000

"I cannot state too strongly the crucial role dredging plays in the economic livelihood of the region," said DeFazio.

### Fire Season Began June 23

Coos Forest Protective Association has announced that fire season began at 1:00 a.m. June 23. This activates restrictions on both public and industrial forest use on all private, county, state and Bureau of Land Management lands as well as rural fire districts within CFPA's protection boundaries and means the end of unregulated outside burning for rural residents. Written permits and on-site inspections will be required for all types of outside burning, including debris burning and the use of burn barrels. Permits are free and may be obtained as follows.

Residents living in rural areas can call their CFPA office during business hours, seven days a week, at 347-3400; A Fire Warden will come to inspect the burn site and write the permit.

County residents within an incorporated city should call their local fire departments for burning restriction and permit details.

Industrial fire regulations are also in effect. Contact your CFPA office if you are not familiar with them. As fire season progresses, additional closures and restrictions may be imposed as weather conditions become more severe. 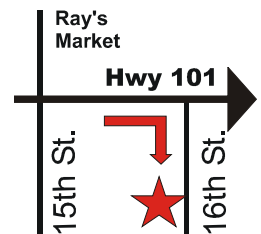
