Chamber Request Approved

The Port Orford City Council met on Monday night and began with a public hearing for Ordinance 2004-05 – Change in the Commercial Zone. This would make the placement of pre-fabricated buildings

in the commercial zone a “conditional use” subject to approval by the planning commission.

City planning director Chuck Nordstrom read a letter from ODOT that they had no objections to the ordinance. City attorney John B. Trew recommended the council adopt the definition of structures affected as pre-fabricated. The only testimony from the public came from Desiree Glinden. She expressed her love for this town and said it had a chance to become something lovely unlike other south coast towns. She spoke about the city adopting an architectural overlay zone. Councilor Jim Auborn made a motion to adopt the language in the ordinance with some changes taking out the section requiring that the pre-fabricated structure match the existing structure. It passed and the text of the ordinance will be changed before the final vote on it.

The council reviewed a request from Shari Jarboe that they waive the fee for the Community Building for the Pacific High Cheerleader’s flea market and bake sale. Jim Auborn said he wanted to revise the community building fee schedule so events, which are non-commercial, like this come under the \$20 fee. He said he would be in favor of letting them rent the building for \$20. The council will look at the fee schedule, which is supposed to be reviewed every year.

Jack Pruitt spoke under citizen’s concerns on the subject of system development charges for sewer and water hookups. He read from an upcoming Bandon election measure where the voters there will choose whether or not to raise the system development charges from \$4,000 to \$13,000. Pruitt noted that Port Orford will be growing and he suggested the council review the Bandon measure.

The council discussed at great length the problems at the Visitor Center with the bathrooms. City public works staff is constantly being pulled off jobs to go down to the bathrooms and unplug the toilets. City Administrator Ken Knight said he wanted to get a laborer position or trainee using state funds and that person could help with the workload.

The council reviewed the Ordinance Violation Report in the police report. The City has now hired an ordinance control officer. Her name is Deneen Kahman and she began work earlier this month. Councilor Carl Eskelson asked why when ordinances are being broken like mobile homes with no garages there was no enforcement.

Jim Auborn said the Parks Commission is very upset with the vandalism at Buffington Park to the basketball courts. He said they wanted to hear from the police chief about the investigation. Chief Bill Rush said that it was at a dead end right now.

The council discussed an architectural review board, which the planning commission had been directed to look into. The council talked about the need to form a committee, which would then come back to the planning commission with their ideas. An ad hoc citizen’s committee will be formed with help from the Port Orford Chamber of Commerce to look into an architectural review board and come up with a proposal.

Carl Eskelson, a member of the county recycling committee said they had recently discussed plans for a compost facility in Brookings.

Councilor Emily Francona talked about the recent America's Wild Rivers Coast presentation in town and said she was disappointed by the lack of attendance by business owners and visitor center volunteers.

Mayor Gary Doran said he had recently gone on an Enterprise Zone tour with county commissioner Ralph Brown. They were with a business interested in relocating into the Enterprise Zone. Doran also went on a tour of the Rotary Club centennial project remodeling of the American Legion building. He expressed appreciation for the work Rotary is doing.

Steve Donovan, SHN project engineer for the sewer plant upgrade project said the barge would be mobilized within the next two weeks and the sewer outfall concrete mats would be placed. He em-

phasized this part of the project must be complete by the end of September. Ken Knight complimented Steve Donovan on the tremendous work he has done getting the change orders done and the project done on budget. Steve Roemen, local project inspector, said Laskey-Clifton had started work last week on the sewer treatment plant upgrades.

The council then went into a discussion about whether to adopt Resolution 2005-01 making adjustments to the fiscal year 2004-05 budget through a supplemental budget. The \$5,000 would be put in the parks budget for preliminary engineering of the Interpretive Trail System. This \$5,000 would pay for the map and a study of what needs to be engineered. Councilor Carl Eskelson expressed concern about where the money would come from in the future to maintain the Interpretive Trail. This trail would go from Battle Rock Park to the Dock and also down Oregon Street to Seventh Street

and then north. The cost would be \$233,000, most of which would be paid for by a Transportation Enhancement Grant from ODOT. City matching funds of 10% would be required and money for that would have come from the Transient Lodging Tax Funds.

Jim Auborn made a motion to adopt Resolution 2005-01 and the vote was 4-2 against with Auborn and Francona voting yes and Beck, Campbell, Eskelson, and Jerry Steinhorst voting no. Because of this vote the council passed on considering Resolution 2005-02 to apply for the Transportation Enhancement Grant.

The council took up the issue of changing the City Charter. Recently, a council committee had met for three hours to discuss changes to the City Charter dated September 9, 1975. The purpose of changing the charter was to bring it more



in the line with the Oregon League of Cities model charter. One of the biggest changes in the new proposed charter would make the mayor a voting member of the council. Ken Knight referred to the proposed charter as a council-manager form of government. The council unanimously voted to remove a portion of the proposed charter dealing with restrictions on the city manager as far as becoming and remaining a resident of the city.

Jim Auborn made a motion to adopt Resolution 2005-03, the title and summary for the City Charter measure and it passed 5-1 with Jim Campbell voting no. Campbell had spoken against the mayor being a voting member of the council. Passage of the resolution means the voters in the City of Port Orford will vote on the proposed new City Charter to replace the existing one in the November 2 election. It is expected that there will be a town hall meeting to discuss the new charter and reasons it is being placed on the ballot.

The council was presented with a recommendation from the Parks Commission to sign an agreement with the Chamber of Commerce to rent space in the Visitor Center for a six month trial period. Jim Auborn made a motion to direct the city administrator and city attorney to draft a contract for the Chamber of Commerce to use the visitor center per the agreement and it passed 6-0.

Part of the consent calendar approved by the council included a proclamation by the City making the month of October Disability Employment Awareness Month.

New Youth Pastor



next general election at which time an election shall be held for the unexpired term of predecessor. Proposed charter states that appointee's term of office runs from appointment until expiration of the term of office of the last person elected to that office. Establishes the office of city manager as the administrative head of the city government. City manager may appoint and remove department heads with council approval. Removes fiscal officer responsibilities from city recorder duties. If approved, new charter will be effective January 1, 2005.

The previous local option tax revenue measure expires at the end of the 2004-2005 fiscal year. If the local option tax measure is not enacted, then the City will eliminate the Police Department, since there are insufficient property tax revenues to pay for general city operations and fund the Police Department. The local option tax imposed by this measure will be for four years, beginning with the 2005-2006 fiscal year. It is estimated that the local option taxes to be raised each year will be \$108,806.58 in FY 2005-2006; \$112,070.78 in FY 2006-2007; \$115,432.90 FY 2007-2008, and \$118,895.89 in FY 2008-2009.

Phishing

If you use email, you'd better understand phishing or you're going to be sunk sooner or later. Phishing is method of duping people into providing private information such as credit card numbers, Social Security numbers, etc. which are then used to obtain goods or services fraudulently or to engage in identity theft. It is the fastest growing form of criminal activity on the net with a growth rate of about 52% per month!

A phishing attempt begins by sending out a spoofed email that appears to be from a bank, eBay, PayPal, or some other legitimate organization. The email may offer an enticement, warn you of a problem or in some other way induce you to click on a link in the email. If you do, you will be taken to a web site that will look very much like a legitimate one and will ask you to enter your name and other information. That information will be harvested and used by the bad guys to your great dismay.

About 5% of those who receive a phishing email fall for the scams so there is plenty of money to be made by the perpe-

trators who may send out millions of emails in a single pass. The email address used to send the original email will, of course, be bogus. The web site you will be directed to will probably be hosted on the computer of some innocent user who hasn't applied all the Microsoft security patches from Windows Update and who doesn't use a firewall. Such machines are usually taken over by the bad guys for their own use in about 3 hours from the time they first go online. Web sites on these machines are typically used for only a couple of days then thrown away and a new one is established somewhere else. It makes it difficult to catch these folks!

How can you tell a legitimate email from a phishing attempt? It's not easy and it's getting harder all the time. In the early days the emails were often poorly formatted, had spelling errors or broken links and were usually pretty easy to spot. Life is no longer that simple! Emails these days are slick and look perfectly authentic. The web site will also look authentic (as it should, most of it will probably have been copied from a legitimate one.) About the only clue you have is the link that is embedded in the email.

A link is composed of at least two parts. There is the actual address to which you will be redirected and which you cannot normally see, and there is a visible part, which is the text you click on to invoke the link. The visible text can say anything and has nothing to do with where the invisible address will take you!

The simplest solution is never again to click on a link in an email. Instead, bring up your web browser yourself and enter an address that you know to be good for the web site in question and go there manually. There is a lot to be said for this simple security measure! If you want to know more, however, read on...

To tell whether an email is legitimate, you need to look at the invisible part of the link and determine if it is going to take you where it says it will or whether it will take you to some fraudulent site. There are two parts to this investigation: 1) viewing the invisible part of the link and 2) understanding it once you see it.

A typical link looks something like this: text to be displayed. To reassure viewers, the displayed text is often the same as

the address which follows the “HREF=” so that they can see where the link will take them. In a phishing email, the address shown will usually differ from the one that will actually be used.

To view the actual address, right click on the suspected message and choose “view source” from the menu. This will open up a new window containing the source code for the message. It may be pretty intimidating to look at but don’t panic yet. Once we can see the source for the message, we need to find the link. Hit CTRL-F to bring up the find command and have it search for “HREF=”. You may need to click “find next” one or more times until you find the link you are looking for. Note that phishers often include several peripheral links that will take you to valid places on the real web site so don’t be fooled if you find a link that appears to be good. Be sure to check the links you plan to use!

Once you’ve found the right link, look at the first part of the address (up to the first “/”). It can take any of several forms such as these: <http://www.mydfz.com>, <http://12.45.48.9>, or <http://204288009>. Any legitimate web site should use the first (text) form. If you see a numeric form, it’s probably done that way solely to confuse you and to hide the real destination. You should probably NOT click on such links! The address given may look

almost correct but almost doesn’t count. Watch out for tricks that can be used to fool your eye such as using an “l” instead of a “1” or a “O” instead of a “0” or for names that are misspelled or have extra hyphens in them or extra junk at the beginning or end. If you’re in doubt, it’s probably bogus. If you’re not confident you can tell the difference, you probably can’t. Don’t use it.

If you identify a phishing attempt, you can forward the email to reportphishing@antiphishing.org and to any abuse or spoofing email account set up by the vendor in question. Learn more at www.antiphishing.org/ and www.ftc.gov/ or www.us-cert.gov/ (search their sites for “phishing”.)


the many programs developed for children and families over the years.

Ray Bradbury wrote Fahrenheit 451 and it was first published in 1953 and became a best seller so had 3 other printings the last being in 1983.

Did Michael Moore misuse the title of a previous best seller so he could capitalize on the familiarity of the name Fahrenheit? Moore is quoted in the UK Mirror while in Great Britain that "Americans are the dumbest people on the planet" and "our stupidity is embarrassing". His films are not documentaries as they are claimed to be. Worthy scrutiny is revealing that he has doctored film footage, manipulated facts and spliced speeches to tamper with the truth. A book by David Hardy and Jason Clarke exposes how Moore pulls off a "Man of the people" image while living a fabulously wealthy lifestyle in Manhattan. And it doesn't seem to be true that Moore was a son of factory workers but rather upper middle class.

The truth will come out. But it is tragic the damage he has done to those he falsely accused and maligned and to those who were charged high prices to hear some of his speeches or see his films.
