Jail Hearing Set By Evan Kramer



The Port Orford City Council met on Monday night and began with citizen's considerations. Wendy Thomas told the council the city was entering a period of growth and she urged the council to adopt land

use and animal control ordinances and plan for the growth. Jody Bulaich told the council the animals that live here are assets. Bulaich works with the 4-H program, which recently held a successful horse day event in Buffington Park. She asked people with animal/horse concerns to share them with the 4-H people. Mayor Jim Auburn urged Bulaich to work with the ordinance committee.

Mayor Auburn said the jail issue would have a formal land use hearing before the next council meeting. Frank Smith told the council another option for the former city jail, now sitting on private property, is to move it forward twenty feet into Seventh Street. He said it wouldn't interfere with traffic. Smith said he had talked to a local contractor who told him it could be moved. Mayor Auburn said the owners of the property the jail sits on

have rejected the planning commission options, which were listed in last week's paper. Volunteer Fire Department Chief Gayle Wilcox said the fire department was willing to be the lead entity to do whatever it takes to preserve the jail.

City Administrator Ken Knight spoke to the council about his recent trip to the Northwest Manager's Conference. He called it a very good conference focusing on the many challenges faced by cities including tax revolts. There were also seminars on ethics.

City attorney John Trew recommended having the public hearing on the jail when Planning Director Chuck Nordstrom is available. The date when Trew and Nordstrom plus the council are available is Wednesday, April 13, 7:00pm. This date and time is now set as the land use hearing on the jail and was described as "quasi-judicial". The council will decide on the fate of the historic city jail at the hearing. The property owners have requested a permit to demolish the jail. The City has 120 days from the date the permit was requested (February 23) to respond. Later on in the council meeting Mayor Auburn asked Gayle Wilcox to contact the owners of the property the jail sits on and discuss a solution to saving the structure.

Chamber of Commerce president Jay Stoler gave the chamber liaison report. He said the Chamber was moving forward on the Wind Fest set for Saturday, May 28. He said it might be a wine and wind fest.

Mayor Auburn told councilor and streets liaison Carl Eskelson he needed to send a letter to ODOT about the City being given Coast Guard Hill Road.

Councilor Milton Finch recommended that court clerk Ellen Mundell be given more hours so she could write grants for the city.

Councilor and watershed liaison, Steve Abbott, attended the last watershed meeting. He said a car crusher was coming to Port Orford in June and that people could bring cars, refrigerators and washing machines to the city shops area to be crushed. Abbott had taken a tour of the Port Orford conservation easement in the North Fork Hubbard Creek watershed and noted a lot of gorse has been cut but help is needed watering all the recently planted trees.

Steve Donovan, Senior Project Engineer with SHN on the wastewater treatment plan upgrade told the council we didn't have final completion on the project. He

said the contractor is continuing to incur liquidated damages and that currently the city is holding back \$40,000 in payments to Laskey-Clifton. The general obligation bonds for the project cannot be sold until the project reaches final completion. The city has incurred damages of \$16,000-\$18,000 so far.

Fire Chief Gayle Wilcox presented the council with a quarterly report on the fire department. There were 32 calls between July 1, 2002 to June 30, 2003 and 68 calls for service between July 1, 2003 and June 30, 2004. So far in this reporting year there have been 31 calls since July 1, 2004. Calls range from structure fires, controlled burns, false alarms, medical assistance, hazardous materials, and motor vehicle crashes.

The council passed Resolution 2005-18, which would transfer \$250 from the

Buffington Park's budget to the reward fund regarding the trees being chopped down in Buffington Park. This resolution also creates a contribution fund.

The council passed Resolution 2005-19 approving the annual adjustment for inflation to the water and wastewater systems development charges. The rate of inflation calculated out to 7.19759% between December 31, 2003 and December 31, 2004.

The council passed Resolution 2005-01 concerning a supplemental budget for the Parks Department of \$300. This will pay for two parks commission members to attend a grant-writing workshop, which will be held locally.

The council passed Resolution 2005-20 "declaring the Chief of Police a city officer to be supervised by the mayor and city council. This resolution says the Chief of Police shall be employed and supervised by the mayor and council.

The Chief of Police shall also "continue to receive administrative and budgetary support from the City Administrator." The resolution continues that the City Administrator's job description shall reflect these changes.

Milton Finch made a motion to accept the modified city administrator's job description as presented by the city attorney and it passed 5-0.

The council accepted the consent calendar on a motion by Milton Finch. It included approval of the right of way form as edited, the mayor's appointments of Jody Bulaich to the Parks Commission and Jeff MacFarlane to the Transient Lodging Tax Committee, the Mayor's reappointment of Jim Billings to the Parks Commission, and approval of the minutes for three previous meetings. It also included a letter written by Mayor Auburn to the State Senate Transporta-

tion Committee regarding Senate Bill 894, which he does not support but instead, encouraged them to support Senate Bill 566. Senate Bill 894 would designate every national highway in Oregon a freight route while Senate Bill 566 would according to Auburn "maintain the integrity of our scenic highway system."

There are now three ways to speak at council meetings. You can speak at the beginning of the meeting under citizen's concerns. You can either sign a sheet at the beginning of the meeting and speak or you can get the subject you want to speak about on the agenda. You have to have your request to speak to the city recorder by the Tuesday before the meeting at 5:00pm. Thirdly citizens can now speak at the end of the meeting under citizen considerations.

Jack Pruitt thanked former Mayor Gary Doran for his comments at the last council meeting. Pruitt said the council had done a disservice to the law enforcement panels with their decision.

City Administrator Ken Knight spoke about water issues regarding the North Fork Hubbard Creek watershed and the need for more impoundment of water. He said by summer the City may have to offer residents a blend of water from Garrison Lake and North Fork Hubbard Creek. You read it here first – the next big issue for the city once the final completion is done on the sewer treatment plant and Mark Creighton serves his first day as police chief is going to be WALTER!

March Port Meeting By Jane Cramer

Commissioners Gifford Barnes, Ed Dowdy, Evan Kramer and George Welch, as well as Port Manager Gary Anderson were present at the March 15 regular meeting of the Port Commission. Commissioner Dave Knapp was absent.

Under Unlisted Items for Commissioners, Kramer reported that a phone call to the Curry County Board of Elections had revealed that as of March 15 no one had filed for any of the vacant Port Commission positions. Commissioners Barnes, Dowdy and Welch are not running for reelection. Kramer stated it was important to have at least one person running for each position and filing deadline is March 17. Some people expressed interest in running for the position and were encouraged to speak with Anderson to learn which positions were open.

Dowdy and Anderson reported on a meeting they had attended with Curry County Commissioner Ralph Brown which covered the possibility of individual quotas being set for groundfish and efforts to have community quotas be considered as well. Individual quotas would favor trawlers, while community quotas would work better for those fishing from the Port Of Port Orford. Community quotas will be included in a secondary discussion.

They also discussed the possibility of a marine research institute being sited on Port property, but Brown advised this was unlikely because of the lack of infrastructure (motels and restaurants) available in Port Orford. Bringing the facility to the Port would fit in well with the Strategic Plan.

Under Public Comment, Jane Cramer spoke about the Port being honored during the 2005 Jubilee. She suggested the commission look into sponsoring some

activities in and around the Port to attract visitors to the dock.

The new ice machine has arrived and should be up and running by April 1. Anderson is working on pricing and billing procedures.

Port employee Ed Schrieber gave a report on his estimates for refurbishment of the Cannery to prepare it for rental. Much of the work would be done by Port employees and would consist of cleaning up and painting. They would work on small areas at a time in order to be able to rent out space as it is finished.

Under New Business Anderson spoke about applying to ODFW for a grant to install an aluminum stairway from the dock to the beach near the port office. The old metal stairway from the former dock to the beach is rusty, disintegrating and unsafe to reinstall.

Commissioners also discussed Senate Bill 734 which could have adverse effects on local fisheries. Anderson will write a letter in opposition and Kramer will help him research the matter.

Anderson reported on his recent trip to Washington D.C., which included meetings with people who might be able to assist in getting more money for dredging, as well as with Peter Friedman, a lobbyist for small draft ports. Dowdy and Welch moved and seconded that the Port pay Anderson's expenses for the trip. The motion passed unanimously. Anderson will check to see if a supplemental budget is needed to implement this and if so, will have it ready by the next meeting.

After review and approval of a letter of support for the Port of Brookings, commissioners reviewed the Manager's Report and Financial Report and adjourned into Executive Session under ORS 192.660 (1) (e) Real Estate and ORS 192.660 (1) (h) Pending Litigation.

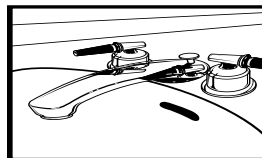
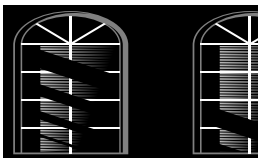
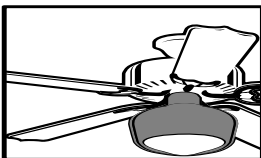

Special Districts Election

The filing deadline has passed for the May 17 special districts election. Most positions have one person running in them but that's not the case with the Port of Port Orford Commission where nine candidates filed for three positions. Campground Closed

Cape Blanco State Park's campground and other overnight facilities will be closed from Monday, March 21 through June 30, 2005 for electrical and water system improvements.

Cape Blanco State Park's day use area and trails will remain open. Regularly scheduled tours of the historical Hughes House and the Cape Blanco Lighthouse will begin again on Friday, April 1.

The campground, which is normally open year round, has 53 campsites with electrical and water hookups. All sites are available on a first-come first-served basis. Cape Blanco State Park is located at the western edge of Cape Blanco Road of US Highway 101 and covers over 1,800 acres. The park is laced with day use trails and horse trails, which will remain open for the public while the electrical and water system improvements are made.

Tioga Sign Relit

The Tioga Hotel is the tallest building in the Coos Bay North Bend area. It is now a residential hotel with a couple of restaurants in it as well as a bus station and a ballroom and dominates the landscape of downtown Coos Bay. The Tioga Hotel has a multi-story sign on the front of the building. For at least fifteen years it has not been lit but all that has changed. The ownership has invested money into the grand old sign and now the pink neon letters are lit. The sight, especially at dusk, is stunning and an example of one of the many ways historic renovation and rehabilitation of buildings is going on throughout the country. Buildings in downtowns like department stores are being renovated and turned into housing for downtown dwellers. Beautiful old movie theaters are being restored to their original grandeur and reopened as playhouses and concert venues. Old signs that sat on top of theaters, hotels and other buildings are being relit to reinvigorate the neighborhoods they occupy, just as what has happened in downtown Coos Bay.

The new stadium seating multiplex at Pony Village is well along the way construction wise with the front nearly complete as of last week. The theater complex will include eleven screens with all rooms having stadium seating. The new Ross Store has opened in Pony Village and is already drawing huge crowds of bargain conscious consumers. Something new, something old but things are changing in Coos Bay and North Bend.

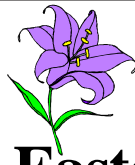

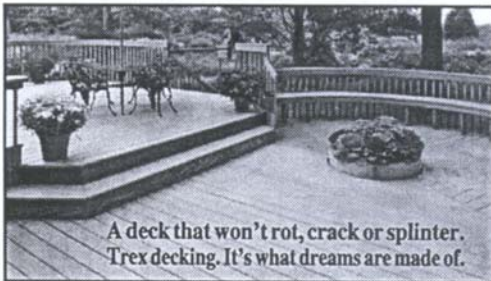

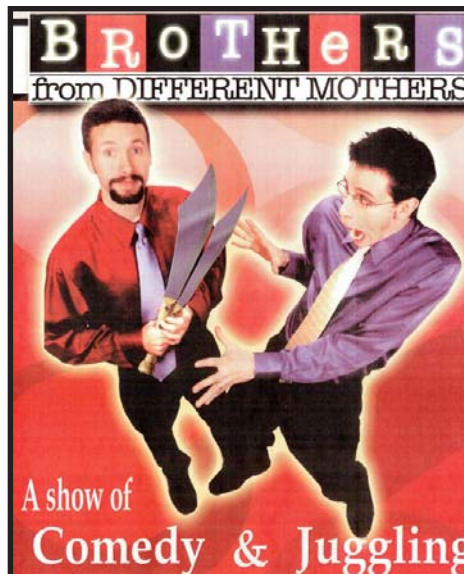

Letter to the Editor,

As most people in town now know someone has been poisoning animals in the Port Orford area for the last several months. I don't know how many cats have been killed, but I understand that at least ten dogs have.

Whoever is doing this should keep in mind that, under certain circumstances, animal abuse in Oregon can be a class C felony, if the perpetrator has been convicted of assault involving domestic violence or assault against a minor child at least twice in the past. It is also a felony if the animal abuse was committed in the presence of a minor child. A class C felony can bring five years in prison. Even if the above special conditions don't apply, animal abuse is still a class A misdemeanor, which can result in one year in jail for the perpetrator.

Whoever is doing it should also keep in mind that if the poison bait is picked up and eaten by a child, instead of an animal, the charge could be first degree manslaughter, a class A felony good for 20 years in prison.
