Port Budget Hearing By Evan Kramer



The Port of Port Orford budget committee met on Tuesday night, May 3, at the Port office. Committee members attending included David Pesonen, John Mobley, George Welch, Jane Cramer, John Jensen,

Evan Kramer, and Ed Dowdy as well as port manager and budget officer Gary Anderson.

The committee elected George Welch as chairman of the budget committee. Manager Anderson noted it was easier to budget this year as we have some money.

Budget officer Anderson's message to the committee reads as follows:

"Revenues – there was a 17% increase in dockage in January that won't be fully realized next year. Because of the increase, the three month salmon closure and reduced bottom fish quotas, boats may be taken home or moved to the boneyard. Sport fishing is also down this year to date possibly because of the price of fuel. Both revenues and expenses for fuel reflect only price increases not volume increases with a built in 20% margin. Because of this and almost doubling

the variable rent we may need to do a supplemental budget for this fiscal year. Miscellaneous sales were increased to include overnight camping fees and ice sales.

Expenditures – part of the utilities increase includes power demands of the ice machine and water usage of over-nighters. Repair and maintenance includes trash, which will increase with over-nighters. Ice machine and freezer expenses were also budgeted in. Dues will cover OCZMA and PNWA. Airfare and motel costs were based on this year's actual, anticipating one more trip to finalize a dredge system."

The four largest sources of revenue for the Port are fuel sales, dockage and hoist fees, rent from the tenants, and variable rent (1% of what the fish buyers pay the fishermen for their catch).

The largest expenditure for the Port is personal services at \$159,100 for the manager, administrative assistant and three hoist operators. The Port of Port Orford does not participate in the PERS (Public Employees Retirement System.). Fuel is the second largest expenditure with utilities coming in third at \$25,500 and repair and maintenance coming in at \$21,000. The good news regarding the fiscal year 2005/06 budget is there is enough money to make the yearly loan

payment to the Oregon Economic and Community Development Department of \$21,868. The Port has made the past two payments but failed to make two payments early on in the process. This year's budget included a line item for contingency of \$6,000. This line had been zeroed out the previous two fiscal years.

Jane Cramer made a motion that the budget committee approves the Port budget of \$370,430 as presented by the budget officer and recommends that the Port Commission pass the budget at their next meeting. The motion passed 6-0. David Pesonen made a motion that the Port of Port Orford budget committee recommends that the Port Commission approve a tax rate for fiscal year 2005/06 of \$.3591 per thousand dollars of assessed valuation for operating purposes. The motion passed unanimously.

There is other Port news and it has a happy ending. On Wednesday, May 4, the fishing vessel Eagle III, owned by Darrel Cobb, broke loose from its mooring at the Port. The chain under the water came undone and the boat drifted ashore at Dock Beach. The incident happened around noon and people at the Port were on it right away. The fishing vessel Golden Eye, owned by Aaron Longton, was hoisted into the water and a rope was tied

between the Eagle III and Golden Eye. Tony Cotter from Hallmark Fisheries was also in the water in his dingy helping with the boat rescue. Within minutes the Eagle III was pulled off the shore and was moving on its own. The boat was not damaged and once again it showed that when the chips are down at our Port everyone works together.

Health Advisory Issued

A public health advisory has been issued due to higher than normal levels of bacteria in ocean waters at Hubbard Creek beach in Curry County.

Water tests indicate higher than normal levels of fecal bacteria, which can result in gastroenteritis, skin rashes, upper respiratory infections and other illnesses. Direct contact with the water should be avoided until the advisory is lifted, espe-

cially for children and the elderly, who may be more vulnerable to waterborne bacteria.

While this advisory is in effect at Hubbard Creek beach, visitors should avoid wading in nearby creeks or in discolored water, and stay clear of water runoffs flowing into the ocean. Even if there is no advisory in effect it is recommended to avoid swimming in the ocean within 48 hours after a rainstorm.

Although they discourage water contact, state officials say they continue to encourage other recreational activities on this beach because they pose no health risk even during an advisory. Neighboring beaches are not affected by this advisory.

Robert Smith with Oregon State Parks said they are not able to answer why this situation has occurred. He referred to it as non-source point pollution, which could come from a variety of factors

from runoff from upland points to pet wastes.

Water quality is monitored at selected beaches along Oregon's coast by the Oregon Beach Monitoring Program. More detailed test results are available at www.healthoregon.org/beach

The duty of the Parks Commission is to recommend to the City Council what should be done with the following issues:

The Old Jail: Fire Chief Gayle Wilcox, spokesperson for an ad hoc group of citizens and volunteer fire fighters who want to care for and restore the Old Jail, told the Commission that the owner of the property was amenable to trading land in a quid pro quo deal that would put the Old Jail and a small area around it back on city property and give the new land owner more room at the other end of the plot. The only other alternative was demolition with the salvageable parts being donated to the city. The former option was the most popular. This would mean a new “minipark” that the Parks Commission would ultimately be responsible for. They will recommend moving ahead with the trade, which in essence, is for an historical piece of property that will be going on the state and perhaps national historic registers. The expense for this could be about \$800-\$1350 for a

survey and appraisal and would come out of Parks budget.

Park Lighting: The Commission will recommend fixing the light at the Buffington skate park. This will be done in accordance with Dark Skies and the light will be capped off and lowered to about 14 feet and focused on the skate bowl. Buffington Park will also remain open 7:00am to 10:00pm.

BMX Park: High School teacher Roger Rasmussen gave a very enthusiastic presentation of the proposed new BMX Park that will occupy a 60 by 100 foot area across from and 100 yard south of the skate park. The track will be designed and constructed by Rasmussen and some high school student volunteers, who will receive community service credit hours for their work. Everyone seemed to think this was a positive move and would benefit the kids. The Commission will recommend moving ahead on the project.

Tree City, USA: Parks Commissioner Joanne Ruoff suggested that Port Orford join the Tree City, USA program and plant trees in areas to enhance beautification. That program will be recommended.

Trees on Right-of Ways: It will be recommended to give a warning citation to a local home owner who had a contractor cut down some trees on what appeared to be her property but was actually city property. The contractor may also receive a warning citation. After some discussion it was also recommended to educate the public with a multi-media campaign and periodic reminders to call the city before they cut down trees or build on a questionable area.

Alcohol Use in Parks: A recommendation to prohibit the use of alcohol by anyone in a City Park, except by permit or special occasion, will be made to the Council. The feeling was that that current law, “monitor to see that drinking is not excessive” is vague, unclear and allows adults to consume from an open container in any area of the Park, even areas used by families and young children. Many were concerned that casual public drinking was not a good example to set for the many underage juveniles that frequent the park.

Briefly, in other subject areas; the horse association is being re-organized; a dedication contract has been agreed upon; the handball court will be removed and a mini-skate park for pre-teens would be devised; everyone seemed to be in favor of requesting guard rails for the embankment at Battle Rock Park; and the Parks budget was discussed.

Co-op Gets Tax Break

Coos-Curry Electric Cooperative (CCEC) took another major step forward in its crusade for financial stability after receiving word from the Internal Revenue Service that the Co-op would receive a tax abatement of more than \$2.1 million in penalties and interest assessed on the sale of its South Coast Satellite TV business.

Coos-Curry petitioned the IRS for relief back in June, 2004. After reviewing the case, the IRS determined that the Co-op showed sufficient and reasonable cause for late tax filings on the sale of South Coast Satellite, which resulted in the penalties and accruing interest.

"This is the long-shot victory of the season and a huge win for our members," said Terry Hanscam, Coos-Curry Electric's Board Chairman. "Getting tax relief from the South Coast Satellite sale has been an uphill battle from the very

beginning. It's gratifying to see all of the hard work and perseverance pay-off."

While working to stabilize the Co-op's finances, the staff and board examined the tax basis for various penalties that the Co-op had been assessed and engaged Seattle-based law firm LeSourd and Paten, P.S., to file an injunction to stop the interest from accruing. Similar letters were filed with the Oregon Department of Revenue and Franchise Tax Board for the State of California.

The Co-op emphasized that although the abatement is not a cash refund, it constitutes a considerable savings for Coos-Curry's member-owners because the Co-op would have had to pay penalties and accrued interest.

On the heels of last week's announcement of the first successful audit since the Co-op's reorganization, this latest victory provides further proof that CCEC is on the right path as it continues to

resolve the financial difficulties experienced in recent years. Hanscam said the management team will build on this momentum as it returns the Co-op to solid financial ground.

"We've got the right people in place to really point the Co-op in a positive direction," Hanscam said. "We're still making progress, but I think every member would agree that this is significant progress." Hanscam added, "This is very good news for Coos-Curry Electric, and that means it's good news for the Co-op's member-owners."



Humbug Mountain Fish Story

Brush Creek, which cuts through Humbug Mountain State Park and dumps into the Pacific Ocean south of Port Orford, was subjected for many years to past management practices that cleaned streams of woody debris. Biologists and park managers at that time thought at that time this would ease fish passage and create pleasing aesthetics for the public. It is now known that large woody debris and logs in streams are critical for fish habitat.

Oregon Department of Fish and Wildlife fisheries biologist Steve Mazur set out to clean up the past and return Brush Creek to a productive stream for winter steelhead, fall Chinook salmon, Coho salmon, coastal cutthroat trout and Pacific lamprey.

An Oregon Plan for Salmon and Watersheds restoration project was planned and implemented in cooperation with Humbug Mountain State Park and the Oregon Department of Transportation, with additional funding and in-kind contributions from the Oregon Wildlife Heritage Foundation, U.S. Forest Service and the South Coast Watershed Council.

In the day-use section of the park, blackberry bushes along the creek were removed, and whole trees and logs were placed. The stream bank was planted with Douglas fir and native hardwoods. Park personnel removed concrete picnic

tables that had been placed on the stream banks. The project also included decommissioning 250 feet of an old road that ran next to that section of Brush Creek.

At the mouth of Brush Creek, 3,000 cubic yards of fill from the park's beach access road and parking lot were removed. ODOT was instrumental in project design and generously offered a place to put this material.

To help enrich the stream, approximately 400 Chinook salmon carcasses from the Elk River Hatchery have been placed in Brush Creek annually starting in 2003.

Habit improvements are working. A smolt trap installed near the mouth of Brush Creek and monitored by ODF&W and park personnel will help monitor the success of past, present and future habitat projects. It is too early to determine population trends, but the number of steelheads, coho and lamprey smolts have increased during the last year.

Log and root wad structures stayed in place in the stream for two winters, creating pools and hiding cover for migrating fish. The structures slowed the water flow, causing a build-up of gravel bars for spawning fish. Now Brush Creek has come full circle since the days of clean streams.


Wildfire Awareness Week

It's Oregon Wildfire Awareness Week. This annual campaign began in 2004 following two of the most severe fire seasons in state history. Over one million acres of Oregon's forestland was scorched by fire in 2002 that included the 500,000-acre Biscuit Fire in southwestern Oregon. Many of the fires were the result of lightning strikes that peppered the state in mid-July. Wildfire Awareness Week's purpose is to activate local citizens to reduce fire hazard risks, by reminding homeowners and communities of the potential dangers and what they can do on their own to mitigate hazards. campaign's goal is to support local wild-fire reduction efforts and create citizen accountability and responsibility.

Coos Forest Protective Association (CFPA) reminds residents to be prepared before fire season arrives. Before planting perennials this spring, take time out to make your home safe from wildfires. This is the time of year to perform simple clearing that could save your home in the future.

"Residents should create a 'survivable space' around their homes to keep fire out," says CFPA spokesman Tom Fields. Survivable, or defensible space, is the area between a house and overgrown vegetation. Pruning nearby trees, mowing high grass and moving all fire prone materials at least 30 feet from your home can make a big difference.

Fields says cleaning up is half the battle. "You could have perfect firescaping that

is lean, clean and green, but your home could still be in trouble if your roof is prone to fire." He says the roof is the most vulnerable part of your house in a wildfire. Fire embers from an approaching wildfire can be carried great distances and land on rooftops. If it's time to replace your roof, Fields says to consider fire resistant material. It's also beneficial to clean pine needles and leaves from your roof and gutters and remove dead branches hanging over your roof. CFPA reported that 54 fires burned 188 acres in Coos, Curry and Douglas counties last summer. While no homes were destroyed in 2004, fire managers say it makes good sense to take the necessary precautions. "Fire can't tell the difference between trees and homes. Homes are just another type of fuel that the fire feeds upon," Fields added.

City Budget Meetings

That sound you hear coming from City Hall is the sound of numbers being crunched in the annual city budget. There are some moans and sighs in there too. The full City Council along with volunteer budget committee members Gary Doran, Emily Francona, Joanne Ruoff, Ken Williams and Jim Rhoades make up the official Budget Committee. Administrator Ken Knight with assistance from finance specialist Dave Johnson helps guide the line-by-line dissemination and discussions.

So far, the Committee has met for a total of four hours, two each on Wednesday

and Thursday of last week. There was supposed to be another meeting on Monday, May 9 but was postponed because too many participants had called in sick. The meetings pick up again on Thursday, May 12 at 6:00 pm.

While no decisions have been made, there have been some line items like training and travel chopped down to save money. Ken Williams made the suggestion that all salaries be frozen as many employees were scheduled to go to a higher level of pay in the new fiscal year

which will start on July 1. Williams said he did not feel the city would be able to continue increasing salaries and health benefits for much longer and needed to make some radical changes.

Councilors Ed Beck and Jim Campbell were adamant about cutting expenses to the bone and not passing on any unnecessary expenses to the taxpayers.

There will be at least two more meetings and possibly more to finalize the budget and have it published and adopted before June 30.

Weatherization Program

Coos-Curry Electric Coop General Manager Werner Buehler responded to questions regarding the status of the weatherization program. According to Buehler, "the heat pump financing program was implemented in 1992 and to date we have been involved in 2,550 installations. The weatherization/insulation program was established in 1982 and year to date we were involved in 3,044 homes and businesses. Additionally, our duct-testing program was implemented in 2001 to 2004. During this time we conducted 940 duct test/balometer tests."

Buehler continued in his e-mail "as of last Friday's board meeting, we have decided to suspend these programs effective June 1. We have effectively met our BPA conservation goals, and expended the funding provided. At this writing, we do not know for sure what programs BPA will be offering in the new conservation rate period (Post 2006) and at what funding and incentive levels. Once BPA makes a firm decision on what programs they will offer and what incentives they'll offer, we should be in a position to choose the most valuable programs for our members."
