### Getting Better All the Time By Evan Kramer



The Port Orford City Council meeting was bookended by two positive agenda items on Monday night.

The meeting began with a public hearing regarding the Port Orford Li-

brary grant. Port Orford Public Librarian Tobe Porter explained briefly to the council the grant was a \$500,000 community block grant the city was applying for on behalf of the library. There was no comment from either the public or the council but Porter was given a hearty round of applause when she left the speaker's chair. The grant application is being submitted to the Oregon Economic & Community Development Department and if successful will make construction of our new library possible next year.

The council had been sent a letter from Deady Street property owners Ted and Elaine Owen regarding a debris pile on a property adjacent to theirs as well as possible erosion problems. Elaine Owen told the council she was there to hear their response to their letter. Don Poirer, the engineer for the adjoining property, which is owned by Sandra Anderson, spoke next and passed around drawings

of a driveway project, which will provide access to the property. He said they wanted to start working tomorrow on the driveway to the Anderson property and that Joe Marsh had been hired to do the clearing, brushing and build the road. The driveway is an extension of one that leads to the Owen property and is located on an undeveloped city street. Poirer said the driveway would be done within a week and a half. He said the debris pile would be removed once the road is complete. Poirer said Anderson would be responsible for installing the utilities which will not cost the city any money. Public works administrator Dave Pace will inspect the sewer and water lines once they are installed.

Port Orford Arts Council treasurer John Lincoln questioned the council about the Arts Council event this Sunday at the Community Building. Mayor Auburn had denied the Arts Council's request for a temporary liquor sales permit for the Mary McCaslin concert this Sunday. Mayor Auburn said he denied the permit because there would be children present. Lincoln explained to Auburn the beer sales would be held in a cordoned off area. Councilor Milton Finch explained that under Oregon Liquor Control Commission rules it was legal to have a cordoned off area for sales of alcoholic beverages. No liquor can go out of the

area and no one under 21 can go in. The council agreed to the temporary liquor sales permit once it was made clear they would be held in a cordoned off area.

Mayor Auburn said the city was negotiating with Coos-Curry Electric about them installing the two Tsunami warning sirens. The city is due several street lights under their contract with Coos-Curry and would trade some of those for installation of the Tsunami sirens. Mayor Auburn said in addition Coos-Curry would be retrofitting all the city street lights to Dark Sky standards.

The council will hold a Water Master Plan meeting on Monday, October 24, 7:00pm, in the council chambers. A copy of the Water Master Plan is available at the Port Orford Library for people to read.

Mayor Auburn said there had been several good applications for the Department of Land Conservation and Development grant for a facilitator for the Port and surrounding area study. The facilitator will be chosen on Friday.

Some late bills have come in from SHN Consulting Engineers regarding the sewer upgrade project. Dave Pace said he wanted to discuss several problems with the

project with SHN engineer Steve Donovan.

Councilor Steve Abbott said the watershed committee was looking for citizens to serve on the Garrison Lake restoration committee. Abbott mentioned the lake as a secondary source of water for Port Orford.

Mayor Auburn said the city is currently advertising for a City Administrator. The deadline for applications for the job is the end of November and they could have a candidate selected by the first of the year.

The council discussed the job description for the police chief. They made a few minor changes in the four page document including the chief would work "with day-to-day supervision as designated by the council." It had read day-to-day supervision would be done by the

Chairman of the Public Safety Subcommittee. Councilor Jim Campbell made a motion to accept the job description as amended and it passed 6-0.

Councilor Campbell made a motion to accept Borrower's Resolution #2006-09 and it passed by a unanimous vote. This resolution authorizes the city to borrow money from Sterling Savings Bank of Washington State to purchase the Vactor truck for the public works department.

The council then cleared the council chambers except for the press and went into executive session under Oregon Revised Statues 192.660 2(i) – Job Evaluation.

They came back into regular session after finishing the executive session. It was noted the police chief had been given a very good evaluation. Councilor Campbell made a motion to declare that Police Chief Mark Creighton's six month trial period over, to raise his salary to Step 4

(it had been at Step 1), and that he would be paid the equivalent of PERS (Public Employee Retirement System) directly rather than have it put into PERS. The motion passed by a 6-0 vote and the meeting came to an end.

### Health District Meeting

The Curry Health District Board will hear the annual presentation from district auditors when they meet in regular session Wednesday, Oct. 26. While usually held in Gold Beach, the forthcoming board meeting will begin at 2:30pm., in the Port Orford Senior Center.

The health district operates Curry Family Medical, home to Shindler's automated pharmacy, in Port Orford, as well as Curry General Hospital and Shore Pines Assisted Care Community in Gold Beach. ### No Place Like Home By Valerie & Evan Kramer

It had been far too long since our last vacation and we were both more than ready for one so on Friday morning, Sept. 30, 2005, we (Evan and I and Honey Bear) left the house about 8am and started off. We didn't get far. Our first stop was Port Orford's Circle K where we loaded up with drinks and muffins. Finally we left Port Orford behind and headed south on Hwy 101. We stopped at the visitors' center just north of Brookings an hour later to walk the dog. The staff at the center were very friendly. Normally we would have stopped at McDonalds for breakfast but this time we didn't. Evan long-time McDonalds fan, Valerie, is finally getting tired of poor service and over-priced drinks. Besides, we had our muffins to eat so with no further stops, we finally arrived at the California border.

California is, I believe, unique in the states in that all major roads into the state are guarded by agricultural inspection stations in an attempt to keep out foreign insects or other pests that might wreak havoc with California's agriculture business. Much of California's fertile land is

guarded by mountains and deserts, so hitch-hiking bugs could become a major problem and expense. ## **New Patient Info System**

The Curry General Hospital board of directors, Wednesday, Sept. 28, approved the acquisition of a new \$916,372 digital information system expected to vastly improve hospital functions and streamline patient care over the next decade. The board based its approval on recommendations from the hospital management council, as well as clinical and business managers who have been researching health information systems for more than two years, according to Gary Short, chief financial officer.

“We’re currently doing all the things the new system will do, but we’re doing them manually,” he added. “The digital system will put Curry General on par with systems found at all the larger health centers, such as Asante or Providence.”

Pam Tracy, R.N., said the system will eliminate the long hours that nurses spend doing paperwork by hand. “Going digi-

tal will allow us to spend more time at a patient’s bedside. Patient histories and medication lists will all be on the computer as an electronic medical record.”

The new system also will allow nurses to quickly communicate patient needs to other departments – such as dietary, lab or radiology,” Tracy said. “Now we have to make separate calls to each of those departments.”

Rebecca Moore, the hospital’s business manager, has acted as project manager, overseeing comparison studies and system analysis since 2003. She and other members of an in-house health systems information committee observed demonstrations by four corporations and personally inspected systems at several Midwest hospitals last year. Eventually, they recommended CPSI, the Alabama-based firm that was finally chosen to design and build the system. Specializing in rural hospitals, CPSI boasts more than 530 clients, including Columbia Memo-

rial Hospital in Astoria, which implemented a similar information system in August, Moore added.

Implementation is expected to begin at Curry General Hospital in February 2006, with extensive training planned before and after that date, Moore said.

When asked if the acquisition will include systems in Port Orford, a hospital spokesperson replied, “It will include Port Orford, Brookings, the works. We’re all connected. Say that a patient comes into Curry Family Medical over a year and then one day needs to drive to the Curry General ER in Gold Beach on a weekend. The ER staff will be able to instantly access his electronic medical record, see what meds he’s taking, what previous diagnoses he’s had, everything that could help save his life. We do that now, it just takes a bit longer because we need to find his paper chart in a big filing cabinet rather than just accessing it by computer.”

### 'Mushroom Madness' Walk

Curry General Hospital's Sole Pursuits presents "Mushroom Madness," a day of free guided hiking, wild mushrooming and taste-testing, when Mary and Steven Taylor lead hikers along Bald Mountain Creek, northeast of Port Orford, Saturday, Oct. 29.

Participants can carpool or drive themselves to meet the Taylors at 10 a.m., on the east side of Highway 101 at Elk River Road. The group will follow them up Elk River to a small campground about 20-30 minutes from Highway 101. Hikers will meander down an old BLM road, taking animal trails and paths off the main road. The hike will conclude with a walk along Bald Mountain Creek before returning to the campground for samples of the Taylors' homemade wild mushroom soup. "Hikers are encouraged to explore the woodlands in the opposite direction after the soup break," Mary Taylor says.

"Although we will be walking up and down an old gravel road which is fairly steep in some sections, I don't think that the route will tax most people. When you

Walkers also should wear hiking boots and can bring whistles and compasses, a paper bag for mushroom collection, extra lunch snacks and water. Be prepared to walk in weather-proof garments.

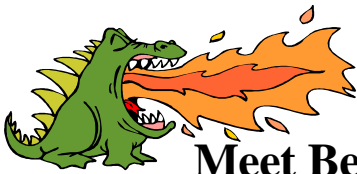

### Fire Season Officially Over

The Coos Forest Protective Association officially ended fire season on October 15 at 8:00am. Industrial fire precaution restrictions are no longer in effect and outdoor debris burning is now allowed without a permit outside incorporated cities in Coos, Curry and western Douglas County.

CFPA fire managers advise residents to exercise caution when burning. This time of year, several days of sunshine and dry weather can create a fire risk even if a week or more of rainy, cool conditions precedes them. The only type of burning requiring a permit is for logging slash.

To request a burn permit for slash disposal or if you have other general questions regarding debris burning, call your nearest CFPA office: Coos Bay (541) 267-3161; Bridge (541) 572-2796; Gold Beach (541) 247-6241.

The burn pile is located at the City Shops on Port Orford Loop Road. The burn pile will be open on Saturdays at the discretion of the fire department. 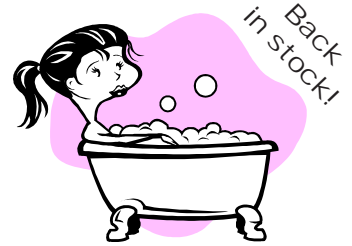

**KCBY Responds**

The following is a letter sent to Port Manager Gary Anderson from Ken Croes, Station/Sales Manager for KCBY-TV in Coos Bay (a CBS affiliate).

"First of all thank you for your e-mail. We appreciate the fact you cared enough to write.

As you know, we have been working to repair the problem for well over a month. The problem has proven to be an unprecedented engineering challenge. The Port Orford translator and a second unit that

feeds the translator at another hill location have failed. Both pieces of equipment are on our engineer's work bench awaiting parts replacement or have been sent away to the manufacturer for repair. At the same time, our backup systems are in use elsewhere keeping another translator location alive while its primary unit is being repaired. It took three engineers at three different hill locations simultaneously to even diagnose the problem. VERY unusual step. Needless to say, this has been the most frustrating (and expensive) repair challenge we have faced in the 44 years we've been on the air.

Our hope is to restore service by mid-week next week but I cannot promise it. We thought we had a cure twice before only to be dashed again. And all of this is happening at the worst time for us in that CBS is premiering most of their new and popular shows this month and next month.

I assure you that we are making every effort (and spending every dollar) necessary to bring service back. Hopefully our efforts will be rewarded soon. Thank you again for your e-mail."
