**Water Master Plan**

### Water Master Plan

The Port Orford City Council held a meeting on the updated water master plan on Monday night, October 24. Steve Donovan, from SHN Consulting Engineers, led the discussion. SHN

wrote the updated water master plan. He discussed a variety of scenarios including a drought. Donovan brought up 2002 when by the end of summer the city was using the maximum amount of water coming into the Hubbard Creek impoundment.

Donovan described the three “states” of water as raw (from the impoundment), treated (from the water treatment plant) and sold (water that is delivered to homes and is measured on your water meter). He said the City needs to achieve a goal of 15% water loss but currently it runs at 30%. He told the council they can gain more water by reducing water loss rates. He explained later that on an average day 180,000 gallons of raw water is used with 160,000 gallons treated and 124,000 sold.

He said the “equivalent population” for Port Orford is currently 1,700 which includes people staying in motels, RV

Parks, using restaurants, etc. He said within 50 years the equivalent population will be 4,650 including people living in the urban growth boundary.

Donovan listed three ways the City can go about expanding their sources of water. They can expand the existing dam (impoundment) at Hubbard Creek; add another reservoir above the existing one of the North Fork of Hubbard Creek, and look at Garrison Lake as a viable source of water (which it is not currently, due to the salinity). The Garrison Lake intake is located west of Arizona Street but Donovan suggested moving it possibly to the east side of Arizona. He said people would notice the taste difference between the lake and Hubbard Creek water. Mayor Jim Auburn told Donovan the salinity level in the lake was getting worse. Donovan suggested using reverse osmosis and nano-filtration to remove the salt.

The suggestion of using Elk River water for the City was not an option as that water is reserved for fish and farming. Donovan told the council that Hubbard Creek water is reserved for the city, not for fish.

Donovan said building up the Hubbard Creek dam was the cheapest and fastest way to go in adding water resources and that loss prevention was the best source

of water. Donovan estimated the cost to fix the water loss problem at \$3 million if the problem was leakage. He said it would cost \$200,000 to replace all the water meters in the city if they hired a private contractor. Councilor Steve Abbott seconded the idea about building the dam bigger and installing four master water meters in different parts of the city to identify where the loss of water is occurring. Donovan had brought up the idea of the master water meters to help determine where loss was occurring.

Donovan recommended converting the Deady Street Reservoir to a raw water storage tank. He estimated the cost of conversion at \$60,000 and said the roof needs to be replaced. Donovan recommended purchasing a site for an additional reservoir north of town (at an elevation). Hensley Hill was suggested.

Donovan spoke about the existing water treatment plant in Buffington Park and said everything didn't work well with the upgraded plant. He said it needs to be maintained on a 24 hour basis and recommended changing from chlorine gas to an alternative. He said we will soon be the last community in Curry County using gas chlorination in their water treatment plant.

### Water Master Plan Continued from Front Cover

A ten year plan was discussed which would entail restoring Garrison Lake and expanding the Hubbard Creek impoundment. Cost saving methods were discussed including replacing the 600 or so water meters in house rather than farm the work out to a contractor. Mayor Auburn recommended the City do a "One Stop" in Salem to look for funding the water system upgrades.

Other issues discussed were a conservation and water curtailment plan. Steve Donovan said the City needs a water curtailment ordinance and the M word came up in regards to a moratorium on building permits if the city water supply was not sufficient. If that situation occurred the City would have to come up with corrective measures.

The council didn't take any formal action at Monday's meeting. It constituted

the formal public hearing on the water system upgrade. They will take up the subject again at a regular council meeting as to which parts of the plan to proceed on.

### Final History Class

Shipwrecks, wartime, mining and several other topics will be covered at the final session of the Curry County Mini-History class on Thursday, November 3 at 7 p.m. at the Port Orford City Hall.

Treacherous shoals and rocks were the graveyard of many freighter and passenger ships on the Curry coast during the 1800's and 1900's before the advent of Loran and other aids to navigation. World War II saw the sinking of ships off our coast and the aerial bombing of Curry County by the Japanese. Port Orford played an important role in most of these events.

Military presence was evident all up and down the Oregon Coast with Army and Coast Guard patrols ready to repulse enemy attacks or saboteurs.

It was the lure of gold that brought many settlers to Curry County and while many of them moved on to other diggings, a few stayed and became among the finest of families. Mining was an important factor in the history of the county.

Last Thursday was a first hand look of history as it unfolded through the stories of six long-time Curry Countians. Lucile Lindberg Douglas, Dolores Marsh Mayea, Bob McKenzie, Tim Flake, Lloyd Kreutzer and Leon White shared memories of growing up in North Curry County to the 38 people attending the session.

The sessions are free and are sponsored by SW Oregon Community College and the Curry Historical Society.

### Health Dist. Approves Audit By Evan Kramer

The Curry Health District Board held their monthly meeting in Port Orford at the Senior Center on Wednesday afternoon. The meeting began with a 45 minute presentation of the 2004-05 audit by Steve Evans from the auditing firm of Symonds, Evans & Company, P.C. The total operating revenue for the fiscal year was \$11,992,138 while the total operating expenses were \$12,011,433. The district's total net assets as of June 30, 2005 were \$3,508,696. The District made \$176,000 on the sale of land in Brookings which they had bought to build an imaging and urgent care center but after purchasing the property decided not to go ahead with it. The sale was made in July of this year and will be included in next year's audit. Evans' explained the Health District's financial position has improved over past years since both clinics were designated Rural Health Clinics and the Hospital was designated a "Critical Access Hospital." They receive better payments from Medicare because of the designations.

Board member Doug Jamieson moved to approve the audit and it passed 4-0.

Curry Health District operates Shore Pines Assisted Living Facility, Curry Family Medical Clinic in Port Orford, Curry General Hospital and the Brookings Medical Center.

The Health District has a three person management council consisting of medical administrator Dr. Reg Williams, Ginny Hochberg, CEO, and chief financial officer Gary Short. Dr. Williams discussed the need for updating both the ultra sound system and the CT Scanner. He said the ultra sound system needed updating for higher resolution and deeper penetration as well as being more comprehensive and reliable.

The hospital is looking at a GE and Toshiba system with an estimated price of \$85,000. Williams said the hospital was losing ultra sound business to the north and south where people were going for better service and higher standards.

Williams discussed the need for a 16 "slice" CT Scanner, saying the single slice one the hospital has now is not the standard anymore. He discussed the district purchasing a used 16 slice CT Scanner, saying it would generate more reve-

nue by allowing more procedures and better patient care. He said once again with the old scanner the hospital was losing business to the north and south. Williams quoted a price of \$575,000 for a used 16 channel CT Scanner. Williams said the most pressing need was for an upgraded ultra sound system. Gary Short said a lease plan was better than purchasing one. Board member Roger Davis made a motion that whether the district purchases or leases an ultra sound machine to let Gary Short determine the best way to go economically and it passed 4-0 with Gary Anderson, Barbara Stover, Davis and Jamieson voting yes. Short said leasing focuses on cost where it is going to be used.

Gary Short said the "go live" date for the new computer system is February 1, 2006. The board discussed sending various employees to Mobile, Alabama for training sessions for the new system. The board approved sending five employees to the training sessions.

## **Prescription Drug Information**

The Port Orford Senior Center held a meeting last week to discuss the Medicare Plan B prescription drug plan going into effect in November. Sharon Mather from RSVP led the meeting and told people the enrollment period for the new prescription drug plan is November 15 through May 15, 2006. She described the process as "so confusing" and this from a person who attended at least two training seminars on the subject. The RSVP toll free phone number in Gold Beach is 1-888-811-1521. Please call this number if you need help enrolling as they can help you pick your plan.

Mather said she didn't know which insurance companies were participating in the program. She said there were 50 plans available under Part B. Mather said people who don't enroll by June 2006 that it would cost them 1% extra for every month they delay. Mather said even if you take no prescription drugs

now you still need to sign up. Everyone who has Medicare is eligible to sign up.

To get the information booklet "The New Medicare Prescription Drug Coverage, What You Need to Know" for free contact AARP at their toll free phone number, 1-888-687-2277.

Veterans need to sign up to enroll in the VA system. We now have a Curry County Veterans Service representative in Port Orford every Tuesday at the North Curry Service Center, 1403 N. Highway 101. His name is Frank Van Meter and his office hours are 1:00-4:30pm. Veterans need to bring in their discharge papers when applying for assistance.

Mather said she would be back in Port Orford after November 15 to help people enroll in the prescription drug program. She said people would need to have a copy of all the prescription drugs they take, the dosage, and how much it costs you now, plus your Medicare card which

has your Social Security number on it. Mather added that some pharmacies would not be participating in the new prescription drug plan.

## Homeless Youth Study

The League of Women Voters of Curry County is embarking on a study of Homeless and Runaway Youth in Curry County as part of a statewide effort by Leagues in counties throughout Oregon. The Homeless/Runaway Youth study was adopted as a two year state study at the League of Women Voters convention in May.

The League of Women Voters of Umpqua Valley (Douglas County) influenced the adoption of the statewide Homeless Youth study at the May state convention. From their recent study, which they conducted in their own county, the Umpqua Valley League found "There are many contributors to homelessness in young people. What is surprising is that most Americans believe these kids are the rebellious ones who won't 'be nice' at home. This is a fallacy. These rebels make up approximately 10% of this population. The rest of the kids leave home for survival purposes."

The Oregon League of Women Voters was directly responsible for House Bill 2202, passed by the Legislature in 2005, which directs the Commission on Children and Families to lead a process with other state agencies and community partners to develop a comprehensive and coordinated approach for services and support for runaway and homeless youth. This study will assist the process, and the Curry County League has partnered with our county's Commission on Children and Families to do this study.

The Oregon Homeless and Runaway Youth Work Group, in its report to the Interim Committee on Health and Human Services, Feb. 2005, states that "Estimates of Oregon's homeless youth population range from 23,000 to 25,000." These are young people ages 12 to 21, who have left home because of serious family problems, are not in safe and stable living situations and cannot be reunited with their families.

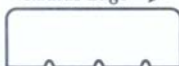

### TLT Funds Available
