City Administrator Search By Evan Kramer

The Port Orford City Council met last Tuesday night with the Mayor and all councilors present except for Jerry Steinhorst.

They began the meeting with Assistant Volunteer Fire Department Chief Wade Phillips reading the quarterly fire department report (September 30-December 31, 2005) as submitted by Fire Chief Gayle Wilcox who was out on an ambulance run. Membership in the department stands at 17 as of the end of December. Councilor Steve Abbott asked Phillips about a defunct fire hydrant at Twentieth and Jackson Streets. The department is aware of the problem.

The council awarded Certificates of Appreciation to Jerri Muskrat for her volunteer work on behalf of the police department and to John Fink for his work as a reserve member of the police department. Jerri Muskrat put in several hundred hours of time working in the office but is no longer a volunteer.

Mayor Jim Auburn said that the advertisement for a new city administrator closes on Friday, January 20. He said the personnel subcommittee would review the applications on Friday. Mayor Auburn later said the subcommittee chose four

people for the council as a whole to interview on February 3.

Councilor Ed Beck asked finance director Dave Johnson about bills the city had received from SHN Consulting Engineers. The bills had been held up by SHN but Johnson said the city was current with SHN now. Beck requested that all bills from SHN be sent to the City in a timely manner.

Councilor Abbott asked Public Works Director Dave Pace about the non-functioning fire hydrant at Twentieth and Jackson. Pace said he had ordered a new hydrant to replace the non-working one. Abbott asked Pace about the back up generators for the water treatment plant and the Hubbard Creek reservoir. Abbott said he wanted the City to move on this issue in light of a recent power outage that shut down pumping water from the reservoir. Pace said the City could go for three days with water if the power went out. The City does not have the money to buy the generators now.

Police Chief Mark Creighton said they had hired John Fink as the code enforcement officer. Creighton said the department had recently received a \$2,000 grant from ODOT to pay for overtime enforcement of seat belt laws, DUII, and speeding and that a car had been donated to the

department by the Bandon Police reserves. The department has also received several new digital radios. The council and Creighton spoke about the \$750,000 Homeland Security Grant the county had received. They had questions about where the money had gone and how it was distributed. Councilor Abbott made a motion that he and Creighton will draft a letter to Sheriff Mark Metcalf asking about how the grant monies were appropriated in the county. Mayor Auburn will sign the letter on behalf of the city. The motion passed 5-0. When the council finds out where the money went please share it with the rest of us.

The council considered the revised police policies and procedures manual with councilor Jim Campbell making a motion to approve the policy manual with the changes the attorney incorporated and it passed 5-0.

The council voted 4-1, with councilor Milton Finch voting "no," in favor of a motion by councilor Campbell to approve a right-of-way usage license for Robert Mielenz for parking, storage of bark, etc. at God's Green Earth. The business sign on Nineteenth Street is not included in the motion and will have to be moved 10 feet from the road. Mayor

City Administrator Search Continued from Front Cover

Auborn told Mielenz the council still has a problem with the business's two signs.

Councilor Campbell made a motion to approve the right-of-way license for the planting of shrubs by Kelly Dunbar at his property on Jefferson Street. Campbell's motion amended the right-of-way license to include the shrubs be approved by the City.

The council approved Resolution 2006-12 which authorizes the acceptance of a United States Department of Agriculture Community Facility Grant for \$50,000 for improvements to the American Legion building including new ADA approved bathrooms.

The council approved Resolution 2006-13 which authorized the acceptance and disbursement of a Community Block Grant from the Oregon Economic and Community Development Department in the amount of \$500,000 for the construction of a new Port Orford Public Library.

The council unanimously voted yes on Ordinance 2006-06 which proclaims no eminent domain for purely private benefit. Mayor Auborn said this Ordinance was important in light of the recent Supreme Court ruling in the case of New London, Connecticut. People's homes were taken by eminent domain and then sold to a private developer. The council ordinance states the "City of Port Orford shall not use the power of eminent domain for the sole benefit of private entities." This ordinance is modeled on one recently passed by Curry and Jackson Counties.

The council by motion agreed to amend the Franchise Agreement with Coos-Curry Electric. In lieu of receiving two street lights from Coos-Curry the City will receive two poles and energy for the two Tsunami warning signs from the electric cooperative.

The council passed on a request by Curry Family Medical to place a sign on city property at Highway 101 and Madrona. Mayor Auborn informed the council the

City no longer owns that property having given it back to the County. Chief Creighton suggested Curry Family Medical goes to ODOT for permission to get a highway sign.

Council Campbell made a motion to approve the consent calendar which included the minutes for two meetings and a Proclamation by the City proclaiming January 30 through April 4 as a Season for Nonviolence. The consent calendar included approval of the Mayor's appointments to the Parks Commission – Mark Murray, Planning Commission – Frank Smith, Doug Jamieson and Erna Barnett, and Ken Williams to the budget committee.

The council's next regular meeting will be held on Tuesday, February 28.

Storm Damaged Roads

As heavy rains continue to drench the area, many Bureau of Land Management (BLM) Coos Bay District forest roads have suffered damage and several remain closed. Motorists are urged to use increased caution when traveling on these forest roads, especially at night. Damage to roads include slumps (loss of fill), slides, plugged culverts, and downed trees.

“Many of our roads are affected by rain and storm damage, especially those roads in drainages and low lying areas,” said Gloria Robbins, Maintenance Manager for the Coos Bay District. “Ridge roads tend to fair better and suffer less damage.”

The BLM is currently conducting an inventory and assessment of its road system and recreation facilities to determine the extent and location of the damages. Once the inventory is completed, clean-up and repairs will be prioritized and completed as soon as possible.

The following roads are closed:

- Baker Creek Road (31-12-3) at milepost 4 due to a fill failure.

- Rassler Creek Road (31-11-14) due to a slide.
- Upper Rock Creek Road (30-10-3) at milepost 6.5 due to a slide.
- Dead Horse Road (28-9-8) at milepost 3 due to a fill failure.

The BLM is closely monitoring the following roads. Avoid traveling on these roads at night and watch carefully for debris and cracks in the pavement:

- Smith River Road
- Burnt Mountain Access Road
- North Fork Coquille Road

The group campsite at Edson Creek Campground, south of Langlois, is closed due to a damaged low water crossing.

Wireless Internet

That boom truck with the crane and antennae on top of it in Port Orford on Wednesday and Thursday was worth noting. Verizon has hired a contractor to test for the best location for a wireless Internet antennae in Port Orford. The contractor had his truck adjacent to the City of Port Orford water tower on Wednesday morning. The test antennae was raised 125 feet above the truck and transmitting to a location in Port Orford. On Thursday he moved the antennae to a location near the Castaway Motel. The contractor said Verizon intends to offer wireless Internet service in town within one year.

Lamprey Talk

On Wednesday, February 1, 7:00pm, the Kalmiopsis Audubon Society will host a presentation by Leo Grandmontagne, president of the Oregon Lamprey Society, about the role of lamprey in coastal rivers, at Port Orford City Hall. Grand-

montagne has lived and worked, as a logger and a sheep farmer, for 65 years in Coos and Curry Counties. But for the past 10 years, he has focused his attention on researching lamprey in the South Fork Coquille River and has come up with some interesting theories. Come hear Grandmontagne's story, learn about lamprey, and see the fascinating photos of this amazing creature that is native to our south coast rivers. This education

program is free, and all community members are welcome.

The presentation will be a unique opportunity to learn about lamprey, a little-known creature that is native to our local rivers. It is also a chance to hear about how a man, untrained in science but deeply interested and engaged in his place, has made a valuable contribution to understanding of fish in our rivers.

Port Commission Meeting By Jane Cramer

The Port Commission with all members and Port Manager Gary Anderson present met in regular session on Thursday, January 19.

The February meeting will be held on the regular 3rd Tuesday meeting date (February 21). It had previously been decided to change the date because of a Council Chamber scheduling conflict which has since been resolved.

Under Public Comment Jeff Miles, speaking for local fishermen, asked the Port to take the lead in an attempt to have an economic disaster situation declared because of the financial impact on fishermen and local businesses by weather conditions and shoaling. Boats can only go in or out at high tide because of shoaling and five boats have been damaged trying to get near the dock for unloading product and hoisting.

There was some discussion about dredging due next week and whether that would impact any decision. There is a fine line between dredging enough to keep the Port open after winter storms and reserving enough allocated dredging funds to bring a clamshell dredge in next summer. Clamshell dredging is more cost effective and has longer lasting benefits. Scott Luhr will contact Mike Murphy to determine the process and ramifications of a disaster declaration.

Manager Gary Anderson spoke about a letter from DEQ giving the Port a clean bill of health for the property at 5th Street and Harbor Drive. The hole is being filled and Commissioners will have a workshop meeting soon to explore plans for utilizing the property to the best advantage.

Only one response was received to the advertisement for an Attorney of Record. Shala McKenzie Kudlac of Bandon was approved for the position.

There was a discussion about revising the Port's Drug Policy. Anderson will contact Special Districts for advice on random testing specifics.

Commissioners were given a record of commercial and sport hoists for the last seven years. 2005 would have been an excellent year except for the weather in December and the delay of crab season opening. Sport hoist totals in 2005 were the best in the seven year period.

Anderson reported promising leads in the effort to obtain matching funds for a Connect Oregon Grant to pay for the Port to install its own dredging equipment.

Anderson has applied for a Transient

Lodging Tax grant to replace the sign going down to the Port.

Commissioners and the public were reminded to attend two important upcoming meetings. The first will be a town meeting on Tuesday, January 31 at 7pm in the Council Chambers. The public is invited to address plans for changes to the Port Orford Strategic Plan. The second will be Friday, February 3 at 6:30 at the Savoy Theater. There will be a 30 minute film followed by a question and answer period about marine reserves.

Free Health Screening

Free health checks – from children's dental screenings to adult bone scans and vision checks – are expected to draw a large variety of participants when the first Brookings-Harbor Health Fair opens its doors from 10am to 3pm Saturday, Jan. 28, in the Kalmiopsis Elementary School gymnasium, 650 Easy St. in Brookings.

An Oregon public health consultant will screen children for dental problems throughout the fair. Additionally, audiologists will offer free hearing screenings; eye experts will conduct vision screenings; and Curry County Health Department staff will take blood pressure readings.

Heel bone scans will be offered to check for brittle bones in older adults; and painless measurements will be provided to check an individual's body mass index.

Other interactive services planned include health career counseling for youth and mid-career adults, a chance to wear "drunk driving" goggles, pharmacist checks of medications, and samplings of therapeutic body rubs and rolls — compliments of at least five different local massage therapists.

For nutritional pick-me-ups, attendees can order bottled water, juices and healthy, low-fat items from an outside grill. Those needing an emotional pick-me-up can pet Jake, a golden Labrador who volunteers as a health therapy dog.

Education and entertainment will combine at 11:30 a.m. when a Brookings Jazzercise group demonstrates the popular fitness activity to music on stage in the school gym.

Highlighting the event, six health providers will give free health seminars at 10:30 a.m., noon and 1:30 p.m. Speakers will include Juliane Leighton, M.D., Jan

Willms, M.D., Charles Hochberg, M.D., Linda Zia, R.D., James Strom, substance abuse counselor, and OSHA state officials.

Co-sponsors hosting the health fair include the City of Brookings, Curry County Public Health Department, Brookings School District 17-C, Curry General Hospital and Sutter Coast Hospital.

Sewage Overflow

The City of Port Orford experienced an overflow of the sewage collection system on Jan. 10 and again on Jan. 17 at the manhole located at the intersection of Hamlet and Wyoming St. The cause of the overflow was excessive flows to the pumping station on Wyoming St.

The excessive flows were caused by heavy rains and the overflow was mostly storm water run-off entering the collection system. The overflow amounts were minimal and posed no health risks to the public.

Oregon has enacted a new statute for law enforcement to deal with dangerous dogs. Under the new statute, "Maintaining A Dangerous Dog" is committed when a person is the keeper of a dog and that person, with criminal negligence, fails to prevent the dog from inflicting serious physical injury on a person or kills a person, is a potentially dangerous dog, or a dog is used as a weapon to commit a crime. The resulting punishment can be either a Misdemeanor with a maximum penalty of one year in jail and a \$6,250.00 fine or a Felony with a maximum penalty of five years in prison and a \$125,000.00 fine depending on the seriousness of the offense.

The Police Department now provides loaner cellular telephones to people in need, such as victims of domestic violence who do not have telephones, and need to be able to contact 911 at any time.

If anyone has a cellular telephone and charger they have converted and has no further use for, you can donate it to the Port Orford Police Department at 555 West 20th Street.
