

Shifting Sand

Dunes Alteration Project

Way back on October 20, 2005, the Oregon State Parks and Recreation Department (OPRD) held a public hearing in Port Orford at the Community Building regarding a permit to remove 80,000 cubic yards of sand on the Elk River Spit.

The application by Sixes rancher Scott McKenzie was approved with conditions on May 8, 2006. McKenzie owns property to the east of the Elk River Spit and the build up of sand dunes to over 30 feet high has blocked his view of the ocean.

McKenzie worked with the State and the United States Fish and Wildlife Service (USFWS) on this application which main goal is to "restore and maintain suitable breeding habitat for the state and federally listed threatened Western Snowy Plover. Habitat restoration will involve removing the non-native European beach grass and grading the dune to approximately the level it was in 1967." 88,500 cubic yards of sand will be removed from the fore-dune by bulldozer creating a flat open beach with sparse vegetation that will be conducive to western snowy plover breeding. The removed sand will be placed on the beach at the tidal level where it will return to the littoral transportation cell by natural forces."

It needs to be noted that Scott McKenzie started out with the goal of removing a sand dune which had built up and blocked his view of the ocean on what is his land. It was State Parks and USFWS who introduced the snowy plover into the story because they wouldn't issue a permit to remove the sand without the snowy plover restoration program attached to it.

Oregon State Parks and Recreation issued this permit with a total of 20 conditions taking up one and one half pages of single spaced copy including condition #6 which states as follows:

"Project is to be performed outside the major sport fishing recreation season to limit safety concerns when operating heavy equipment in a seasonally high recreation traffic area."

Condition #14 involves the snowy plover. If requested by the USFWS, OPRD will not consider beach restrictions at the site unless, or until, at least one pair of Western Snowy plovers show signs of nesting patterns as described in the HCP or until the Elk River site becomes a priority unoccupied site as outlined in the HCP.

The permit was issued by Tim Wood, Director of Oregon State Parks.


There is an appeal process for people disagreeing with this decision but the time period for filing an appeal ran out on June 8. The newspaper was notified the permit had been approved with conditions one week prior to the July 4 holiday. At the October 20, 2005 meeting Calum Stevenson, Coastal Coordinator with State Parks said the decision would go to the Director and be made within 45 days but at least one extension of the permit process was given when requested by McKenzie.

Port Orford just enjoyed a successful and fun July 4 Jubilee celebration followed last Saturday by the most successful Sunset Garden Club tour of all. Now it's county fair time as the Curry County Fair opens on Thursday, July 20 and runs through Sunday, July 23. up on the Jubilee which theme was "Dancing in the Streets". There is plenty of live entertainment this year at the fair plus many of the traditional things that make a county fair a celebration of 4-H, livestock and agriculture.

Police Report by Chief Creighton Creighton@popd.org

07-03 Police took a report of a male subject watching children in the area of Tenth Street. The complainant indicated the subject was suspicious. A report has been taken and no crime was committed. The subject was identified but no further action was taken at this time. NOTE: always watch when people are walking about your community especially when children are out playing. If anyone looks suspicious call the police immediately. We need to know who these people are.

07-04 Police responded to Buffington Park on a complaint of several children

threatening with knives in the area. Police arrived and made contact with an off duty police officer who had the two children detained. The boys had chased another while brandishing a knife. The oldest boy was age nine. Police contacted the children's parent who was asleep in a vehicle. One parent advised that the boys were not supposed to have the knife until they attended a special knife training school. None of the victims parents wished to pursue a criminal complaint. The knife was confiscated and the juvenile's parents were warned for failure to supervise a child.

07-04 While patrolling Battle Rock on July 4, police cited two male subjects for Minor in Possession of Alcohol, one male was cited for furnishing alcohol to minors, and one male subject was arrested, and lodged in the Curry County Jail for Furnishing Alcohol to Minors.

07-04 Police responded to a residence on 16th Street on an incomplete 911 call. It was determined that a male subject had dialed 911 instead of the correct area code. No other action taken.

07-06 Police were dispatched to a residence on Port Orford Loop Road where it was reported that a male subject and his child had fled from a residence. Witnesses advised they had heard gunshots from the residence after the male subject, and child walked away. Police contacted the male subject and child, and dispatch attempted to call into the residence but no one answered. Police requested additional units from Curry County Sheriff's Department, and requested the Port Orford Ambulance stage near the scene. An Oregon State Police Officer arrived to assist, and it was finally determined that no shots had actually been fired. Someone had thrown rocks against a building which sounded like gunshots. The call was determined to be a verbal only domestic, and was handled at the scene. NOTE: Thanks to Curry County Sheriff's Office, Port Orford Ambulance, and Oregon State Police for their fast response.

07-06 Police were dispatched to a motor vehicle crash on Highway 101 near Rays Food Place.

07-07 an incomplete 911 call was received near 9th and Jackson Street. Police responded, and a female subject reported that her neighbor had not come home. It was later determined that the neighbor was alright and did return home. **REMEMBER:** anytime something seems suspicious in your neighborhood, or with a neighbor call us. It is very important that all of us keep alert and watch our neighborhoods, even if it doesn't seem impotent at the time it is always better to be safe than sorry.

07-08 Police responded to Ninth and Oregon Street on a report of an elderly male subject in the street. Police contacted the subject who was advised to stay off the roadway so he wouldn't get hit by a vehicle, and to use the crosswalk areas. The male subject was upset, and after shaking his cane at the police officer decided to comply. No other calls were received on this subject.

07-08 Police contacted a male subject south of Port Orford after a report of Criminal Mischief. After the investigation, the male subject was cited to appear

for Careless Driving, Criminal Mischief II, Open Container, and Possession of Controlled Substance Marijuana.

CHIEFS NOTE: The fireworks and parade went very well. We had all three of our police officers working the parade and fireworks, and five of our reserve officers. Two officers were in plain clothes during the fireworks display and went among the crowd taking care of minor problems before they escalated. During the display we had a problem on the beach with subjects operating ATV's dangerously, and some unlawful drinking. The officers responded to the beach and arrested one male subject for contributing alcohol to minors, another male subject was cited for furnishing, and two more were issued citations for minor in possession of alcohol. Remember we only have three police officers and I'm trying to cover our community 24 hours a day 7 days a week for emergency calls. My officers and I are generally not in the office, we are out working. We are dispatched by Curry County Dispatch center at 1-800-543-8471. They always know which officer is on call, or on duty working. You can call that 800 number for any emergency, and they will forward the

Port Orford Grant

Curry County and the cities of Port Orford, Gold Beach, and Brookings have been awarded a total of \$162,000 from the Oregon Department of Land Conservation and Development (DLCD). Lane Shetterly, department director, made the announcement today as part of an overall award of more than half a million dollars in federal coastal planning assistance grants to Oregon's coastal cities and counties.

The funds are part of a federal Coastal Zone Management grant to the state from the National Oceanic and Atmospheric Administration, Office of Ocean and Coastal Resources Management.

Shetterly said Curry County will receive two kinds of grants: one is for coastal planning assistance, based on a population formula; the other is for technical assistance or special planning, based on proposals.

Curry County will receive \$27,000 in planning assistance funds, Brookings \$6,000, Gold Beach \$5,000, and Port Orford \$4,000.

"Coastal local governments need all the help they can get in managing development pressures and protecting our coastal heritage," said Shetterly. The county and cities will budget the funds for staff to answer questions from landowners, administer local land use regulations, and conduct long-range planning.

Curry County and the three cities applied to DLCD in April for special technical assistance grants. After reviewing all of the requests, DLCD awarded the county \$22,000 for equipment to be used to complete a county-wide geographic information system, or GIS, which will enable citizens to find information about land use and properties over the Internet. The cities will also receive funds for GIS: Brookings \$10,000, Gold Beach \$6,532, and Port Orford \$11,468.

"There's a high level of interest in how this area develops and many issues to resolve," said Shetterly. "These funds will enable the county to work with residents and the city to create an appropriate development plan."

Port Orford will receive \$30,000 for phase two of planning for its downtown, port, and oceanfront areas.

"Port Orford is a gem ready to be discovered," Shetterly said. "The city has done a great job of involving the public to create a vision for the oceanfront and port areas, which are so valuable to the community. This is grassroots planning at its best and I'm pleased we can help the city take the next steps to secure that vision."

The State of Oregon receives federal funds because DLCD's Coastal Management Program, approved in 1977, meets national requirements.

Grants Awarded

Local fishery conservation organization Port Orford Ocean Resource Team recently received three grants totaling \$300,000 to support their program work in 06-07.

The David and Lucille Packard Foundation awarded POORT a two year, \$240,000 grant for community-based fisheries management to ensure the long-term conservation of the nearshore reef systems of the southern Oregon coast.

The Regional Marine Conservation Project grant for \$50,000 will support developing a definition for area based management for Port Orford, analysis or relevant scientific data to inform local fisheries management, and a project for Port Orford fishermen to increase access to the commercial halibut fishery.

A \$10,000 grant from Ecotrust will support organization capacity building.

POORT is a nonprofit science and educational organization working to support our community's access to the ocean.

POORT's Vision: A sustainable fishery and marine ecosystem that utilizes the best science and local experiential knowledge for the community to make local fishery management decisions that 1)sustain and improve the habitat and population base of fish 2)provide high quality, high value sea food products to consumers 3)support the economic viability of the PO community.

We'd only covered a little over 100 miles on Tuesday and less than 100 on Wednesday. With the extra traffic it still seemed like a lot of driving. We got breakfast at Panero and checked our email, went to our appointment at the funeral parlor, picked up the prescription at Walgreen's and finally headed out to see Mom again. On the way we stopped at some interesting stores in Chester, Ohio. One Ski shop had decorated their yard with a fence made of skis. Evan got some photos.

Next we checked out a toy store that specialized in just Legos. I remember Legos as those little plastic thingies you stick together to make something that doesn't do anything or look like much of anything. Those days are past and Legos have changed. They had fancy buildings, a cathedral, a skyscraper, and several running railroads all made from Legos and many more items as well. The little blocks still exist but there are zillions of specialty parts to allow you to create just about anything you can imagine. The vendor, if I remember correctly, said he was the largest retailer of Legos between the East Coast and Chicago.

In the same shopping center Valerie checked out a small computer store while Evan and Honey Bear made friends in a dog store. Honey Bear won. Evan came

away loaded with new kinds of food and other goodies for her and she loved them all.

We finally got to Heather Hill and Valerie made her final visit to her mom. Saying goodbye is never easy but maybe not having a chance to say goodbye is even worse. Just about two weeks later, at 12:30am Friday, May 26, Valerie's mom passed away peacefully and painlessly.

After we left the complex, we needed some peaceful time. We stopped at the Holden Arboretum, 3500 acres dedicated to connecting people with nature for inspiration and enjoyment, fostering learning, and promoting conservation. www.holdenarb.org.

Nearby, we also stopped at the headquarters of the Herb Society of America (www.herbsociety.org). Their headquarters is a fascinating historic building and includes a tremendous library of books about all aspects of herbs.

Finally Evan paid a quick visit to the James A Garfield House in Mentor. After that we went back to our room only to find that it had not been made up nor the towels changed. The front desk was very friendly and explained that the cleaning staff doesn't enter rooms of guests with pets unless the owner is there. Turnpike west from Cleveland. The Ohio Turnpike is a for-pay freeway. When you get on, you are given a ticket and when you leave, you pay a toll depending on how far you've come. It cost \$6.60 for us to go from south of Cleveland to the Indiana state line. There are occasional (infrequent) rest stops with food, gas, very clean rest rooms, etc. and we stopped at one of them. They all offer WiFi service but again it was \$3.95 per hour so we declined to use it.

The Turnpike continued in Indiana and we stopped at another rest stop near Gary. Evan walked Honey Bear and made friends with the driver of a J&R Schugel semi truck who was also traveling with his dog. Evan asked about the route around Chicago and the driver said he was going that way and that we should just follow him. Traffic was heavy but the driver knew his job and always knew just which lane to be in. Salmon Disaster Relief

After meeting with commercial fishers in Newport to discuss the Administration’s latest response to the salmon fishery crisis, U.S. Senator Ron Wyden today blasted the Commerce Department for proposing Small Business Administration (SBA) loans to help salmon fishers instead of direct aid or a declaration of a commercial fishery failure.

“What our fishing communities needed to hear from the Secretary of Commerce is that real help is on the way now,” Wyden said. “Instead, our fishers have been invited to take on more debt at a time when they’re already on the financial brink.”

According to Secretary of Commerce Carlos Gutierrez’s announcement last night, the SBA could provide low-interest Economic Injury Disaster Loans. However, according to fishers at Wyden’s meeting in Newport and several

Oregon banks contacted about the SBA loan proposal, SBA loans will not work for this type of disaster because many fishers — shut out of this fishing season, after a bad season last year — would not have the collateral, current income or a dependable income for the future in order to qualify for loans.

The Secretary announced his proposal for SBA loans in a conference call last night with Wyden, U.S. Senators Gordon Smith, Dianne Feinstein and Barbara Boxer, Governors Ted Kulongoski and Arnold Schwarzenegger and members of Oregon and California’s House delegations. During that call, Wyden also pressed Gutierrez to contact the Chairman of the Senate Appropriations Committee, U.S. Senator Thad Cochran, and ask for assistance in getting emergency disaster assistance funding through Congress; the Secretary agreed to call Cochran.

Earlier this year, the National Oceanic and Atmospheric Administration closed 90 percent of the fishery. The closure has already resulted in millions of dollars in losses to fishermen and communities dependent on the salmon industry. In response to Administration foot-dragging, Wyden temporarily blocked a major piece of fisheries legislation, the Magnuson-Stevens Fishery Conservation and Management Reauthorization Act of 2005, until after his amendment making salmon fishermen eligible for disaster assistance was added to the bill. The inclusion of Wyden’s amendment, if also adopted by the House, clears the way for the congressional delegation to pursue much-needed disaster aid.

**Rare Birds
 By Evan Kramer**

The Port Orford Public Library hosted authors Dan Bessie and his wife Jean Johnson for a book signing and reading at the TransAction Gallery over the July 4 weekend.

Bessie read from his most recent book "Reeling Through Hollywood: How I Spent 40 Fabulous Years in Film and Never Made a Nickel." The book details his years in the film business from his time as an animator at MGM to making education films and documentaries. It details the making of his two motion pictures, Executive Action which he produced and Hard Traveling which he directed. Jean Johnson read from her book, "Starlings in the Park", based on true life experiences.

Dan Bessie spoke about his other book "Rare Birds An American Family" which contains chapters devoted to the many "rare birds" in his family. They include his father Alvah Bessie who worked as a screenwriter at Warner Brother's studio during the 1940's. After an appearance before the House Committee on Un-

American Activities in 1947 where he refused to testify he was blacklisted and later jailed in Texas. Alva Bessie was one of what became know as the Hollywood Ten. Other rare birds in the family included Bessie's cousin Phoebe Snetsinger. The 1994 Guinness Book of World Records listed Phoebe as the world's leading birdwatcher with over 8,500 birds spotted and identified. She was killed in November of 1999 in a jeep accident in Madagascar while on a bird spotting trip. Dan Bessie's uncle on his mother's side was Leo Burnett who founded and ran the Leo Burnett advertising agency that gave us the Jolly Green Giant and the Marlboro Man among others. Another uncle was Harry Burnett who was one third of the Yale Puppeteers. They produced extremely popular marionette and live review shows at their Turnabout Theater in West Hollywood for 15 years. Dan Bessie lovingly calls his mother Mary the rarest of the rare birds in the chapter devoted to her.

The Dan Bessie and Jean Johnson books are available at the Port Orford Public Library. I highly recommend reading Rare Birds.
