### CCEC Shows a Profit

The Coos Curry Board of Directors held their monthly meeting on Friday at the District headquarters. Board members present included Pete Radabaugh, David Itzen, Daryl Robison, Grant Combs and Gary Schlottmann. Board member John Herzog participated in the entire meeting via a telephone conference call as he was out of town. The board's Portland attorney Michael Hanlon was present for the meeting.

Board Chairman Daryl Robison noted that the agenda has been changed and public comment is now taken at the beginning of the meeting. The board was asked about the status of the energy conservation program which used to include help with insulating houses and financing heat pumps. They were also asked about the outsourcing of the monthly billing to Sterling Bank in Portland. Robison responded that these and other issues would be discussed at the board strategic planning meeting on August 7 and 8. It will be held in Gold Beach.

Don Heinzman said the board was told the minimum monthly charge (base rate) needs to be evaluated and asked if early steps could be taken to lower it. The base rate is \$33 a month for residential users.

Heinzman also said the reconnect fee of \$200 is unjustifiable. He recommended the board review the general manager's salary and see if it was justified.

The board discussed changing the meeting times and locations. Board member David Itzen wanted to table the discussion until the board strategic planning meeting. Daryl Robison said it was important the board become available to the members. Gary Schlottmann suggested the board have forums to meet with the public and hold them in the evenings.

The board considered the list of checks written before voting to accept them. Daryl Robison had several questions on various checks. He asked chief financial officer Doyle Eden about several checks and there were some which Doyle couldn't explain to him. One area of concern from Gary Schlottman was the \$17,000 the Coop spent on the Ruralite the past two months. This will be addressed at the strategic meeting. David Itzen said people look to the Ruralite for information about the Coop. He emphasized that several important decisions will be coming up in the next year or two.

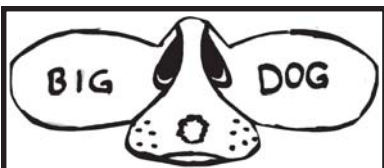
Doyle Eden presented the Form 7 financial report to the board. The year to date revenue for the Coop for the first six months is \$14.645 million. The margin

or "profit" for the first six months is \$2.233 million. Direct costs for the six months were \$9.948 million while indirect costs were \$2.464 million. The majority of the direct costs go to purchasing power. The Coop reported \$1.127 million in non-operating revenue to bring the total net income before tax to \$3.360 million. Most of the non-operating income came from South Coast Satellite.

Income for the month of June was \$2.195 million. The Coop had budgeted \$1.944 million in revenue. The revenue for the year is ahead of schedule according to Eden because of the sale of more kilowatt hours of electricity. Sales were up \$1.5 million over last year. General Manager Werner Buehler said the Coop was the beneficiary of a wet, cold winter resulting in increased sales of electricity and cheaper power. The cost per kilowatt in 2006 had been 2.93 cents but the budgeted cost was 3.60 cents.

Grant Combs attended the Oregon Rural Electric Coop Association meeting. He replaced Terry Hanscam as the Coos-Curry representative to that group. Combs attended a conference on ocean wave energy put on by the Oregon Science and Technology partnership with Oregon State University. They have located seven potential sites on the Oregon Coast

for exploring wave energy production including one in Gardiner at the site of the now closed International Paper mill. Potential cost for ocean wave electricity is 25 cents per KWH.

The board was given a large notebook of information they will discuss at their upcoming strategy planning meeting including the description of the duties of the president/chairman of the board.

The board discussed use of vehicles under discussion of the policy review committee report. The general manager will tweak the procedure on personal use of company vehicles. All board members will serve on the policy review committee. Daryl Robison said he wanted to see some immediate attention paid to some of the policies.

The board next meets in public session on Friday, August 25, 10:00pm in Port Orford.

## Civic Beautification Award

At their monthly meeting in July Anne Goetzman, newly elected president of the Sunset Garden Club, was proud to announce an unprecedented achievement for the organization, the winning of the first place Civic Beautification Award sponsored by the Pacific Region of National Garden Clubs for 2006. It started with a desire by Joan McDow, past president of the club, to beautify the northern entrance to Port Orford which, until recently, was in disrepair and presented an unsightly entrance to the city. Under the leadership, perseverance and guidance of Anne Goetzman, this year's club president, along with McDow and a host of volunteers, the boat and xeriscape portion of the landscape project was completed last winter and, after a lot of hard work and a \$500 grant from the Council, with matching funds from the Sunset Garden Club, an overview of the project was submitted by Goetzman which culminated in the award. Needless to say the

club members were overjoyed with the recognition, no small feat considering the contest was held between the region's eight western states and all their cities. The Pacific Region includes Oregon, Washington, Alaska, California, Idaho, Arizona, Nevada and Hawaii. The award came with a certificate of achievement and twenty dollars. Ruth Root, awards chairman for the western region, states that there are no National awards, only regional, so this is the highest award a garden club in the United States can achieve.

Goetzman's design utilizes deer resistant plants, a xeriscape theme to minimize summer watering as well as stones and gravel, mimicking a rocky shore line, to lessen winter erosion on the steep slope. The drought resistant plants will eventually develop into a wave pattern around the boat, signifying Port Orford's ties to the ocean. The recent addition of maritime flags along the mast ropes has enhanced the boat. The project consumed

many hours and days of volunteer time, as it does to this day, utilizing garden club members, the Rotary Club and many others. An ongoing project, next up is the removal of brush and non-native vegetation from the area, along with further distribution of the remaining rock and gravel, a testament to the Sunset Garden Club's continuing efforts to beautify Port Orford.

## No Bids for Dredging

The Army Corps of Engineers held the bid opening for the summertime clam shell dredging for the Port of Port Orford, Coos Bay and Winchester Bay on Thursday, July 27. No bids were submitted for the dredging which is necessary to keep the three Ports open this winter. Immediate steps are being taken with the Port of Coos Bay in the lead to get the situation resolved with the Coast Guard and get dredging started. The dredging contractor needs a permanent load line certificate and none of them had that.

## Guatemalan Stoves

George Lewis and Dick Smith from the Florence Rotary Club presented to the Port Orford Rotary Club a talk about their work on the Guatemala Stove Project. Several Rotarians from the west coast of the United States went to Guatemala with the goal of changing the lives of Mayan Indian families by installing efficient stoves for cooking. This will improve the health conditions where there is a very high cause of death to children under age 6 by falling into fires and being burned. The adults also suffer as the cooking is done inside small homes with no ventilation. The Rotarians provided \$100 for each stove and each family paid the additional \$25 required to purchase the stoves. The Rotarians installed the stoves. They were able to help 81 families, which is about 750 people. Both Lewis and Smith enthusiastically explained how fulfilling the project was for the Rotarians and how winsome, friendly and appreciative the Guatemalans were. Women gather all the wood, and now with the new efficient stoves they will only need to gather 20% of what they used to need to cook their meals. Don O'Neil invented the stove and the parts

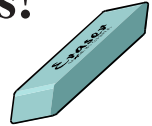
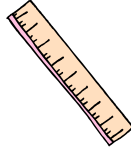

## Albino Crab

Port Orford fisherman Joel Purkey went fishing on Friday and while pulling his crab pots came up a very rare albino Dungeness crab. It was intended for live sale to Norcal Fisheries. The lightly colored crab is currently being kept alive in his own fish tank by Norcal while Purkey decides what to do with it. Vicky Nowlin, manager of Norcal Fisheries, said

there were three albino crabs caught in Oregon during the Oregon Dungeness Crab season which ends on August 15. This out of approximately 14 million crabs landed. The Oregon Coast Aquarium has an albino crab on display that shares a 5,000 square foot aquarium with a variety of other crabs. There have been 899,841 pounds of crab landed in Port Orford this season. Total for the state this year is 27,412,316 which makes it the second best in history.

It may be, though we didn’t actually see all that many gas pumps, but then it was dark when we arrived. Their web site says they have 16 “fueling islands” and makes no claim to be the largest. That claim, however, is made on some other sites. To confuse matters further, Little America Hotels & Resorts now owns properties in several locations in various states and some of them are also named “Little America”. Fortunately, they also have many, many motel rooms so we were able to check in, have a bite to eat and crash.

#### **2006-05-16 Tuesday**

Tuesday came, and with it another newspaper to typeset.
