### Services Set for Howard Lichtig By Evan Kramer

A memorial service for Judge Howard Lichtig will be held this Friday, October 6, at 1:30pm at the Port Orford Community Building. He died as a result of a motorcycle accident on Interstate 5 near Cottage Grove on Thursday afternoon. He was heading up to a judicial conference in Bend on his Harley Davidson when a truck moving over into the left lane forced him out of that lane and into the guard rail.

Lichtig practiced law in Port Orford for sixteen years before being appointed to the Circuit Court in May of this year by Governor Ted Kulongoski to replace Judge Hugh Downer. Before that Lichtig practiced law in the East Bay area in California and was a juvenile court judge. He served as the Port Orford municipal judge for several years but resigned when he was appointed to the Circuit Court.

Howard Lichtig was a very well liked person in Port Orford where he practiced law and Langlois where he lived. When he was appointed to the Circuit Court it was the culmination of a 30 year plus law career for him. Not only was it exciting for him but also for his many friends and acquaintances in the north Curry County community. We were as thrilled as he

was that he had become the Circuit Court Judge. And now we're shocked and saddened at the loss of this wonderful and very empathetic human being.

There were many sides to Howard Lichtig besides the law. He and his wife Flo have big hearts and love dogs. There are nine of them currently and each one has its own story of how it came to live in the Lichtig household. One day while talking with Howard out by Highway 101 a stray dog came running by us. I watched as it ran out in the street but not Howard. He took off in swift pursuit of the errant dog in an effort to save it from itself. I don't know if he ended up adopting that one or not, but over the years Howard and Flo welcomed many dogs into their home. Howard's favorite dogs were his poodles which he got from a rescue shelter.

Howard was the pack master and den leader for our local Cub Scout Pack 98 the past ten years. He enjoyed being part of the Cub Scouts and served as pack master for about ten years in California also.

Howard and several of his friends got together monthly for many years where they played poker for penny ante stakes. The purpose wasn't to beat the other guy out of any large sum of money but to

enjoy each other's company, tell jokes and relax and enjoy life.

Howard served in the US Navy for four years and later on took up flying and got his pilot's license. He took Valerie and I for our one airplane flight over Curry County many years ago and it was something seeing our house from the air. He enjoyed working with his hands and was good at carpentry, plumbing and electrical work. Speaking of working with his hands, Howard was also quite good at magic and sleight-of-hand.

Howard had filed for a full six year term on the Circuit Court which represents Curry and Coos County in August. He was the only person to file for the November ballot for the position. According to Curry County Clerk Rene Kolen by state law Howard's name will remain on the ballot but be struck through. It is too late for anyone else to get their name on the ballot so the position will be decided by write in votes, rather than an appointment from the governor.

People wanting to do something in memory of Howard Lichtig are asked to give a donation to their local animal shelter; or they can make a donation to the ALS (Lou Gehrig's disease) Society in the name of Howard and William Lichtig.

**Herzog Fights for Reductions

The Coos-Curry Electric Board of Directors met on Friday, September 30 with all six board members present. The meeting began with comments and questions from the public. The board was asked about the outsourcing of the billings and mailings (Sterling Bank Portland), emergency calls (Minnesota) and hiring a lawyer from Portland. They were told the importance of keeping jobs locally for the benefit they have on our economy and to weigh the benefit of supporting the local community. Board president Daryl Robison said these is-

suues will be looked at during the ongoing budget process which culminates on November 13.

Karen Jensen asked if the board has access to the employee's personnel files and Robison told her no.

Lou Mincer asked about progress on reducing electric rates and Robison referred to the ongoing budget process finishing up by November 13. He said all the analysis would be done by then and that the board needed to know the impact of reducing rates. The budget process will be quite intense.

Chief Financial Officer Doyle Eden gave the Form 7 financial report. The company's margin through August 31 of this year is \$2,293,000 on revenue of \$18,974,000. Revenue fell far short of budgeted for the month of August at \$2,107,000 while \$2,414,000 was budgeted. The Coop lost \$125,000 in August due to decreased revenue. Eden said the Coop was doing quite well and noted there were other years that weren't as good. He declared the health of the cooperative as good.

Gary Schlottmann spoke under staff reports and said the tree trimmers from Cape Sebastian to Myers Creek were not doing a good job. He said they weren't cleaning it up and had left trees and brush that would present a problem.

Daryl Robison attended the NRECA (National Rural Electric Cooperative Association) meeting in Fairbanks. He was the only board member to attend. Many things were discussed including the difference between an investor owned and member owned electric cooperative. The goal for investor owned coops is to maximize profits. Robison said the board needed to do a better job communicating with the members. He said costs of power will go up in 2011. He spoke of the need for a balance between the environment and rates. Other things discussed at the meeting included support for renewable sources of power, technical and engineering standards, the Energy Star program, and involvement with economic progress. He said that 24% of the members of coops will pay more for Green Power. 454 people participated in

the conference which Robison described as worthwhile.

Board member Pete Radabaugh attended the NWPPA-BPA (Northwest Public Power Association - Bonneville Power Administration) allocation conference. He said by April 2008 the Cooperative will need to sign its 20 year contract for power and that the board needs to figure out by then which way they will go.

The Board is working on bringing someone in to provide education for the new members rather than have them attend training out of the area. They are working on a timeframe and cost for classes.

Board member John Herzog spoke under new business and said we should address what the public said about rates. He said he wanted to give something back to the members. He recommended giving them 200 free kilowatt hours a month. David Itzen told Herzog that the board needed to run an orderly meeting and that his issue was not on the agenda. Herzog said he was tired of being orderly. General Manager Werner Buehler said they were working on lowering the rates. Daryl Robison said he couldn't support Herzog's idea until after the board goes through the budget process. Gary Schlottmann said the board would have an answer to the members by November. Buehler told people not to assume the Coop would lower rates. Herzog summed up his feelings by saying "process schmosess" frustrated by his attempts to lower the owner-members rates.

200 free kilowatts a month would represent a savings of \$12.60 to the residential consumer. The Coop pays about half that or 3¢ per kilowatt hour for electricity.

### Letter to the Editor,

I am writing to express my shock and dismay at the unanimous passing of City of Port Orford Ordinance 2007-05 at the Monday, September 18, City Council

meeting. My very serious concerns and disappointment are from two points of view; one as a Port Orford Planning Commissioner and the other as a private citizen.

As a Planning Commissioner, I feel strongly that this proposed Ordinance should have been presented to the Planning Commission first, so that public hearings could have been held before the Planning Commission. Then, after hearing citizen input and Commissioner discussions, the recommendations from the Planning Commission should have been sent to the City Council for action.

As a private citizen, I am outraged that the City Administrator and City Council would take it upon themselves to take action, without citizen input, that effectively shuts down two successful businesses in town that cater to the working people of Port Orford, as well as those of us who have retired here and enjoy supporting all businesses, including the very efficient, clean, and economical "transient business" of Doc's Taco's and The Big Dog. The two transient business in town serve a much needed service of local fast food at reasonable prices, which I believe complement our local restaurants, rather than hurting them.

I can only hope that this "pushed through" ordinance 2007-05 will be reversed, and quickly. The groundswell of Port Orford citizen outrage demands it!

## Book Signing Sunday

This Sunday, October 8, at 2pm, Brookings resident and Oscar award winner Elmo Williams will sign copies of his new book *Elmo Williams, A Hollywood Memoir*.

In 1954, Williams won the Academy of Motion Picture Arts and Sciences Award (the Oscar) for editing the classic film, *High Noon*. He also produced and directed many other enduring movies, including *Tora! Tora! Tora!*, *The Poseidon Adventure*, *20,000 Leagues Under the Sea*, for which he received another Oscar nomination, and *The Longest Day*.

"Fate has thrown me some interesting curves," said Williams, the farm boy turned film editor, director and producer. As a child, Williams traveled with his family in a covered wagon to a new life in a New Mexico homestead. In 1932, the teenaged Williams went to work as a gopher for film editor Merrill White and within three years he was a partner in an editing company in London. Williams' career bloomed to include also producing and directing.

His new memoir covers early childhood through his years working behind the

scenes with fellow Hollywood movie legends to his pensive reflections at age 93. The publisher calls it "a story of hard work rewarded with a deeply fulfilled life, and of one man's effort to communicate with others in the universal language of film — and of laughter."

In addition to his new Memoir, Williams will also be signing copies of his late wife Lorraine's collection of holiday let-

### Internet Project Update

R. Scotty Auble, president of CurryISP, Inc., announced today that the company has been disqualified for a grant from the USDA Community Connect Project for this funding year.

“This is a setback in immediate opportunities to fund the project”, said Auble. “We don’t have any other funding options on the table at this time, but are actively seeking alternative sources in both the public and private sectors.”

Auble said the USDA disqualified the grant application based on a technicality. He said the USDA encouraged CurryISP, Inc. to apply again next May, provided the program receives funding from Congress again.

Another board member for the company said, “This community needs a reliable high speed internet option and we are still unable to locate other providers willing to commit to a timeframe. In a recent newspaper article, a contractor working for Verizon said they may offer DSL here in a year or two, however this is still unconfirmed.”

According to Auble, much valuable work that can still be used in the project was done in preparing the USDA grant application, including a detailed network design, project budget estimates, and work timetables. This work, as well as the community partnerships that were developed, will ease the process of applying for other funding.

“In completing the application we developed a detailed business plan that shows the feasibility and sustainability of our business model. We can show other prospective funders and partners that this is

a viable project as a result of our efforts,” said Auble.

The company also announced that so far it has been unable to obtain 501c(3) tax-exempt status from the IRS. Because of this, donations to CurryISP, Inc. cannot be deducted as charitable contributions on federal or state income tax for 2006. The company apologizes to donors that were counting on a deduction, and is offering to refund donations upon request until December 31, 2006. All donations received will be used to implement the high-speed internet project when the necessary funds have been obtained.

## Port News Updates

There were several good pieces of news concerning the Port, Dock and Commercial fishing industry last week.

An ad hoc committee was formed on Friday, September 28 to undertake a "jetty study" that will build a fact based timeline of the jetty's actual performance. Has it really been helpful, or was the design flawed? A group of volunteers have begun sorting through old files to isolate key documents and will present updates to the Port Commission.

Scoping consultant Elizabeth Sheehan, and Director of Financial Consulting for Shoreline Enterprise Pacific, Adam Zimmerman, were in town to conduct studies for a possible Marine Research Station at the Port. There were meetings with Leesa Cobb and Valerie Mecum of the Port Orford Ocean Resource Team (Poort) and other local leaders and officials. A reception was held on Thursday evening

at the Poort office in TriAngle Sq. where a number of citizens and commercial fishermen brainstormed economic improvement ideas for the Port and dined on a buffet of fresh seafood.

At the League of Women Voters candidates debate, all four candidates running for city council identified the Port and Dock as the city's most valuable resource and that the city must work closely with the Port in developing the Refinement Plan.

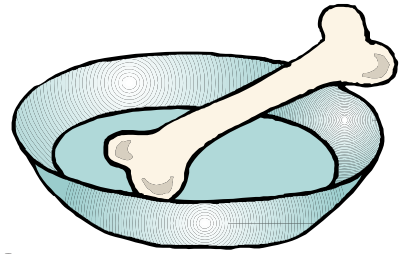

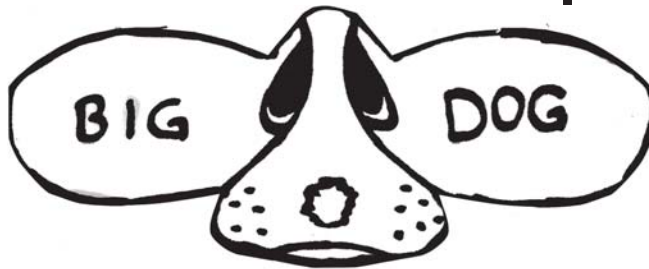

## Emergency Response Training

The Citizens Emergency Response Team (CERT) Coordinator, John Woodland, announced that a free training for citizens will be offered on Saturdays, Nov. 11 and 18 from 9:00-5:00 at the Curry County Emergency Operations Center in Gold Beach. Participants must pre-register and be present both days.

Following a "major disaster" in Curry County people will have to rely on each other for help in order to meet their immediate life saving and life sustaining needs. First responders who provide fire and medical services will not be able to meet the demand for services. Factors such as number of victims, communication failures, and road blockages will prevent people from accessing emergency services they have come to expect at a moment's notice through 911.

The CERT training to be covered on Nov. 11 includes Disaster Preparedness, Fire Safety, and Disaster Medical Operations Parts 1 & 2. Nov. 18 training will be Light Search & Rescue, CERT Organization, Disaster Psychology, Terrorism & CERT, and Course Review & Disaster Simulation.

CERT is about readiness, people helping people, rescuer safety, and doing the greatest good for the greatest number. CERT is a positive and realistic approach to emergency and disaster situations where citizens will be initially on their own and their actions can make a difference.

Through training, citizens can manage utilities and put out small fires; treat the three killers by opening airways, controlling bleeding, and treating for shock; provide basic medical aid; search for and rescue victims safely; and organize themselves and spontaneous volunteers to be effective.
