Council Listens to Public By Evan Kramer

The Port Orford City Council met in special session on Wednesday, October 18, for the stated purpose of approving Ordinance 2007-06, repealing Ordinance 2007-05 (relating to transient food businesses).

Councilor Steve Abbott said he would have a hard time voting tonight as the council wasn't following the rules. He said an Ordinance needs to be read at one meeting and then a second time at a second meeting before being voted on. Mayor Jim Auburn told him this was an emergency situation because of the Land Use Board of Appeals suit against the city by Pat and Jackie Eldridge regarding Ordinance 2007-05. Auburn said it was in the best interests of the council to repeal Ordinance 2007-05. The gist of the conversation was two wrongs make a right.

The council voted on two versions of Ordinance 2007-06. The first one they voted on would repeal the amendment to Ordinance 2007-05 and it would take effect immediately because the findings of fact provided the situation was an emergency. The vote on the motion by Councilor Jim Campbell was unusual. Councilors Abbott and Ed Beck ab-

stained; Councilors Milton Finch and Jerry Steinhorst voted no, and Councilors Carl Eskelson and Jim Campbell voted yes. The motion failed.

Councilor Campbell made a motion to approve Ordinance 2007-06 but this version did not contain the emergency clause. Councilor Abbott said the council should pass Ordinances after they are properly posted. He objected to the process and said he would abstain. The meeting notice was properly posted but there were no copies available to the public or press of the two Ordinances being voted on. The vote on this motion was close as initially Abbott and Steinhorst abstained; Milton Finch voted no, and councilors Ed Beck, Jim Campbell and Carl Eskelson voted yes. Mayor Auburn applied a bit of pressure to the two abstainers to vote yes or no. Jerry Steinhorst voted yes and the motion passed 4-1-1. This Ordinance does not go into effect for thirty days.

Jim Campbell then made a motion that the city not enforce Ordinance 2007-05 until Ordinance 2007-06 goes into effect in 30 days. The vote was a unanimous 6-0.

Fall Election

The ballots have been mailed for the November 7 election as well as the Vot-

ers Pamphlets. Now it's time to sit down and decide which way to vote on the many ballot measures and candidates.

There is a different sort of election going on for the Judge of the Circuit Court, Fifteenth District. Howard Lichtig had been appointed by Governor Kulongoski in May to fill out the Circuit Court position being vacated with the retirement of Judge Hugh Downer. Circuit Court Judges are elected to six year terms of office. Judge Lichtig had filed for a six year term and was the only candidate for the position on the November 7 ballot. He was killed in a motorcycle accident on September 28. Because of the timing so close to the election his name remained on the ballot but has been marked out.

The option for Curry and Coos County voters now is to vote for a write-in candidate for judge. First you have to connect the two arrows on the right side of the ballot with a number 2 pencil and then to the left of the arrows write in the name of a person to be judge for the next six years. According to Curry County Clerk Rene Kolen voter "intent" is what matters so if you misspell either name but your intent is clear then that person will get the vote.

There are two people running active campaigns for this judicial position. They are Jesse Margolis and Chris Keusink, both attorneys practicing in Curry County. They weren't nominated by anyone but chose to run. The Curry County Bar Association took a preference poll of its members and voted by a 17-3 margin to support Margolis for the position. On Monday, October 23, the Coos County Bar Association released the results of the secret ballot preference poll they conducted. They voted by a 54-22 margin to support Jesse Margolis for the position.

Qualifications to become seated as Circuit Court Judge include being a resident of Oregon the previous three years to election or appointment, and the person's residence or principal office must be in the judicial district they will serve in, plus they must be a member of the Oregon Bar Association at the time of their election or appointment. There are six Circuit Court positions in the Fifteenth Judicial District which covers Coos

and Curry Counties. Two of those positions must be filled by people from Curry County.

The winner of the election will be the person with the most write-in votes. There will be another opening on the Circuit Court Fifteenth Judicial District when Judge Richard Michelson retires early next year. That vacancy will be filled with an appointment by the next governor of Oregon, be it Ted Kulongoski or Ron Saxton.

Port Selects Dowdy by Jay Stoler

The Port of Port Orford met on Tuesday, October 17 at City Hall for their regular monthly meeting. There were about a dozen interested citizens in the audience and all the Commissioners, except President Scott Luhr were present. Vice-president Bob Milenz chaired the meeting.

The highlight of the meeting was the appointment of Ed Dowdy to replace John Mobley who resigned in September. There had been three applicants for the Commissioner position. They were from Scott Mecum, John Thomas and former Port Commissioner Ed Dowdy. Before the decision was made, Mecum withdrew his name from the list, leaving Dowdy and Thomas as the only candidates. Thomas was not in the audience but Ed Dowdy was.

The Commissioners asked Dowdy to answer some questions and talk about his background, which includes a long list of prestigious credits as a high ranking government employee and consultant, professor and former Port Commissioner for about five years. Dowdy has been instrumental in helping to write grants and problem solve for the Port, and has been volunteering his help all along. He expressed his familiarity with all the major issues and his desire and commitment to be a steward of progress for the Port.

The Commissioners then selected Ed Dowdy, he took the oath of office and joined the Commission on the panel for the rest of the meeting as an official member, again.

In other Port news:

- The Commission passed a revised version of the random drug testing policy for safety sensitive positions only. The policy will go into effect in 60 days and will be administered by a third-party, Bio-Tech.
- The Commission discussed the request to raise the weight limit on the big hoist to 39,000 pounds with a loaded vessel. Manager Gary Anderson said he had done a study and said the hoist life may be reduced by almost five years if consistently heavy vessels were lifted. There were other points of view that the Port should be kept a small boat dock, while others saw the market moving toward the larger vessels and wanted the Port to accommodate them. Veteran fishermen Mike "Cappy" Ashdown and Chris Aiello contributed to much of the conversation. Another consideration was a contingency plan in case the hoists became inoperable. Commissioner Dowdy called for a contingency plan and no further action was taken.
- Planning Commissioner Dave Holman addressed the Commission as the new "informal" liaison between the Planning Commission and the Port. Holman ex-

plained that the Planning Commission will be making some ordinances concerning the Refinement Plan and wanted to invite the Port Commission to hold a joint meeting to continue to stay on the same page with the Planning Commission. Port Commissioner Evan Kramer said he would be informal liaison with the Planning Commission and will attend their meetings. Holman was also commended by the Commission for his volunteer help in an on-going jetty research project at the Port, and for volunteering his engineering skills to look into another problem on the dock.

- Gary Anderson announced that the dredge Nehalem will be dredging the Port in mid-November. Several fishermen and Commissioners expressed frustration with the 7000 yard dumping limit over the jetty and vowed to continue to find new and creative ways to handle the business-threatening shoaling problems themselves.

The regular Port meeting is on the third Tuesday on the month in Council Chambers at City Hall at 7:00 pm. The public is encouraged to attend.

Candidates Show Unity by Jay Stoler

The Port Orford and North Curry Chamber of Commerce presented the final Candidates Debate and Ice Cream social last Thursday in City Hall. There were nearly 30 citizens in attendance including Mayor Auburn and Councilors Steve Abbott and Carl Eskelson.

Five of the candidates were present. John Hewitt, Jodi Bulaich, Jake Marshall, David Smith and Pat Buffington. All except Buffington were at the League of Women Voters Forum earlier in the month. Councilor Jim Campbell declined to attend as well as candidate Gerri Creighton.

The candidates were "grilled" for over 75 minutes and showed an amazing amount of unity on major issues including the water, public works, safety and the Port.

When asked if the administrative structure of the city should revert to having the Police Department be under the administrative supervision of the City Administrator, all candidates voiced similar opinions.

While all of the candidates expressed that the Chief was personally doing a good job, there were questions about the structure and size of the department.

John Hewitt said the Chief had a three-year contract but he would open to reviewing it. Both David Smith and Jake Marshall said that the structure had been changed because of a conflict with a former Administrator, but should be looked at being changed back. Jodi Bulaich said that Port Orford had an extremely high ratio of police to citizens and wanted to examine that if elected. Pat Buffington said she didn't have any specific problem with the department but would want to look at the structure.

All candidates agreed that a strong relationship with the Port was vital to economic success and development of the town. All thought tourism was important and wanted to see the town look good.

The candidates were united on the water issue and all said it had to be top priority to find and fix the leaks and be accountable for the missing water. Most agreed a new water system was the ultimate answer and would work toward that if elected.

On the issue of public works, the candidates wanted to see that department get the help it needed to be able to provide adequate service and find and fix the leaks.

After the formal questions the candidates mingled with the audience and answered a few more questions. The event ended about 8:45pm.

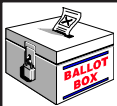
Donations of non-perishable foods and fresh produce are also needed at this time in our pantry area (same hours as above).

Weed Control

The Curry Weed Advisory Board is pleased to announce the availability of cost-share dollars for noxious weed control in the Sixes Watershed. Landowners can complete a short application that describes the problem and proposed solution for a weed management project on their property. Weeds to be managed must appear on the Curry County Weed List. The program includes cost share of up to 75% for weed management plans, and up to 50% for on-the-ground weed management projects. A maximum grant amount of \$500 per landowner per year is in place and funding is limited.

The Curry Soil and Water Conservation District acts as the Curry Weed Advisory Board and has been working on building a program that includes education, assessment, and noxious weed management. "The Sixes River Watershed includes all lands that drain to the Sixes River. Landowners and land managers have worked together over the last year to form the Sixes Weed Management Area and to write overall management goals. Targeted weeds are Japanese knotweed, Gorse, and Brooms, all of which are decreasing the productivity of the land and rivers in the basin," says Dana Hicks of the Curry Soil and Water Conservation District.

The Mystery of the Disappearing Grosbeaks

The Evening Grosbeak is an enigma. Many people who used to see these raucous birds descend on their feeders in large numbers now report that they haven't spotted one in years. Reports from volunteers who count the birds at their feeders as part of Project FeederWatch, a bird-monitoring program coordinated by the Cornell Lab of Ornithology and Bird Studies Canada, show that grosbeaks are indeed declining. In fact, grosbeaks are completely missing from many areas where they were common as recently as the early 1990s.

Questions about Evening Grosbeaks began more than a century ago when these birds rapidly expanded their range from western North America to include many areas in the East. The range expansion brought these gluttons to feeders all across the northern half of the

continent by the 1950s. Noisy flocks would routinely visit backyard bird feeders and devour sunflower seeds. Grosbeaks were one of the most common species reported to Project FeederWatch when the program began in 1987. Now, nearly 20 years later, Evening Grosbeaks have fallen off of the list of most common feeder birds in most regions.

The Evening Grosbeak is a yellow, black, and white finch with a bill that appears too big for its body. Its winter range typically covers the entire northern half the United States and it is found year-round in many western states and southern Canada. Evening Grosbeaks are an irruptive species, meaning their migration is irregular, linked to the availability of food. They may be abundant in an area one year and nearly nonexistent the next.

However, the long-term trend shows that these irruptions have almost ceased in many areas of the East, and declines have been documented in their core western range as well.

The reasons for the decline are unclear are the birds dying, are they failing to reproduce, or are they simply moving elsewhere? Scientists are not sure, but bird watchers may help unravel the mystery by counting birds at their own feeders and submitting information to Project FeederWatch. Participants report all of the birds seen, so researchers can learn where grosbeaks are found, as well as where they are missing. Participants may submit reports as often as once per week from November to April. Everyone is invited to participate.

The more eyes looking out for grosbeaks and other birds, the better! Anyone interested in signing up for Project FeederWatch in the United States can do so online at www.birds.cornell.edu/pfw or call the Lab toll-free at (800) 843-2473. In Canada, contact Bird Studies Canada at (888) 448-2473. For the \$15 participation fee (\$35 Canadian), participants receive the FeederWatcher's Handbook, a poster of the most common feeder birds, a subscription to the Lab's newsletter, BirdScope, instructions, a calendar, and the FeederWatch report, Winter Bird Highlights.

Letter to the Editor,

The reasons not to vote for Saxton can be justified just from a few simple facts.

Ron Saxton will re-organize Oregon state government and not raise taxes. This will require cutting the public services supporting the state's infrastructure, from public schools, to the Oregon health plan, to state assistance for the elderly, to road, highway and bridge maintenance. But much more.

Saxton wants to give away the state to corporate interests and Ted Kulongoski supports the state and the broad range of the public's interests with prudent, knowledgeable and fair determinations.

A vote for Saxton and Feldkamp is a vote for Bush—his failed economic and foreign policies. Don't vote for Bush again!
