### **Governor on the Economy**

Oregon Governor Ted Kulongoski outlined a plan to rebalance Oregon's state budget after the State Economist reported a more than half-billion dollar shortfall for the current 2009-11 biennium on May 25.

"This decline is significant and immediate action is required to keep the budget in balance," said Governor Ted Kulongoski. "On one hand it is surprising, while on the other hand, I have consistently cautioned that we could see continuing declines in state revenues even as the economy begins to recover – and that we should be better prepared to deal with such declines. Today, unfortunately, the reasons for my cautions were confirmed."

As provided under ORS 291.261, the Governor announced his plans to take action by exercising the allotment authority to reduce state agency spending for public services by approximately \$560 million to rebalance the budget in alignment with today's forecast.

As required by state law, this reduction will be equally distributed among state agency budgets and schools. At this time, the Department of Administrative Services is estimating the reduction will equate to about 9.0 percent of each agency's budget for the remaining 12 months of the biennium.

"We could gamble and hope that the next forecast in September delivers a rebound and the hole is diminished, but the longer we wait, the deeper the cuts that will be needed to rebalance the budget in the remaining months of the biennium if that does not occur," the Governor said. "Throughout my tenure as Governor where I have managed the state through two devastating recessions, I have learned – and am convinced – that in a situation like this, that the best response is swift and decisive action."

That is why the Governor today directed state agencies to develop plans to implement the cuts needed to rebalance the budget for the remainder of this biennium.

Agencies are instructed to report back in two weeks with their reduction list. The Governor is also directing state agencies to meet with their union representatives to explore alternatives to layoffs.

The Governor also announced the following personnel actions to be effective immediately, including:

Extending the salary freeze for executive service, management and unrepresented employees through June 2011, the end of the current biennium. This action will save the state \$7.9 million in general fund.

Requesting public employee unions meet with the state to discuss extending the salary freeze to all represented employees, which would deliver a total savings of \$12 million in general fund.

Asking the Public Employees Benefits Board (PEBB) to explore benefit changes to keep cost increases to 5% for the next plan year, as opposed to the nearly 10% increase as currently projected. Achieving this cost containment goal could save approximately \$30 million

in total state funds in the next plan year, which begins in January 2011.

"I am not taking these actions lightly, nor am I implying that state employees are in any way to blame for our circumstances. To the contrary, they have helped us weather a terrible economic storm," said the Governor. "We owe them our respect and our gratitude. I am simply recognizing that difficult times demand difficult actions. And when times get even more difficult, as they just did today, I am asking again for their understanding and their cooperation."

The Governor closed the press conference with another call for resetting state government. In acknowledging that there is the potential for additional one-time assistance from the federal government for health care and education, the Governor cautioned again that the state can no longer rely upon short-term solutions for what is a long-term problem and must end the practice of only budgeting in two-year increments.

“When my Reset Cabinet comes back next month with a menu of options for state government, we will be faced with some difficult choices, unpopular choices and controversial choices,” said the Governor. “But they will be the right choices if we want to end this up-and-down, invest-and-cut pattern of the last 20 years.”

Note: This budget forecast and the effects of it will seriously impact the budget for the Port Orford-Langlois School District for the budget year 2010-11. See the May 5 edition of this paper for a report with the recommended cuts in order to balance the 2010-11 school district budget.

The reason given was to make the project more “esthetically pleasing for the developer” (according to the project’s designer).

I am against the way this City Council has handled this whole ordeal. This "Project" as everyone refers to, should have gone back to the Planning Commission the minute that the plans were changed, but no, December 18th of 2008 at the last Council meeting of the year, four City Councilors took it upon themselves to issue a Right of Way Permit, so that the plans did not have to go to the Planning Commission. John Hewitt, who at the time had a business in the old building, did not declare a conflict of interest, which by the way is part of the Real Rules, and he seconded the motion to issue a ROW permit to allow the Hawthorns to go forward with the new plans. I can tell you all, the original ROW permit did not have any drawings attached to it, let alone let the Public in on what was transpiring. I know this because I was on the Council at that time, and I did get the packet of what was going on at that meeting. So from the beginning, the Public was not made aware of what was going on with Public Property at Battle Rock until after it happened. Thus, the outrage from the Public, as to what is really going on. All of this has made the current Council look very shady as to what they have passed, for this "Project".

When I quoted the City Ordinance for the MU Zone, I was trying to make a point that the "Project" was not conforming to the Ordinance as far as the Parking goes. James "Jim" Rhoades, age 81, of Port Orford, died May 29 in Coos Bay. The son of Ellsworth and Lucille Rhoades, Jim was born and grew up in Lee's Summit, Missouri, where he attended elementary and high school. After graduation, he enrolled at Park College, Parkville, Missouri, where he met Pat Phillips, who later became his wife of over 58 years.

In 1949 Jim joined the Missouri State Highway Patrol. He was assigned to Maryville, Mo, until his induction into the U.S. Army in 1950 during the Korean conflict. Following this service he returned to Maryville, where he was stationed until he was promoted and transferred to St. Joseph in 1961, where he served as Criminal Investigator for the Troop H area. During this time he

Our non-profit organization's mission is to provide resources to the at-risk Curry County community family members striving for positive and successful lives. With our Family Support and Connections program, we offer a family advocate that connects families to local resources and referrals. The agency's advocate also provides to Curry County parents a twelve week evidence based educational parenting class. This educational class helps parents in many ways to reduce stress, anger management, develop crisis plans and build family support networks without violence. We provide the parents with a snack or meal and child care as needed at class site. We reached 78 families last year who continue in the advocate's service programs; of these families over half completed the parenting class. We are now teaching two classes each week serving over twenty new families with hopes to reach many more in the upcoming class sessions this year.

Families receiving food stamps can only use them for food items; therefore our agency has developed a non-food pantry to help families get through on limited funds. We are asking for your support, any donation would be helpful. The pantry list of items that we strive to keep stocked are: feminine hygiene products, dish soap, diapers (all sizes), bath soap, shampoo, deodorant, laundry soap, household cleaning products, toilet paper, Neosporin, tooth paste and tooth brushes. All items may be dropped off at the Gold Beach office Monday thru Thursday from 9:30 to 3:30 or in Brookings on Wednesday's only at the Hanscam Center before 12 noon.

We hope you will give some consideration to assist these programs with a kind donation.

## Corps Stresses Safety

The U.S. Army Corps of Engineers reminds visitors to the coast that jetties were not constructed for recreation purposes and that they should avoid fishing from, and walking, driving or climbing on these structures because of the potential hazards.

Additional work has been performed on the jetties to strengthen them. Despite these moves to prolong their life and usefulness, the structures are not immune to the effects of nature. Waves can remove even the largest boulders from jetties, and underwater currents - which penetrate the structure - remove smaller rocks and sand from inside the jetty. This creates visible and hidden dangers.

Open crevasses between large boulders create stepping hazards. Sinkholes, caused by drifting sand pushed up against the jetty being eroded by moving water inside the structure, can give way unexpectedly. Caverns within the structure, caused by the erosion of stones and sand, could be hidden below a thin surface and suddenly collapse. Sea spray causes rock surfaces to become slippery. Sudden larger waves, even in calm weather, can knock a person off balance or into the water. Waves and strong currents near the jetty can prevent safe recovery after a fall into the water.

The Corps manages more than 30 jetties and breakwaters along the entire length of the Oregon coast, from Astoria, south to Brookings. Construction of the jetties began more than 100 years ago to help mariners navigate between the Pacific Ocean and coastal ports, and were never intended for recreational purposes. For this reason, jetties should be admired for their complexity and contributions to the region from a distance.

**Free Fishing Weekend**

Elk River Fish Hatchery will host the 15th annual Free Fishing Weekend event on Saturday and Sunday, June 12 and 13. Each fishing day will begin at about 8:00am. Young anglers will be allowed to fish for rainbow trout in a special hatchery pond that is stocked with 800 legal size fish (8-12 inches) and 400 whoppers that will weigh from 3-8 pounds each. The hatchery will provide rods, reels, bait and tackle for the kids to

fish with. The bag limit is the first three fish caught. There will be no “catch and release”, so please bring a large plastic bag to carry your catch home.

The event is limited to the first 100 children 10 years old and younger that sign up in person on each day (100 for Saturday and 100 for Sunday). Sign ups will not be carried over from one day to the next. Upon sign-up, participants will be advised of the approximate time when it will be their turn to fish. To provide a more quality fishing experience we will only fish two kids at a time. Each young angler will be welcome to fish on one day only (either Saturday or Sunday, but not both). The event will be held rain or shine, so be ready for the weather. Each child on the sign up sheet will receive a free starter kit (hooks, sinkers, lure and bobber). ### Chinook and Coho seasons

According to a report by the Oregon Department of Fish and Wildlife the number of fall chinook expected to return to many of Oregon's coastal rivers is expected to improve in 2010; however some steams on the North Coast are expected to be below escapement goals. In response, the Commission will be asked to adopt coastal fall chinook regulations that include lower bag limits and area closures on North Coast Rivers from the Necanicum River south to the Yaquina River. Forecasts are for average or better than average chinook returns to south coast rivers; the Commission will consider minor adjustments to permanent regulations for rivers from the Alsea south to the California border.

While the 2010 coho salmon return will not be as large as the 2009 return, it is healthy enough that ODFW biologists are recommending wild coho fisheries on the Siletz and Coquille rivers and Tenmile Lakes. Because coastal coho are listed as threatened under the federal Endangered Species Act, these fisheries must also be approved by NOAA.

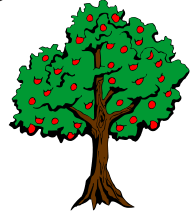

**Oregon Economic Forecast**

The first quarter of 2010 marks the first positive quarterly job growth since the first quarter of 2008. We are hesitant to conclude that this is the turning point we have all been waiting for. Given this is an initial estimate of jobs and a seasonally adjusted measurement, we believe this latest quarter is further evidence of bottoming out of the

recession as it relates to the job market. Hopefully as we move ahead thru 2010, the quarters will continue to show positive job growth.

The year-over-year (Y/Y) employment decline for the first quarter is 3.0 percent. The Y/Y decline has not been below 5.0 percent since the fourth quarter of 2008.

The unemployment rate for Oregon sits at 10.6 percent for April, essentially unchanged for the past six months. The unemployment rate tends to be one of the last measurements to improve as the economy enters recovery.

Almost all service sectors reported seasonally adjusted job growth in the first quarter of 2010. Financial services still posted a slight decline, possibly remnants from the housing and financial declines during the recession. Construction continued with double-digit declines that stretch back to the first quarter of 2008. Manufacturing still struggled with only metals and machinery and other durable goods showing job increases. Government added jobs boosted by Census workers at the federal level.

One year ago in this section, we wrote about signs that the recession may be coming to an end. With GDP moving to positive territory, the general consensus is that the recession is over. Analysts are now scouring the data looking for signs of the strengths and weaknesses of this recovery. Will the recovery be robust or lackluster?

The consensus is still holding to a soft-patch as the inventory replenishment and stimulus spending start to fade in 2010. Although business is feeling much better about the economy, The University of Michigan consumer sentiment survey declined in April and is at its lowest point since November 2009. Although retail sales have seen a strong increase in March, analysts worry about the consumer’s state of mind and their willingness and ability to

increase spending. With no one sector to jump start a robust recovery, the outlook is for the recovery to continue but at a slow pace.

Oregon mirrors the U.S. economy in questions about the strength of recovery. Although data is not as detailed as for the U.S., it is just as easy to find signs of either a robust or lackluster recovery. The Oregon Index of Leading Indicators is showing very strong signals in the last few months, though we caution that the index should be used to identify turning points rather than gauge the strength or weakness of the Oregon economy. The University of Oregon Index of Economic Indicators is showing a similar strong rise over the last 5 months. The Philadelphia Federal Reserve Bank State Coincidence Indicator for Oregon has also turned up and among the 50 states, Oregon ranks 6th in terms of indicator growth year-over-year for March.

The unemployment rate in Oregon for April is still above 10 percent and has been there for the last fifteen months. This is not unusual as unemployment tends to be a lagging indicator of economic activity. Average weekly hours in manufacturing have risen but are still well below levels associated with an expanding economy. Housing permits are considerably higher than a year ago but the level is still reminiscent of recession periods. Housing prices continue to fall albeit at much lower rates. And although the job numbers were positive in this first quarter of 2010, there is still considerable weakness in several labor sectors.

The good news is consensus that the recession, in the U.S. and Oregon, is over. The cloudy news is the strength of this recovery and the prospects for the job market.
