### The end of the Calendar?

### Redfish Rocks Marine Reserve

Oregon's first marine reserves sites will be dedicated in January 2012, marking the culmination of more than a decade of strong local effort by communities, state government, and commercial fishermen, to create protections for Oregon's ocean. The two sites, Redfish Rocks near Port Orford, and Otter Rock, just north of Newport, earned strong support from commercial fishermen who promoted the concept of habitat protection through a marine reserve system.

"We are proud of Port Orford's leadership and support of our marine reserves" said Port Orford's mayor Auburn and charter member of the Redfish Rocks Community Team, a stewardship group. "The Redfish Rocks Marine Reserve and Marine Protected Area give us an opportunity to learn more about our ocean resources and sustainability. Ultimately, these reserves will act as ecological savings accounts to help our commercial and recreational fisheries and provide greater benefits for our ocean and our community for generations to come."

Marine reserves are ecologically important areas that are protected from fishing and disturbance to allow plants

and animals to flourish, and provide opportunities for ecological research. OSU graduate student Tom Calvanese has been working with local fishermen to track the movements of rockfish living in the reserve using acoustic telemetry.

The community of Port Orford has provided significant support for implementing the Redfish Rocks designation through a local community team process. Comprised of a diverse group of stakeholders, the Redfish Rocks Community Team has been assisting the Oregon Department of Fish & Wildlife (ODFW) in developing a management plan for the site.

"The Port Orford Ocean Resource Team has focused our work on the triple bottom line approach. This marine reserve is one piece of a sustainable fishing program, and this community has a high level of interest in the reserve since more than half of the total nearshore fishing permits are owned and fished out of Port Orford." Said Leesa Cobb, ED of the Port Orford Ocean Resource Team.

In addition to Redfish Rocks and Otter Rock, three other sites have been recommended for designation—Cape Falcon, Cape Head and Cape Perpetua.

A fourth site, Cape Arago, is also being considered. The total area of state recommended marine reserves comprise a little more than 3 percent of Oregon's Territorial Sea.

The effort to establish marine reserves began in 2000 during Governor Kitzhaber's administration and continued under Governor Ted Kulongoski's administration. The governors' advisory group on oceans, the Ocean Policy Advisory Council (OPAC), has helped to lead Oregon's marine reserve process along with ODFW. The rules for both Redfish Rocks and Otter Rock, the two initial marine reserve sites established by the State of Oregon in 2009, will go into effect on January 1, 2012 following the completion of baseline studies on biological and socioeconomic resources.

The Red Fish Rocks Community Team has raised enough money to purchase

two buoys and they are now in place. Also coming up soon are on-shore markers for lining up the boundaries of the marine reserve from land. There will also be informational signs at Battle Rock Park and Port Orford Heads State Park.

The Oregon Department of Fish and Wildlife is the responsible state agency for management of the marine reserves. The Oregon State Police have the responsibility of enforcing the laws pertaining to the marine reserve.

### Community Takes Initiative

On December 24, Chris Aiello and Lyle Keeler of the Port Orford Ocean Resource Team, and Tom Calvanese of the Fishtracker Project launched Chris' boat, the F/V J&C, to place buoys marking the westward boundary of the Redfish Rocks Marine Reserve. These

also mark the boundary between the Marine Reserve and the Marine Protected Area. The ODFW rules governing the Marine Reserve and MPA at Redfish Rocks go into effect on January 1, 2012. "We felt it was important for the boundaries to be marked before the rules go into effect," said Lyle Keeler of the PO Ocean Resource Team. "Since crabbing is allowed in the MPA, but not in the Marine Reserve, and crab season is already underway, it was important to make sure the boundary between the two be clearly marked. This is also important for those participating in the live fish fishery, and for sport fishermen."

As of January 1, 2012, deploying of fishing gear (including crab pots) inside the boundaries of the Redfish Rocks Marine Reserve is prohibited, with violators subject to fines. Although bottom fishing is also prohibited within the boundaries of the adjacent Marine Protected Area, crabbing is allowed there - an important distinction.

"As we were placing the marker buoys, we found crab gear belonging to one fisherman who had deployed

pots just inside the reserve boundary", reported Chris Aiello. "We were able to immediately notify the fisherman, who has since relocated his gear, avoiding any potential violation of the rules he might have faced after January 1, so our effort had an immediate practical impact."

"It was great to be part of the marker buoy project," said Tom Calvanese, Oregon State University graduate student. "In order to comply with the new rules, it's important for fishermen to be able to see where the boundaries of the reserve are." Tom is studying the movement behaviors of fishes of Redfish Rocks as part of his thesis research, aka, the Fishtracker Project. Once they completed the task of deploying the marker buoys, the group turned their attention to retrieving data from the Fishtracker acoustic receiver array. They were able to retrieve data from half of the deployed acoustic receivers. The swell was too large that day to safely access the receivers deployed inside the area of rocky pinnacles. "I am always excited to

get out to the research site and retrieve data. The Fishtracker Project has been a great collaborative effort, and Chris and Lyle have both been instrumental in its success from the very beginning," said Calvanese. (see the article this issue about the Fishtracker Project).

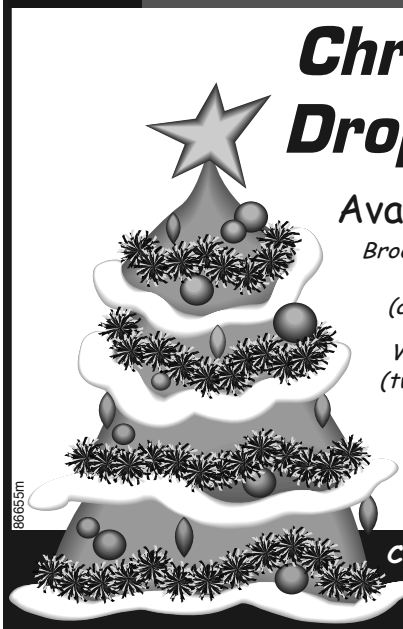

### People Place Signs Lease

On December 7, 2011, the North Curry Families' & Children's Center: The People Place non-profit signed a lease with Curry County as the official tenant of the North Curry Service Center building just south of the library. This momentous occasion completed NCFCC's grueling 7 month negotiation with the county by volunteer Co-Directors Pat Terranova and Jan Bennett who were supported by their Board and their Service Center partners to save this valuable resource for the community. In May, 2011, the Curry County Board of Commissioners indicated they felt they could no longer provide the maintenance support to the Service Center due to the county's financial crisis. Known for years as simply "the blue building," the now-green county-owned building has housed critical state, county and non-profit services for North Curry residents for over 20 years. The successful effort to keep services available for North Curry communities once more reflects the creative gumption and commitment of our area's volunteers.

NCFCC: The People Place has broadened its facilities space and operations

responsibilities to include contracting for and managing the partners' Resource Sharing Agreement which funds the operation of the building. In 1994, when the county began to remove services from the building, a group of concerned citizens formed the NCFCC agency as a non-profit and took over the day-to-day management of the county building with its many partners from state, county and non-profit entities. "We wanted to continue to meet our mission to serve the community with our management of the building. It was tough to go forward without funding for the first two quarters of this fiscal year while in negotiation but we were determined," said Co-Director and Board President Bennett. In the last fiscal year, the center's front desk logged over 7000 in-person or phone contacts in the process of connecting people with services. Board Secretary/Treasurer and Co-Director Terranova was pleased that, "Despite the drain of the lease process, the agency was also able to financially assist the Boy Scouts, the Cape Blanco Soccer Club, Theater 101, the Project Safe Graduation fund, and the math project at Driftwood while supporting other projects with volunteer participation of its Board members."

An investigation into damage inflicted on a southern Oregon coast state park in mid-2011 has been referred to the Oregon Department of Justice.

The Oregon State Police reported the results of their Floras Lake State Natural Area vandalism investigation to the Oregon Department of Justice in November. The Department of Justice is reviewing the report to determine next steps for the investigation. Because the case is open and ongoing, the report is still confidential. Both the Department of Justice and the Oregon Parks and Recreation Department continue to treat the incident seriously.

Sometime between mid-May and early June, 16 pits were excavated unlawfully inside Floras Lake State Natural Area (<http://g.co/maps/3xcax>) north of Port Orford.

Floras Lake State Natural Area is a registered natural heritage conservation area and contains important cultural and natural resources, including federally endangered species such as western bog

### Port & Starboard Lounge

The Oregon International Port of Coos Bay submitted the permit application in January 2007. Today's culmination of that effort opens the way for development of modern marine cargo facilities, expansion of the southern Oregon coast maritime industry and increased use of the Coos Bay rail line. This permit approval further reinforces the viability of the Coos Bay's deep-water harbor for the enhancement of the economy and quality of life in the region.

The proposed multi-purpose cargo slip would accommodate the two berthing areas, one for the proposed Jordan Cove Energy Project liquefied natural gas terminal and a second for inbound and/or outbound bulk and/or breakbulk commodities. Jordan Cove continues to pursue permitting for its LNG project, while the Port continues to have discussions with entities investigating marine industrial property opportunities.

"This permit gives the Port the ability to site multipurpose cargo terminals west of the railroad and highway bridges, positioning the Port to quickly accommodate larger vessels as the industry evolves. It also increases navigation safety and efficiency for those vessels," Kronsteiner said.

Construction of the slip and channel access would occur over 18 months and create an estimated 75 construction and 195 indirect support jobs. Payroll over that time period would total an estimated \$26.2 million overall, bringing essential employment and added stability to Oregon's construction industry.

Longer-term port vessel operation employment tied to ongoing traffic through the berths could total between 26-280 direct jobs and 60-173 indirect jobs, for an annual payroll ranging between \$4.7 million and \$26.7 million annually.
